## PART I—Section 1

## Government of Pakistan Notifications relating to Rules, Regulations, Orders and Resolutions

## MINISTRY OF DEFENCE

(Aviation Division)

Karachi, the 15th July 1950

No. AV-20 (2)/50.—The following draft of certain amendments to the Aircraft Rules, 1937, which it is proposed to make in exercise of the powers conferred by sections 5 and 7 and sub-section (2) of section 8 of the Aircraft Act, 1934 (XXII of 1934), is

published as required by section 14 of the said Act for the information of all persons likely to be affected thereby, and notice is hereby given that the draft will be taken into consideration on or after the 15th August, 1950.

Any objection or suggestion which may be received from any person with respect to the said draft before the date specified will be considered by the Central Government.



*Draft Amendments*

In the said Rules.

**PART XIII-A.—AIRCRAFTS**

(1) In Rule 150 against entry (b) under the heading "Second and other Pilots", the words: "The pilot shall demonstrate his ability by making three take-offs and three landings in the type of aircraft in which he is to serve," shall be deleted.

(2) For Rule 154, the following shall be substituted, namely:—

"154. (1) All pilots while engaged on a licensed air transport service shall, every six months, undergo a check in instrument flying in actual flight, under the supervision of an examiner (Check Pilot) approved by the Director General. This check shall include—

- (a) 180 degrees turns with 30 degrees bank to port and starboard, variation in height not to exceed 100 ft.
- (b) Rate 1 procedure turns left and right. Loss of height not to exceed 100 ft.
- (c) "Let-Down" procedure applicable to the aerodrome in use.
- (d) Recovery from unusual altitudes.
- (e) Route check on route operated.

(2) All pilots before flying as "Pilot-in-Command" of an aircraft with two or more engines on a licensed air transport service shall demonstrate to an examiner (Check Pilot) approved or appointed by the Director General their proficiency in the performance of the following flight tests on the type of aircraft to be operated, namely:—

*For operation by day:*

- (a) Six take-offs, circuits and landings, at varying degrees of load, to include one take-off at maximum landing weight.
- (b) Stalls, to the point of warning, with wheels and flaps up and down, during normal and asymmetric flight.
- (c) Asymmetric flight, including landings, using alternate engine (a), and emergency action with simulated failure of one or more engines during take-off.
- (d) Three approaches at too low a height and two approaches at too great a height with one or more engines inoperative:
  - (i) Take-offs, to include simulated engine failure on alternate engine(s), one at maximum landing weight.
  - (ii) One figure of eight turn with 30 degrees bank, variation in height not to exceed 100 ft.
  - (iii) Recovery from unusual altitudes, loss in height not to exceed 1,000 ft.
  - (iv) Asymmetric flight to include 180 degrees turns with and against inoperative engine(s), loss in height not to exceed 100 ft.
  - (v) Rate 1 procedure turns, left and right. Loss in height not to exceed 100 ft.
  - (vi) Let-down procedure applicable to the aerodrome in use; variation in speed during descent not to exceed 5 m.p.h. above or below the stipulated speed.

The tests mentioned under 2 (b), (c) and (e) (iii) may be modified if this is necessary due to the qualities of the aircraft in question. In this case it shall be marked on the Check Form by the Check Pilot.

*For operation by night:*

- (i) As in (a), (b) (c) and (d) above for operation by day.

(ii) Let-down procedure applicable to the aerodrome in use; variation in speed during descent not to exceed 5 miles per hour above or below stipulated speed.

Provided that the Director General may at his discretion exempt from any or all of the tests prescribed in these paragraphs a pilot whose experience is sufficiently long and varied as to constitute equivalent evidence of his proficiency; and provided further that a pilot, already employed as "Pilot-in-Command", may continue to act in that capacity subject to the completion of these tests, by a date to be notified by the Director General of Civil Aviation.

(3) All the flying tests prescribed in sub-para. 2 must have been carried out within the period of six months preceding the date of application and must have been witnessed and certified by the same examiner (Check Pilot). Certification of the instrument flight check prescribed in sub-para. (1) and the flying tests prescribed in sub-para. (2) will be accepted from the holder of a current pilot's "B" licence who has been approved or appointed by the Director General to act as an examiner (Check Pilot) on the type of aircraft operated.

*Temporary relaxation of qualifications of second pilots:*

In respect of aircraft in Category b, c and d of Rule 150 of Section B of Part XIII-A and subject to such conditions as the Director General may prescribe, a second pilot may be exempted temporarily for a period not exceeding six months or 500 hours of flying, whichever is the shorter, from full completion of flying tests and technical examination on the type of aircraft to be operated, specified in Section C of Schedule II, subject to—

- (a) holding a current pilot's "B" licence,
- (b) having carried out, as a minimum requirement, item a, of the test prescribed in sub-clause (ii) of clause (c) of sub-para. (1) of paragraph (2) of Section C of the said Schedule II, and
- (c) having passed a preliminary technical examination to the satisfaction of the Director General."

**3. IN SCHEDULE II, SECTION A.**

For para. 1 the following para. shall be substituted, namely:—

- (a) "An applicant for the grant of a licence shall be required to produce evidence of having carried out during the 12 months preceding the date of application not less than 40 hours of flight time dual and solo including not less than 10 hours solo of which 3 hours shall include cross country flying (with an instructor on board) during which the applicant shall execute not less than 2 landings at different points along the route. An applicant for the renewal of a licence shall be required to produce evidence of having carried out during the 6 months preceding the date of application not less than 5 hours solo flying".
- (b) An applicant for issue of a licence or for a subsequent endorsement in respect of a type of flying machine fitted with two or more engines shall be required to produce evidence of having included in the flying experience specified in this sub-paragraph not less than 20 hours in command on a multi-engined flying machine, or equivalent experience as second pilot, counting each hour of flying experience as second pilot as half an hour of solo flying experience.
- (c) Except in a case where the Central Government is satisfied that the experience of the applicant as a pilot is sufficiently long and



an applicant for the addition to his licence for first time of a type having two or more engines or subsequent endorsement of another similar type of flying machine shall be required to produce evidence of having carried out not less than 20 hours flying in command or 40 hours flying as second pilot on a multi-engined flying machine fitted with dual control.

(ii) In para. 2 the following clause shall be added in sub-para. (3) :—

“For multi-engined flying machines—General Flying, with an examiner (Check Pilot) on board approved by the Central Government during which the following flight tests applicable to the type shall be carried out, with the aircraft loaded at maximum landing weight, namely :—

- (a) All manoeuvres used in normal flight, including take-off and landing.
- (b) Landing with one engine inoperative using alternate engine(s).
- (c) Emergency manoeuvres, including simulated engine failure after take-off.
- (d) Approach to the stall both level and banked altitudes.

An applicant for the endorsement of multi-engined marine type of aircraft on “A” licence is required to carry out the above flying tests on ground or water.

He must also prove to the Examiner that he can perform the following manoeuvres on the water :—

- (a) Manoeuvring to and mooring aircraft in a mooring buoy.
- (b) Stop the engines and receive and fasten a towing line from standby boat.
- (c) Direct the towing.

(iii) After para. (3) the following proviso shall be added, namely :—

“Provided that an applicant for a additional endorsement on his licence of a type of flying machine with two or more engines whether for the first time or otherwise shall be required to carry out the general flying tests specified in sub-paragraph (3) of this paragraph.”

(iv) In para. 3 after clause (c) of sub-para. (i), the following clauses shall be added, namely :—

- (d) “Elementary navigation, meteorology, flight theory and aircraft operating limitations.
- (e) An applicant for the endorsement of a multi-engined Aircraft on “A” licence is required to carry out the same technical examination in Aircraft Engines and Instruments, as prescribed for the endorsement on “A-1” or “B” licences, under paragraph 3 of section B & C.”

#### 4. IN SCHEDULE II, SECTION B.

(i) For proviso para. (1) the following shall be substituted, namely :—

“An applicant for issue of a licence for a subsequent endorsement in respect of a type of flying machine fitted with two or more engines shall be required to produce evidence of having included in the flying experience specified in this sub-paragraph not less than 20 hours flying in command on a multi-engined flying machine, or equivalent experience as second pilot, counting each hour of flying experience as second pilot as half an hour of solo flying experience.

(ii) For sub-paragraph (IA) the following shall be substituted, namely :—

“(IA) Except in a case where the Central Government is satisfied that the experience of the applicant as a pilot is sufficiently long and varied as to constitute equivalent experience, an applicant for the addition to his licence for the first time of a type having two or more engines or subsequent endorsement of another similar type of flying machine shall be required to produce evidence of having carried out not less than 20 hours flying in command on a multi-engined flying machine or 40 hours solo flying as second pilot on a multi-engined flying machine fitted with dual control.”

(iii) Clause (b) of sub-para. (1) the following shall be substituted, namely :—

“For multi-engined machines :—V General flying, with an examiner (Check Pilot) on board approved by the Central Government during which the following flight tests applicable to the type shall be carried out, with the aircraft loaded at maximum landing weight, namely :—

- (a) All manoeuvres used in a normal flight, including take-off and landing.
- (b) Landing with one engine inoperative using alternate engine(s).
- (c) Emergency manoeuvres, including simulated engine failure after take-off.
- (d) Approach to the stall in both level and banked altitudes.

An applicant for the endorsement of multi-engined marine type of aircraft on “A-1” licence is required to carry out the above flying tests on ground or water.

He must also prove to the Examiner that he can perform the following manoeuvres on the water :—

- (a) Manoeuvring to and mooring aircraft in a mooring buoy.
- (b) Stop the engines and receive and fasten a towing line from standby boat.
- (c) Direct the towing.

An applicant for the endorsement of a multi-engined aircraft who has already completed the flight tests on the particular type of aircraft and holds the endorsement on his “A” licence may be exempted from carrying out these tests again, provided the same have been completed within six months of date of endorsement, and at the discretion of the Director General of Civil Aviation.

(iv) For the proviso to sub-para. (2), the following shall be substituted, namely :—

“Provided that an applicant for an additional endorsement on his licence of a type of flying machine with two or more engines whether for the first time or otherwise shall be required to carry out the general flying test specified in clause (b) of sub-paragraph (1) of this paragraph.”

(v) In para. 3, sub-para. (1), after clause (e) the following shall be added, namely :—

(f) “The examination for a seaplane or flying boat endorsement shall in addition to the usual type-endorsement examination, include an examination (usually written), on the following syllabus :—

- (a) Tidal prediction using the Admiralty Tide Tables, but excluding the Admiralty method.
- (b) The terms used in tidal prediction :  
Height, rise, range and stand of tide ; Mean High Water Springs ; Mean Low Water Springs .



Neaps ; Chart Datum ; Mean Sea Level ; Mean Tide Level ; Soundings ; H. W. F. and C. ; and the Tidal Diagram.

- (c) Abbreviations of importance to seaplane pilots, used in Admiralty charts and plans.
- (d) The Regulations for preventing Collisions at Sea, and Rules as to Signals of Distress."

#### 5. IN SCHEDULE II, SECTION C.

(i) In para. 1 for clause (c) of sub-para. (1), the following sub-para. shall be substituted, namely :—

"An applicant for issue of a licence or for a subsequent endorsement in respect of a type of flying machine fitted with two or more engines shall be required to produce evidence of having included in the flying experience specified in this sub-paragraph not less than 20 hours flying in command on a multi-engined flying machine, or equivalent experience as second pilot as half an hour of solo flying experience.

(ii) In para. 1 for sub-paragraph (IA), the following shall be substituted, namely :—

"(IA) Except in a case where the Central Government is satisfied that the experience of the applicant as a pilot is sufficiently long and varied as to constitute equivalent experience, an applicant for the addition to his licence for the first time of a type having two or more engines or subsequent endorsement of another similar type of flying machine shall be required to produce evidence of having carried out not less than 20 hours flying in command on a multi-engined flying machine or 40 hours flying as second pilot in air transport operations on a multi-engined flying machine fitted with dual control."

(iii) In paragraph 2 for sub-clause (ii) of clause (c), the following shall be substituted, namely :—

"(ii) For multi-engined flying machines—General flying, with an examiner (Check Pilot) on board approved by the Central Government during which the following flight tests applicable to the type shall be carried out, with the aircraft loaded at maximum landing weight, namely :—

- (a) All manoeuvres used in normal flight, including take-off and landing.
- (b) Landings with one engine inoperative, using alternate engine(s).
- (c) Emergency manoeuvres, including simulated engine failure after take-off.
- (d) Approach to the stall in both level and banked altitudes."

"An applicant for the endorsement of a multi-engined marine type of aircraft on "B" licence is required to carry out the above flying tests on ground/or water.

He must also prove to the Examiner that he can perform the following manoeuvres on the water :—

- (a) Manoeuvring to and mooring aircraft in a mooring buoy.
- (b) Stop the engines and receive and fasten a towing line from standby boat.
- (c) Direct the towing.

An applicant for the endorsement of a multi-engined aircraft who has already completed the flight tests on the particular type of aircraft and holds the endorsement on his "A" or "A-1" licences may be exempted from carrying out these tests again provided the same have been completed within six months of date of endorsement, and at the discretion of the Director General of Civil Aviation."

(iv) In paragraph 2 for sub-clause (ii) of clause (d), the following shall be substituted, namely :—

"(ii) For single-engined flying machines—Three landings of which at least two shall be made without the aid of a floodlight.

(iii) For multi-engined flying machines—General flying, with an examiner (Check Pilot) on board approved by the Central Government during which the following manoeuvres shall be carried out, namely :—

- (a) With one engine inoperative, using alternate engine(s). All manoeuvres used in normal flight including landings.
- (b) At maximum landing weight—All manoeuvres used in normal flight including take-off and landing.

An applicant for the endorsement of multi-engined marine type of aircraft on "B" licence is required to carry out the above flying tests on ground/or water.

He must also prove to the Examiner that he can perform the following manoeuvres on the water :—

- (a) Manoeuvring to and mooring aircraft in a mooring buoy.
- (b) Stop the engines and receive and fasten a towing line from standby boat.
- (c) Direct the towing."

(v) In para. 2, sub-para. (2), for the proviso the following shall be substituted, namely :—

"Provided that an applicant for an additional endorsement on his licence of a type of a flying machine with two or more engines whether for the first time or otherwise shall be required to carry out the general flying tests prescribed in sub-clause (ii) of clause (c) and sub-clause (iii) of clause (d) of sub-para. (1) of this paragraph.

(vi) In paragraph 3, sub-para. (1) after clause (g), the following clause shall be added, namely :—

(b) The examination for a seaplane or flying boat endorsement shall in addition to the usual type-endorsement examination include an examination (usually written), on the following syllabus :—

- (a) Tidal prediction using the Admiralty Tide Tables, but excluding the Admiralty method.
- (b) The terms used in tidal prediction :  
Height, rise, range and stand of tide ; Mean High Water Springs ; Mean Low Water Springs ; Mean High Water Neaps ; Mean Low Water Neaps ; Chart Datum ; Mean Sea Level ; Mean Tide Level ; Soundings ; H. W. F. and C, and the Tidal Diagram.

- (c) Abbreviations of importance to seaplane pilots, used in Admiralty charts and plans.
- (d) The Regulations for preventing Collisions at Sea, and Rules as to Signals of Distress."

#### 6. IN SCHEDULE II, SECTION D.

(i) In paragraph 1 the following sub-para. (3) shall be added, namely :—

"3. An applicant for the endorsement of an additional type of multi-engined aircraft shall first hold an endorsement for that type on his "B" licence and in addition may be required to carry out such tests as may be prescribed by the Director General of Civil Aviation."

#### 7. IN SCHEDULE II, SECTION G (GENERAL).

The following new para. shall be added, namely :—

"9. The flying tests prescribed in sub-para. (3) of para. 2, section "A" clause (b) of sub-para.



clause (c) of sub-para. (1) and sub-clause (ii) of clause (d) of sub-para. (1) of para. 2 Section C must have been carried out within the period of six months preceding the date of application and must all have been witnessed and certified by the same Examiner. Certification of the tests will be accepted from the holder of a current Pilot's "B" licence for the type of aircraft to which the application refers and who has been approved or appointed by the Director General to act as an examiner (Check Pilot)."

## REMARKS

During the week ending the 17th June 1950 in the Dominion of Pakistan (excluding 4 towns of East Bengal Province and 13 towns of the Punjab), total number of deaths recorded in 25 towns having a population of over 30,000 was 863. The mid-year estimated population of these towns was 3,961,264 and the death rate per thousand was 11.3. The births in the same towns numbered 1,385 giving a birth rate of 18.1 per thousand of the population.

In 25 towns of the Dominion of Pakistan there were 12 deaths from small-pox and 14 from cholera. The deaths from smallpox were recorded in Dacca and Mymensingh 4 each, Lahore, Karachi, Narayangunj and Khulna 1 each, and those from cholera were recorded in Mymensingh and Khulna 5 each and Chittagong 4. Plague was absent during the week.
