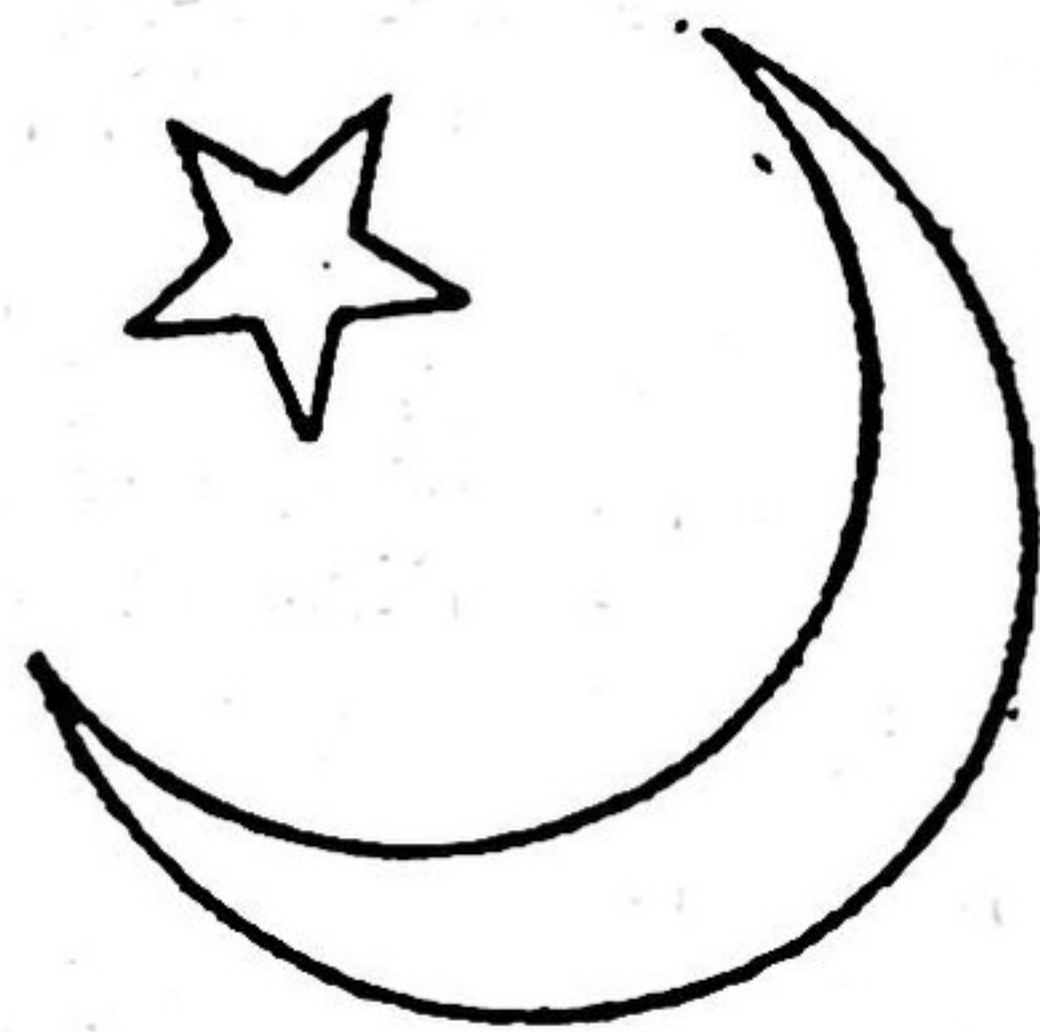

In Schedule A to the said Rules in clause (I) of Form 9, the words “and as regards the products specified in Schedule C of the Drugs Rules, 1945, the applicant shall be our sole agent for import into British India” shall be omitted.

## MINISTRY OF LAW AND LABOUR

No. LW-1 (5)/II/49.—In exercise of the powers conferred by sub-section (1) of section 10 of the Coal Mines Labour Welfare Fund Act, 1947 (XXXII of 1947), the Central Government is pleased to direct that the following amendments shall be made in the Coal Mines Labour Welfare Fund Rules, 1949, the same having been previously published as required by the aforesaid section of the Act.

## Amendment

## DISPENSARY SERVICES

In the said Rules after Rule 40 the following new rules shall be inserted, namely:—

40-A. Standard.—(1) The standard of dispensary services to be provided by the owners of collieries for the purposes of sub-section (2) of section 5 of the Act shall be such as is laid down in Appendix I.

(2) The prescription of standards, so far as medical care is concerned has been made on the basis of working population. The minimum staff requirements for a dispensary are given in Appendix I. Provided however that in the case of any dispensary which was in existence on the date those rules come

into force, the Coal Mines Welfare Commissioner, may, in his discretion, waive the general minimum requirements if he is satisfied that such dispensary is being efficiently run and serves the purpose for which it exists.

40-B. Inspection.—The dispensary services maintained by the owners of collieries shall be inspected at intervals not exceeding one year by such medical officer as may be appointed by the Chairman for the purpose. The medical officer shall, if the dispensary conforms to the standard laid down issue a certificate in Form D which shall be valid for a period of one year from the date of issue.

40-C. Submission of Periodic Returns.—Each colliery owner whose colliery is served by the dispensary shall submit to the Coal Mines Welfare Commissioner:

- (i) in January and July of each year, a statement showing the total amount of coal and coke despatched during the preceding six months from his colliery,
- (ii) in January of each year a certified statement of the expenditure incurred on the dispensary during the preceding 12 months, and
- (iii) “In January of each year, a certified statement of number of persons, employed in the colliery and treated in the dispensary showing the nature of diseases treated, during the previous twelve months”.

No. LC. 27 (2) 49.—In exercise of the powers conferred by sub-sections (2), (3) and (4) of section 26, read with section 24, of the Payment of Wages Act, 1936 (IV of 1936), the Central Government is pleased to make the following rules, the same having been previously published as required by sub-section (5) of section 26 of the said Act, namely:—

#### THE PAYMENT OF WAGES (MINES) RULES, 1950

1. *Title and application.*—(1) These rules may be called the Payment of Wages (Mines) Rules, 1950.

(2) These rules apply in respect of the payment of wages to persons employed in any mine (including coal mines, salt mines, salt quarries and oilfields) to which the Act has or may hereafter be extended, by an employer or by a contractor engaged by an employer.

2. *Definitions.*—In these rules, unless there is anything repugnant in the subject or context:—

- (a) "the Act" means the Payment of Wages Act (IV of 1936);
- (b) "the Authority" means the authority appointed under sub-section (1) of section 15 of the Act;
- (c) "Central Labour Commissioner" means any person appointed as Central Labour Commissioner by the Central Government;
- (d) "the Court" means the court mentioned in sub-section (1) of section 17 of the Act;
- (e) "deduction for breach of contract" means a deduction made in accordance with the provisions of the proviso to sub-section (2) of section 9;
- (f) "deduction for damage or loss" means a deduction made in accordance with the provisions of clause (c) of sub-section (2) of section 7;
- (g) "Form" means a form appended to these rules;
- (h) "Inspector" means an inspector authorised by or under section 14 of the Act;
- (i) "person employed" does not include any person to the payment of whose wages the Act does not apply;
- (j) "section" means a section of the Act;
- (k) "paymaster" means the employer or other person responsible under section 3 of the Act for the payment of wages;
- (l) "contractor" means a person fulfilling, either directly or through a sub-contractor, a contract with the mine owner.
- (m) "Employer" means an owner of the Mines and includes the manager or any other person responsible under section 3 of the Act for the payment of the wages, and a contractor;
- (n) "words and expressions" defined in the Act shall be deemed to have the same meaning as in the Act;

(o) "mines" has the same meaning as defined in the Indian Mines Act, 1923, as adapted and includes coalmines, saltmines salt quarries, and oilfields.

3. *Register of Fines.*—(1) On any mine where the employer has obtained approval under sub-section (1) of section 8 to a list of acts and omissions in respect of which fines may be imposed, the paymaster shall maintain a Register of Fines in Form I.

(2) At the beginning of the Register of Fines there shall be entered serially numbered the approved purpose or purposes on which the fines realised are to be expended.

(3) When any disbursements are made from the fines realised, deduct entry of the amount so expended shall be made in the Register of Fines, and a voucher or receipt in respect of the amount shall be affixed to the Register. If more than one purpose has been approved the entry of the disbursement shall also indicate the purpose for which it is made.

4. *Register of deductions for damage or loss.*—On every mine in which deductions for damage or loss are made the paymaster shall maintain the Register required by sub-section (2) of section 10 in Form II.

5. *Register of Wages.*—The register of wages shall be maintained by every employer either in form III or in such form as the paymaster finds convenient, provided it includes the following particulars:—

- (a) the gross wages of each person employed for each wage period;
- (b) all deductions made from those wages, with an indication, in each case of the clause of sub-section (2) of section 7 under which the deduction is made;
- (c) the wages actually paid to each person employed for each wage period."

6. *Maintenance of Registers.*—The Registers required by rule 3, 4 and 5 shall be preserved for at least three years after the date of the last entry made in them. The registers shall normally be maintained in English, but the Inspector may permit an employer, by special order and subject to such conditions as he may impose, to maintain the registers in any language other than English.

7. *Places for displaying notices.*—The Central Labour Commissioner shall specify such place or places as he thinks fit (hereinafter referred to as "specified place" or "specified places", for the display of notices, lists and rules under rules, 8, 12 and 16.

8. *Notice of dates of payment.*—The paymaster shall display, in a conspicuous place at or near the main entrance of the mines and at the specified place or specified places, a notice in English and in the language of the majority of the persons employed at such place or places showing (1) for not less than two months in advance the days on which wages are to be paid and (ii) the rates of wages and scale of allowances payable to the persons employed in the mine concerned.

9. *Prescribed authority.*—The Central Labour Commissioner shall be the authority competent to approve, under sub-section (1) of section 8, acts and omissions in respect of which fines may be imposed and, under sub-section (8) of section 8, the purposes to which the proceeds of fines shall be applied.

10. *Application in respect of fines.*—Every employer requiring the power to impose fines in respect of any acts and omissions on the part of employed persons shall send to the Central Labour Commissioner.

- (a) a list, in English, in duplicate, clearly defining such acts and omissions;
- (b) in cases where the employer himself does not intend to be the sole authority empowered to impose fines a list, in duplicate showing, by virtue of office, or otherwise such members of his staff as may pass orders imposing fines and the class of establishment on which any such officer may impose fine.



11. *Approval of list of acts and omissions.*—The Central Labour Commissioner may, on receipt of the list prescribed in sub-rule (a) of rule 10, and after such enquiry as he considers necessary, pass orders in respect of the said list either :—

- (a) disapproving the list ;
- (b) approving the list either in its original form or as amended by him, in which case such list shall be deemed to have been approved under sub-section (1) of section 8 ;

Provided that no order disapproving or amending the list shall be passed unless the employer shall have been given an opportunity of showing cause in writing against such order.

12. *Posting of list.*—The employer shall display at or near the main entrance of the mine and at the specified place or specified places, a copy in English, together with a literal translation thereof, in the language of the majority of the persons employed at such mine or place, of the list of acts and omission approved by the authority prescribed under rule 9.

13. *Persons authorised to impose fines.*—(1) No fine may be imposed upon a person, employed in a mine by any person other than the employer or by a person included in the list referred to in clause (b) of rule 10.

(2) In the case of persons employed by a contractor, no fine may be imposed by any person other than the contractor :

Provided that a contractor who runs more than one establishment in two or more localities and who employ not less than 50 persons in one locality, may, with the approval of the Inspector delegate his power to fine to his representative in that locality.

14. *Procedure in imposing fines and deductions.*—(1) No fine shall be imposed on and no deductions made from a person employed in a mine except in accordance with the procedure laid down in the rules and regulations in force in the mine and no fine shall be imposed or deduction made from the wages until the employed person has been given an opportunity of showing cause against such imposition or deductions.

(2) No fine shall be imposed and no deduction for damage or loss shall be made from the wages of a person employed by a contractor until the person authorised to impose the fine or make the deduction has explained personally to the said person the act or omission or damage or loss, in respect of which the fine or deduction is proposed to be imposed and the amount of the fine or deduction, which it is proposed to impose, and has heard his explanation in the presence of at least one other person.

15. *Information to paymaster.*—The persons imposing a fine or directing the making of a deduction for damage or loss (unless such person is the paymaster) at once informs the paymaster of all particulars necessary for completion of the register prescribed in Rule 3 or Rule 4, as the case may be.

16. *Deductions under the proviso to sub-section (2) of section 9.*—(1) No deduction under the proviso to sub-section (2) of section 9 shall be made from the wages of an employed person who is under the age of fifteen years or is a woman.

(2) No such deduction shall be made from the wages of any employed person unless—

- (a) there is provision in writing in the terms of the contract of employment requiring him to give notice of the termination of his employment ; and

- (i) the period of this notice does not exceed fifteen days or the wage-period, whichever is less, and

- (ii) the period of this notice does not exceed the period of notice which the employer is required to give of the termination of the employment ;

- (b) this rule has been displayed in English and in the language of the majority of the employed persons at or near the main entrance of the mine and at the specified place or specified places concerned, and has been displayed for not less than one month before the commencement of the absence in respect of which the deduction is made ;

- (c) a notice has been displayed at or near the main entrance of the mine and at the specified place or specified places concerned, giving the names of the persons from whom the deduction is proposed to be made, the number of day's wages to be deducted and the conditions (if any) on which the deduction will be remitted :

Provided that where the deduction is proposed to be made from all the persons employed in any department or section of the mine it shall be sufficient, in lieu of giving the names of the persons in such department or section of the mine, to specify the department or section affected.

(3) No such deduction shall exceed the wages of the person employed for the period by which the notice of termination of service given falls short of the period of such notice required by the contract of employment.

(4) If any conditions have been specified in the notice displayed under clause (c) of sub-rule (2), no such deduction shall be made from any person who has complied with such conditions.

17. *Annual Return.*—Every employer send a return in Form IV so as to reach the Inspector not later than the 15th of May following the end of the year to which it relates.

18. *Advances to persons employed by a Contractor.*—(1) An advance of wages not already earned shall not ordinarily exceed the amount equal to two calendar month's wages of the employed person. In exceptional cases the amount of such advance may, with the previous sanction of the Inspector, be made to the extent of four calendar month's wages.

(2) The advance may be recovered in instalments by deductions from wages spread over not more than twelve months in the case of ordinary advance and twenty months in the case of special advance. In no case, shall the amount of instalment exceed  $\frac{1}{4}$ th of the wages earned in the one month.

(3) The amount of all advances sanctioned and the repayments thereof shall be entered in a Register in Form V.

19. *Measurement of the amount of work done by piece-workers.*—In case a person engaged in a mine at piece rate and paid according to the dimensions of excavations made by him, a surveyor shall make accurate measurements of dimensions of the excavation in the presence of the person concerned and hand over to him a correct statement in writing containing the measurement figures for the past week or figures of the previous measurement as the case may be.

In case of any objection raised by the person concerned about the correctness of measurement, the surveyor shall report to the manager, who shall, verify the measurements and as far as possible try to settle the dispute on the spot. If no settlement of the dispute is reached between the manager and the person concerned, the question shall be referred to the Inspector whose decision shall be final.

20. *Procedure, costs and court fees.*—The procedure to be followed by the authorities appointed under sub-section (1) of section 15 and the Courts mentioned in sub-section (1) of section 17 of the Act, the scales of costs which may be allowed in, and the amount of court-fees payable in respect of, proceedings under the Act to which these rules apply shall be such procedure, scales and amount as are from time to time prescribed by the Provincial Government in the exercise of its power under the Act.

## FORM VI

Abstract of the Payment of Wages Act, 1936, and the Rule made thereunder.

## Whom the Act affects

1. The Act applies to the payment of wages to persons in mines receiving less than Rs. 200 a month.
2. No employed person can give up by contract or agreement his rights under the Act.

## Definition of wages

3. "Wages" means all remuneration payable to an employed person on the fulfilment of his contract of employment.

It includes bonus and any sum payable for want of a proper notice of discharge.

It excludes :—

- (a) the value of house-accommodation, supply of light, water, medical attendance, or other amenity or of any service excluded by the Central Government;
- (b) the employer's contribution to a pension or provident fund;
- (c) travelling allowance or concession or other special expenses entailed by the employment;
- (d) any gratuity payable on discharge.

## Responsibility for and method of payment

4. The employer is responsible for the payment under the Act of Wages to persons employed under him, and any contractor employing persons is responsible for payment to the persons he employs.

5. Wage-period shall be fixed for the payment of wages at intervals not exceeding one month.

6. Wages shall be paid on a working day within 7 days of the end of the wage-period (or within 10 days if 1,000 or more persons are employed).

The wages of a person discharged shall be paid not later than the second working day after his discharge.

7. Payments in kind are prohibited.

## Fines and deductions

8. No deductions shall be made from wages except those authorised under the Act (see paragraphs 9—15 below).

9. (1) Fines can be imposed only for such acts and omissions as the employer may, with the previous approval of the Central Labour Commissioner specify by a notice displayed at or near the main entrance of the mine and after giving the employed person an opportunity for explanation.

## (2) Fines—

- (a) shall not exceed half-an-anna in the rupee;
- (b) shall not be recovered by instalments; or later than sixty days of the date of imposition;
- (c) shall be recorded and applied to such purposes beneficial to the employed persons as are approved by the Inspector.

10. (a) Deductions for absence from duty can be made only on account of the absence of the employed person at times what he should be working and such deductions must not exceed an amount which is in the same proportion to his wages for the wage-period as the time he was absent in that period is to the total time he should have been at work.

(b) If ten or more employed persons, acting in concert, absent themselves without reasonable cause and without due notice, the deduction for absence can include wages for eight days in lieu of notice, but—

- (1) no deduction for breaking a contract can be made from a person under 15 or a woman;
- (2) there must be a provision in writing which forms part of the contract of employment, requiring that a specific period of notice of intention to cease work not exceeding 15 days or the period of notice which the employer has to give to discharge a worker must be given to the employer and that wages may be deducted in lieu of such notice;
- (3) the above provision must be displayed at or near the main entrance of the mine;
- (4) no deduction of this nature can be made until a notice that this deduction is to be made has been posted at or near the main entrance of the mine;
- (5) no deduction must exceed the wages of the employed person for the period by which the notice he gives of leaving employment, is less than the notice he should give under his contract.

11. Deductions can be made for damage to or loss of goods expressly entrusted to an employed person or for loss of money for which he is required to account, where such damage or loss is due to his neglect or default. Such deduction cannot exceed the amount of the damage or loss caused and can be made only after giving the employed person an opportunity for explanation.

12. Deductions can be made, equivalent to the value thereof, for house accommodation, amenities, or services (other than tools and raw material) supplied by the employer provided these are accepted by the employed person as a part of the terms of his employment and have in the case of amenities and services been authorised by order of the Central Government.



13. (a) Deductions can be made for the recovery of advances, or for adjustment of over payment of wages.

(b) Advances made before the employment began can only be recovered from the first payment of wages for a complete wage-period but no recovery can be made of advances given for travelling expenses before employment began.

(c) Advances of unearned wages can be made at the paymaster's discretion during employment.

14. Deductions can be made for subscription to and for repayment of advances from any recognised provident fund.

15. Deductions can be made for payments to co-operative societies approved by the Central Government or to the postal insurance, subject to any conditions imposed by the Central Government.

16. An Inspector can enter on any premises, and can exercise powers of inspection (including examination of documents and taking of evidence) as he may deem necessary for carrying out the purposes of the Act.

#### *Complaints of deductions or delays*

17. (1) Where irregular deductions are made from wages, or delays in payment take place, an employed person can make an application in the prescribed form within 6 months to the Authority appointed by the Local Government for the purpose. An application delayed beyond this period may be rejected unless sufficient cause for the delay is shown.

(2) Any legal practitioner, official of a registered trade union, Inspector under the Act, other person acting with the permission of the Authority can make the complaint on behalf of an employed person.

(3) A single application may be presented by, or on behalf of, any number of persons belonging to the same factory the payment of whose wages has been delayed.

#### *Action by the Authority*

18. The Authority may award compensation to the employed person in addition to ordering the payment of delayed wages or the refund of illegal deductions.

If a malicious or vexatious complaint is made, the Authority may impose a penalty not exceeding Rs. 50 on the applicant and order that it be paid to the employer.

#### *Appeal against the Authority*

19. An appeal in the prescribed form against a direction made by the Authority may be referred within 30 days to the District Court.

(a) by the paymaster if the total amount directed to be paid exceeds Rs. 300 ;

(b) by an employed person ; if the total amount of wages withheld from him or his co-workers, exceeds Rs. 50.

(c) by a person directed to pay a penalty for a malicious or vexatious application.

#### *Punishments for breaches of the Act*

20. Any one delaying the payment of wages beyond the due date, or making any unauthorised deduction from wages is liable to a fine up to Rs. 500, but only if prosecuted with the sanction of the Authority or the appellate Court.

21. The paymaster who—

(1) does not fix a wage-period ; or

(2) makes payment in kind ; or

(3) fails to display at or near the main entrance of the mine this Abstract in English and in the Language of the majority of the employed persons ; or

(4) breaks any rule made under the Act, is liable to fine not exceeding Rs. 200.

A complaint to this effect can be made only by the Inspector or with his sanction.

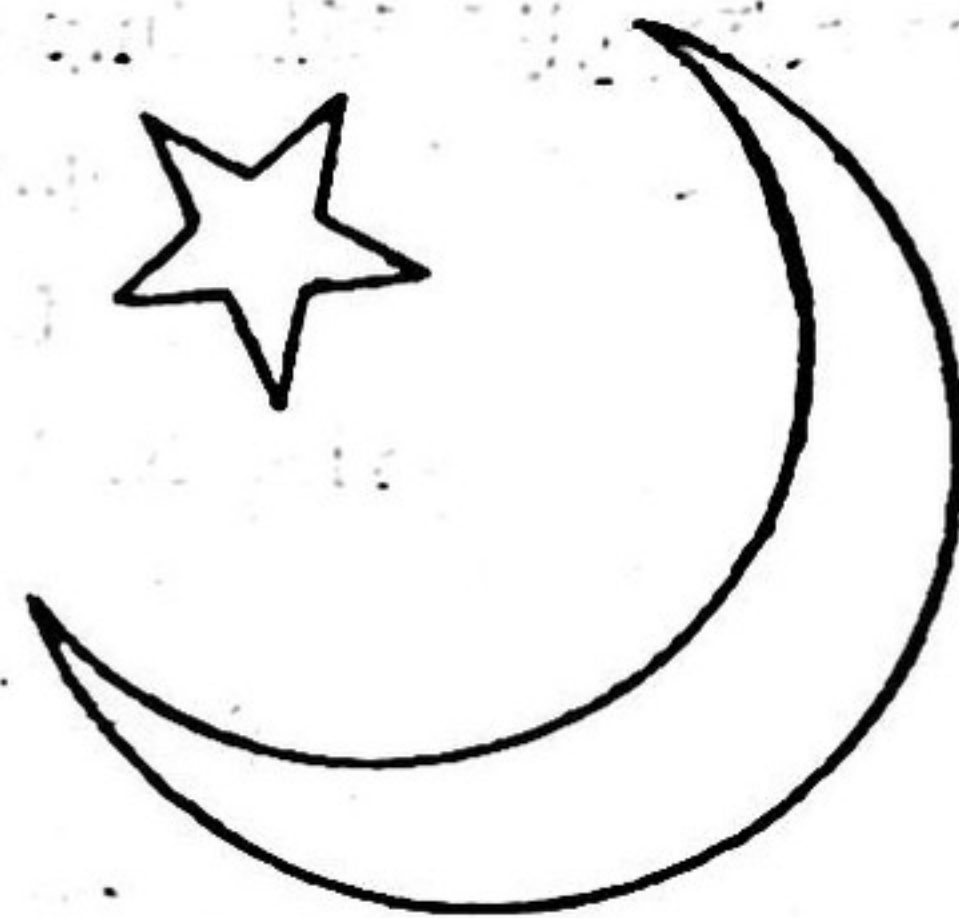

**"ALL PAKISTAN" FINAL FORECAST OF RAPE AND MUSTARD CROP FOR THE YEAR 1949-50**

No. F. 4-19/Stat. 49-50.—*Area.*—The final forecast of the area under rape and mustard crop for the year 1949-50, is 1,432,000 acres as against 1,530,000 acres of the previous year and shows a decrease of 6.4 per cent.

There has been a considerable decrease in the acreage of this crop in Punjab, Sind and Bahawalpur State which is attributed to unfavourable weather conditions and in-adequate supply of water. In other

parts of the Dominion, there has been a small increase in the acreage of this crop.

*Yield.*—The final forecast of the yield of this crop is 236,000 tons as against 265,000 tons of the previous year and shows a decrease of 11.0 per cent.

Except in Baluchistan, East Bengal and Khairpur State there has been a general decrease in the production of this crop throughout Pakistan which is mainly due to unfavourable weather conditions and the decrease in the acreage of this crop.

*First Annual Report of the Board of Directors of the Pakistan Industrial Finance Corporation for the year ended 30th June 1950, under section 36 (3) of the Pakistan Industrial Finance Corporation Act.*

The Central Government, in pursuance of Section 5 of the Pakistan Industrial Finance Corporation Act, have guaranteed a dividend of 2½% per annum on the share capital. It is proposed to call upon the Government to implement the guaranteed dividend.

The accounts submitted are the first but not complete year's accounts on the June to June basis. They cover the period from the 15th July 1949 to the 30th June 1950. The Pakistan Industrial Finance Corporation Act (I of 1949), under which the Corporation has been established, was passed by the Pakistan Constituent Assembly (Legislature) and received the assent of the Governor-General on the 28th February 1949. It however came into force on the 15th July 1949, the date fixed by the Central Government in pursuance of Clause 1 (3) of the Act. The Managing Director joined his appointment on the 10th September 1949, and the Directors (with one exception) were appointed by the Central Government on the 13th September 1949—one Director having been appointed on the 23rd November 1949. The Board of Directors met for the first time on the 27th September 1949.

A nucleus staff was appointed provisionally in May 1949 to carry out preliminary work regarding the establishment of the Corporation and the issue of shares for public subscription. The list of shares was opened on the 15th July and closed on the 21st July 1949. The response from the public was gratifying. The shares were over subscribed by Rs. 33,90,000. The Board made allotment of shares in accordance with the provisions of the Act and the General Regulations on the subject. Simultaneously with the issuing of the share list, the Central Government issued guarantee in terms of Section 5 of the Act for the payment of the annual dividend at a minimum rate of 2½%, free of income tax. The shares were declared to be Trustee Securities and Approved Securities.

We take this opportunity of thanking the Central Government (Ministry of Finance), the State Bank of Pakistan and other Government Departments for their assistance. In order to help us tide over the transitory period, the Government (Ministry of Finance) very kindly agreed to finance the preliminary expenses in connection with the establishment of our office, subject to recovery from the Corporation. All the expenditure incurred between May and 5th December 1949 on salaries, travelling etc. allowances and fees of Directors for attending meetings of the Board etc., stationery, printing and publicity charges etc., was met under that arrangement. The State Bank of Pakistan helped the Corporation particularly in connection with that issue of the share capital. Mr. Abdul Qadir, the then Acting Governor of the Bank, took personal interest in the matter. The Principal Information Officer, the Director of Advertising, Films and Publications and the Director of News Radio Pakistan, assisted us in our publicity campaign.

*Constitution and Functions of this Corporation.*—As there appears to be some confusion and misunderstanding in the mind of the public it seems desirable to state briefly the constitution of the Corporation, the business which, and the parties with whom, it is authorised to transact and the method and procedure of its transactions.

This Corporation has its head office in Karachi. An office is being opened at Chittagong (East Pakistan). Office premises have been obtained through the Government of East Pakistan and the staff is being recruited.



The authorised capital of the Corporation is Rs. 3 crores divided into 60,000 fully paid up shares of Rs. 500 each. In the first instance, however, only 40,000 shares were issued, the Central Government subscribing for 20,400 shares and 19,600 shares having been reserved for public subscription. The shares are now being quoted at Rs. 517-8-0 each.

The Management of the Corporation is entrusted to a Board of 9 Directors, including the Managing Director: 5 nominated by the Central Government and 3 by the share-holders, the Managing Director being a whole time officer appointed by the Government.

There is an Executive Committee consisting of three members i.e., the Managing Director (who is the Chairman of the Committee), a Director elected by the nominated Directors and a Director elected by the elected Directors.

There is a Technical Advisory Committee to give advice on the schemes submitted to the Corporation for financial assistance or on any point that may be referred to the Committee by the Board.

In addition to this Committee, the Corporation may appoint any other advisory committee to assist it in the efficient discharge of its functions.

The Board, in discharging its functions, is required to act on commercial considerations, but with due regard to the interests of industry, commerce and the public interest generally. In the discharge of its functions, the Board is guided by such instructions on question of policy as may be given to it by the Central Government. Apart from the question of policy, the Corporation is run by an independent management of its own.

*The business which and the parties with whom the Corporation may transact.*—The Corporation has been established for the purpose of making medium and long term credits more readily available to industrial concerns in Pakistan, namely, any public limited company or co-operative society incorporated by an Act of the Legislature or under any law for the time being in force and registered in Pakistan and engaged in the manufacture or processing of goods or in mining or in the generation or distribution of electricity or any other form of power.

In terms of Clause 24 of the Act, the Corporation is authorised to transact the following kinds of business:—

- (a) Guaranteeing loans raised by industrial concerns which are repayable within a period not exceeding 20 years and are floated in the open market.
- (b) Underwriting the issue of stock, shares, bonds or debentures by industrial concerns.
- (c) Granting loans to or subscribing to debentures to industrial concerns, repayable within a period not exceeding 20 years.

The Act also provides that no accommodation shall be given of the type referred to in (a) or (c) above unless it is secured by a sufficient pledge, mortgage, hypothecation or assignment of such property, movable or immovable, and to such extent as may be prescribed. This means that the Corporation is authorised to grant advances only against the security of tangible assets.

In the present circumstances, the Corporation does not undertake underwriting commitments. It would consider underwriting the issue of shares or debentures only when it is reasonably satisfied that there is likely to be an adequate response from the public and the market. For the same reason, the Corporation does not consider it advisable to guarantee loans floated in the market.

The assistance granted by the Corporation is therefore mainly limited at present to the forms of loans and advances against tangible assets.

*Criticism of the Corporation.*—This Corporation has been subjected to criticism directed generally against the aid being restricted to public limited companies and co-operative societies, rigidity of the conditions of loan and rate of interest, etc. It is difficult to deal with general and vague accusations. The Corporation always welcomes discussion with a *bona fide* party any points of doubt assailing its mind relating to the working of this Corporation. Indeed, we are glad to record that those who came forward for such discussion were generally satisfied with the result.

After all is said and done, it has to be remembered that the Corporation has been established under an Act of Legislature and must follow the provisions of that Act. Under it, the Corporation is authorised to extend accommodation only to public limited companies or co-operative societies incorporated in Pakistan.

Furthermore, the Corporation is required to act on commercial considerations and is authorised to grant advances only against the security of tangible assets. It is not considered advisable to throw precaution to the wind and distribute money indiscriminately as our critics would have us do. Our conditions must be business-like so as to prove helpful to the industry on the one hand and safeguard our money on the other. All our terms and conditions follow these two-fold considerations and cannot be regarded unduly harsh or unfair to the borrowing party. The Corporation must also satisfy itself about all aspects of schemes it should be not only technically feasible, but also financially sound.

*Loans Sanctioned.*—The total number of applications for loan, received upto the 30th June 1950, was 92. Out of these 62 were not qualified to receive assistance under the Act.

The first application for loan was considered by the Board at its third meeting on November 30th, 1949. Since then the Board has met five times or, in all, eight times and sanctioned during the seven months upto the 30th June 1950, loans of an aggregate sum of Rs. 69,50,000. All these sums have not been paid actually. The discrepancy in the amount of accommodation sanctioned and that made available to the borrowing concerns is to a large extent due to certain necessary formalities being completed. In one case, the applicant firm did not accept the conditions attached to the grant of loan. In certain cases the borrowing concerns prefer to obtain their requirements in instalments so as to coincide with the maturity of their commitments for which assistance is sought from this Corporation. This enables them to save interest charges. In other cases, industrial concerns, after obtaining the requisite sanction from this Corporation, postpone receiving payment until it becomes absolutely necessary. These are the main reasons for the delay in the payment of the entire amount sanctioned as loan.

Fifteen applications received from eligible concerns by the end of June 1950, are still under investigation.

*Resources of the Corporation.*—The total amount of loan (Rs. 69,50,000) sanctioned up to the 30th June 1950, was well within the resources of the Corporation which are made up of the present paid up capital of Rs. 2 crores. Under Section 22 of the Act, the Corporation is authorised to issue bonds to the extent of five times the amount of its paid-up capital and reserves. As the authorised share capital of the Corporation is Rs. 3 crores, on the assumption that a reserve of a like amount is built up, the potential borrowing capacity of the Corporation is Rs. 30 crores.

Under Section 23 of the Act, the Corporation can also accept deposits from the public but it is not proposed to resort to this until the Corporation is in need of more capital.

There is an Executive Committee consisting of three members i.e., the Managing Director (who is the Chairman of the Committee), a Director elected by the nominated Directors and a Director elected by the elected Directors.

There is a Technical Advisory Committee to give advice on the schemes submitted to the Corporation for financial assistance or on any point that may be referred to the Committee by the Board.

In addition to this Committee, the Corporation may appoint any other advisory committee to assist it in the efficient discharge of its functions.

The Board, in discharging its functions, is required to act on commercial considerations, but with due regard to the interests of industry, commerce and the public interest generally. In the discharge of its functions, the Board is guided by such instructions as

The assistance granted by the Corporation is therefore mainly limited at present to the forms of loans and advances against tangible assets.

*Criticism of the Corporation.*—This Corporation has been subjected to criticism directed generally against the aid being restricted to public limited companies and co-operative societies, rigidity of the conditions of loan and rate of interest, etc. It is difficult to deal with general and vague accusations. The Corporation always welcomes discussion with a *bona fide* party any points of doubt assailing its mind relating to the working of this Corporation. Indeed, we are glad to record that those who came forward for such discussion were generally satisfied with the result.

After all is said and done, it has to be remembered that the Corporation has been established under an Act of Legislature and must follow the provisions of that Act. Under it, the Corporation is authorised to extend accommodation only to public limited companies or co-operative societies incorporated in Pakistan.

Furthermore, the Corporation is required to act on commercial considerations and is authorised to grant advances only against the security of tangible assets. It is not considered advisable to throw precaution to the wind and distribute money indiscriminately as our critics would have us do. Our conditions must be business-like so as to prove helpful to the industry on the one hand and safeguard our money on the other. All our terms and conditions follow these two-fold considerations and cannot be regarded unduly harsh or unfair to the borrowing party. The Corporation

**REMARKS**

During the week ending the 26th August, 1950, in the Dominion of Pakistan (excluding 13 towns of the Punjab and 1 town of East Bengal Province), the total number of deaths recorded in 28 towns having a population of over 30,000 was 998. The mid-year estimated population of these towns was 4,211,251 and the death rate per thousand was 12.3. The births in the same towns numbered 2,139 giving a birth rate of 27.0 per thousand of the population.

In 28 towns of the Dominion of Pakistan there were 18 deaths from Cholera and 5 from Small-pox. The deaths from Cholera were recorded in Mymensingh 17 and Chandpur 1 and those from Small-pox were recorded in Khulna 3, Dacca, and Narayanganj, one each. Plague was absent during the week.
