AUDITOR'S CERTIFICATES RULES, 1932.

Karachi, the 16th November 1950

No. 374/111.—The following draft of amendments to the Auditor's Certificates Rules, 1932, which are proposed to be made with effect from the 1st April,

1948, in exercise of the powers conferred by subsection (2) of section 144 of the Companies Act, 1913 (VII of 1913), is published for the information of all persons likely to be affected thereby and notice is hereby given that the draft will be taken into consideration on or after the 9th December 1950. Any objection or suggestion which may be received from any person by that date will be considered by the Central Government.

*Draft Amendment*

(1) After Rule 7 of the said Rules, the following new rule shall be inserted, namely:—

"Notwithstanding anything contained to the contrary in these rules, the Central Government may impose such conditions, either before or after enrolment, as it may consider necessary, on such Registered Accountants as are not permanently residing in any of the territories of Pakistan."

(2) After sub-rule (1) of rule 14 the following sub-clause (c) shall be inserted, namely:—

"who is found not to fulfil the conditions if any imposed by the Central Government under rule 8."

(3) The existing sub-clause (c) and (d) will be renumbered (d) and (e).



No. J.6072.—WHEREAS I am satisfied that a state of tension exists among the people of Karachi which endangers public peace and tranquility;

AND WHEREAS in my opinion measures are necessary for the purpose of preventing the disturbances of the public peace and order in the city of Karachi and Karachi Cantonment, now, therefore, I, M. Ishak, District Magistrate, Karachi hereby prohibit you from forming, joining or being a member of any processions of five or more persons within the limits of Karachi Municipal area, Karachi Cantonment area and Karachi Port Trust Area.

And prohibit the carrying, collection and storage of all weapons such as lathis, lorhs, cudgels, swords, spears, bludgeons, belchas, knives and all weapons falling within the meaning of arms as defined in the Arms Act (XI of 1878), and all other implements or means which when used as weapons of offence are likely to cause hurt, intended or likely to be used for the purpose of committing riot or disturbances of the peace.

I further prohibit the carrying, collection and storage of stones and other missiles or instruments or means of casting or impelling missiles, acids and other corrosive substance, soda water bottles, etc., intended or likely to be used for the purpose of committing riot or disturbances of the peace.

Note (1).—This order shall remain in force for 1 month upto 15th December 1950, from the date of issue (both days inclusive).

Note (2).—This order shall not apply to the carrying of weapons etc., by members of Pakistan Force or of the Police Force or Government officers while on duty.

Note (3).—This order shall not apply to religious, weddings and funeral processions.

If any person transmits or causes or permits to be transmitted by telegraph a message which he knows to be false or fabricated, or a message which is indecent or obscene, he shall be punishable with imprisonment for a term which may extend to three years, or with fine, or with both.”

### STATEMENT OF OBJECTS AND REASONS

The Telegraph Act, 1885, which deals with messages by telephone as well as by telegraph (telegraph being defined in the Act so as to include telephones) provides no penalty for sending indecent or obscene messages. Subscribers in the larger cities are being subjected to an increasing number of these messages sent by telephone. To disconnect a telephone known to have been used for such a message may affect an innocent subscriber who has been taken advantage of in his absence and in any case it is considered that it is more fitting to prescribe a judicial penalty against the actual offender. The Bill seeks accordingly to amend section 29 of the Act.

## C. A. (L.) BILL No. 68 OF 1950

The last extension was effected through the Railways (Transport of Goods) (Revival and Continuance) Act, 1950. The Act gives powers to the Central Government to issue directions in regard to priority in the transport of goods by rail. Although the wagon position on the North Western Railway has eased for the present, the situation on the Eastern Bengal Railway continues to be serious. It is, therefore, considered necessary that the powers of granting priority for the movement of goods by rail which the Central Government exercise under the Act, should be retained for another three years. To achieve this object, it is proposed to amend sub-section (3) of section 1 of the Act as in the draft bill attached herewith.

## STATEMENT OF OBJECTS AND REASONS

The Naturalisation Act, 1926, which is in force in Pakistan at present, extends only to the Provinces and Capital of the Federation. It is necessary that it should extend to the whole of Pakistan including the Acceding States and other areas included in the Federation so as to be co-extensive with the Pakistan Citizenship Bill. It is also necessary to provide for the oath of allegiance to his Majesty the King to be substituted by an oath of allegiance to the Constitution of Pakistan. The Bill intends to achieve these and other necessary objects.

The powers conferred by the Pakistan (Control of Entry) Ordinance, 1948 (XVII of 1948) have been judicially held to be limited to the powers "to control the entry of persons coming from India into Pakistan". The rules to be framed as contemplated in sections 3, 4 and 6 of the Ordinance are rules which relate principally to the matters mentioned in sub-clauses (a) and (b) of clause (2) of section 7 of the Ordinance. The only case in which a person can be convicted by a court and punished under section 4 of the Ordinance, or in which action can be taken against him under section 6 by the Central Government is where he has entered Pakistan from India in contravention of the Ordinance or of a rule made thereunder. As there is nothing in the Ordinance authorising action by the Central Government under section 6 against a person for overstaying, it is felt desirable that the Ordinance should be amended so as to provide that a person who stays in Pakistan beyond the period for which his temporary permit is valid can be prosecuted under section 4 of the Ordinance.

*A Bill to provide for national service by medical practitioners*

WHEREAS by reason of the shortage of medical practitioners in certain services, and for the sake of the national health, it is expedient to provide for national service by medical practitioners;

It is hereby enacted as follows:—

1. (1) This Act may be called the Medical Practitioners (National Service) Act, 1950. Short title, extent and commencement

(2) It extends to all the Provinces and the Capital of the Federation, and applies to all persons liable to be called up or called up under this Act wherever they may be.

(3) It shall come into force on such date as the Central Government may, by notification in the official Gazette, appoint.

“appropriate Government” means, as respects persons assigned to or serving in the civilian medical service of a Province, the Provincial Government and in all other cases the Central Government.

Every person who is registered under any law for the time being in force as a medical practitioner or who holds a degree, diploma, licence, certificate or other document conferred, granted or issued by any authority referred to in section 3 of the Medical Degrees Act, 1916, or recognised by a Provincial Medical Council, the Pakistan Medical Council or the General Council of Medical Education of the United Kingdom, shall, if he has not completed thirty-two years of his age, and if he is a national of Pakistan, be liable to be called up for national service under this Act. (ii) of any period during which he was absent without leave;

(c) if leave of absence is granted to any person for a period comprising or immediately following the date on which his period of service would otherwise be completed under this Act the Allocation Board may postpone the completion of that period until a date not later than the expiry of his leave.

(2) The Allocation Board may direct that a person's service shall be treated as completed at any time earlier than it would otherwise be completed under this Act.

#### STATEMENT OF OBJECTS AND REASONS

There is a serious shortage of qualified doctors in both the Defence Forces and the civil Medical Departments. The Army, even after the recent recruitment of foreign doctors, is still short of fifty per cent. of its requirements, and in the civil Medical Departments the position is no better. In the Punjab, for instance, 207 out of 580 dispensaries are working without qualified medical officers. After considering every aspect of this problem Government have decided that in order to meet the present critical situation faced by the Health Services of this country, provision should be made by legislation for compulsory medical service by medical practitioners under thirty-two years of age for a period of three years.

## REMARKS

During the week ending the 21st October, 1950, in the Dominion of Pakistan (excluding Sind, Karachi Centrally Administered Area, 5 towns of the Punjab and 2 towns of the East Bengal Province), the total number of deaths recorded in 31 towns having a population of over 30,000 was 621. The mid-year estimated population of these towns was 3,224,430 and the death rate per thousand was 10.0. The births in the same towns numbered 1,681 giving a birth rate of 27.1 per thousand of the population.

In 31 towns of the Dominion of Pakistan there were 3 deaths from cholera and 3 deaths from smallpox. The 3 deaths from cholera were recorded in Pabna and the deaths from smallpox were recorded in Narayanganj, Mymensingh and Sylhet one each. Plague was absent during the week.
