Rates of Income-Tax.

A—In the case of every individual, Hindu undivided family, unregistered firm, and other association of persons not being a case to which paragraph B of this Part applies—

	Rate.
1. On the first Rs.1,500 of total income	Nil.
2. On the next Rs.3,500 of total income	Nine pies in the rupee.
3. On the next Rs.5,000 of total income	One anna and nine pies in the rupee.
4. On the next Rs.5,000 of total income	Three annas and six pies in the rupee.
5. On the next Rs.5,000 of total income	Four annas and six pies in the rupee.
6. On the balance of total income	Five annas in the rupee.

Provided that—

(i) no income-tax shall be payable on a total income which, before deduction of the allowance, if any, for earned income, does not exceed Rs.3,000;

(ii) the income-tax payable shall in no case exceed half the amount by which the total income (before deduction of the said allowance, if any, for earned income) exceeds Rs.3,000;

ADMISSION INTO THE DACCA MEDICAL SCHOOL. SESSION 1951-52.

NOTIFICATION

Applications for admission into the Dacca Medical School during the session 1951-52 in the prescribed form obtainable from the office of the Dacca Medical School on payment of Re. 1 each—postage extra—should reach the office of the Dacca Medical School between 10-30 a. m. and 1 p. m. on all working days within 10 days of the wall up of the results of the Matriculation Examination of the Secondary Education Board, Dacca.

Application should be accompanied by true copies of the following certificates:—

(1) Certificate of having passed the Matriculation Examination with certified copy of the marks obtained or any higher examination in Arts or Science of a recognized University.

(2) Certificate of character—From the Principal or Head Master of the College or School in which the candidate last studied.

When more than 6 weeks have elapsed between the date of leaving the College or School and the date of application for admission, a second certificate of character is required

covering the intervening period. This should be obtained from a Gazetted officer or a gentleman of equal position such as an Hon. Magistrate having an intimate knowledge of the applicant.

(3) Certificate of Age.—Candidates shall be over 15 years of age before commencing their studies. Evidence of age in Matriculation certificate will suffice.

None need apply who has not passed the Matriculation Examination at least in the 2nd Division.

The date of selection will be communicated to the individual candidate in due course.

All original certificates as well as mark sheet shall have to be produced at the time of interview.

Incomplete or late application will not be considered.
