### The Weekly Weather and Crop Report for the week ending the 26th December 1951.

**Summary.**—There was no rainfall during the week under report. The weather was favourable excepting Kishoreganj subdivision. Harvesting of aman was almost over. Sowing of rabi crops and transplantation of boro paddy were also going on. Lands were under cultivation for sowing of aus and jute crop in some subdivisions. There was no scarcity of seeds and seedlings in the province except Sunamganj subdivisions. Scarcity of fodder prevailed in Mymensingh, Netrakona, Patuakhali, and six other subdivisions. Cattle disease was reported only from Mymensingh sadar subdivision. The rate of wages of labour without food varied from annas twelve to rupees two and annas eight per head per day. The lowest rate of wages prevailed in Satkhira subdivisions while the highest in Nilphamari, Mymensingh, Natayanganj, Kshoreganj and 7 other subdivisions.

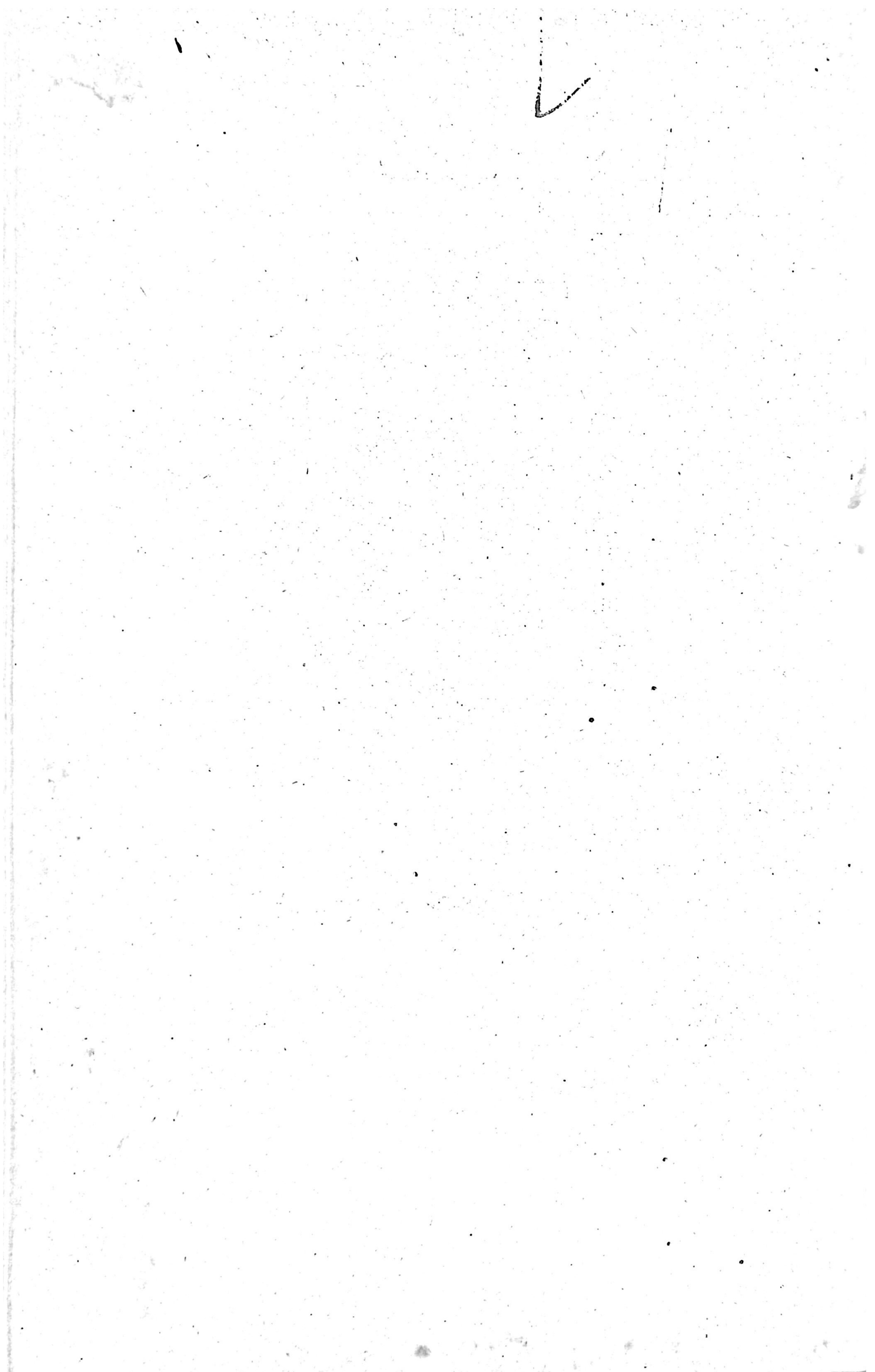
