No. F. 16-3|50-Est.—The following rules regulating recruitment to the Department of Archaeology, Pakistan, Class I and Class II posts, are published for general information.

PART I

1. These Rules may be called the Department of Archaeology, Pakistan, Class I and Class II Posts (Recruitment) Rules.

2. For the purpose of these rules :—

- (a) “Government” means the Governor-General;
- (b) “the Commission” means the Pakistan Public Service Commission;
- (c) “the Service or Department” means the Department of Archaeology, Pakistan;
- (d) “direct appointment” means appointment made otherwise than by promotion or transfer from another service or Department.

3. The Service shall be recruited by the following methods :—

- (i) By promotion in accordance with Part II of these Rules.
- (ii) By direct appointment in accordance with Part III of these Rules.

4. Vacancies in the Service|Department which are filled otherwise than by promotion shall be distributed between the various Provinces of Pakistan in accordance with provisions of the Government of Pakistan, Cabinet Secretariat Office Memorandum No. F. 25|10|50-Est. (S.E.I.), dated the 6th October 1950, and the supplementary instructions connected therewith.

5. (a) Recruitment to the Class I posts of Superintendent of Archaeology will be made by promotion from among Class I Assistant Superintendents in accordance with Part II of these Rules. If no suitable Assistant Superintendent Class I is available for promotion, recruitment will be made by direct appointment in accordance with part III of these Rules.

(b) Recruitment to the Class I posts of Assistant Superintendents will be made by promotion from amongst Class II Assistant Superintendents up to a maximum of 33 1/3% of vacancies in accordance with Part II of these Rules, the remaining 66 2/3% being filled by direct recruitment in accordance with Part III of these Rules. If no suitable Assistant Superintendent Class II is available for promotion against the 33 1/3% quota reserved for promotion, recruitment will be made by direct appointment in accordance with Part III of these Rules.

(c) Recruitment to the Class II posts of Assistant Superintendents will be made by direct appointment in accordance with Part III of these Rules.

PART II

Recruitment by promotion.

6. (a) Recruitment by promotion within Class I and from Class II post to a Class I post in the service shall be made by selection from among the members of the service on the recommendation of the Departmental Promotion Committee and with the approval of the Commission where necessary in accordance with the Pakistan Public Service Commission (Consultation by the Governor-General).

(b) On the successful completion of the probationary period Government shall confirm the officer in his appointment.

PART III

7. Recruitment by direct appointment shall be made by selection through the Commission.

8. Every candidate for direct appointment must be a male, except, however, in the case of the Class post of Assistant Superintendent, National Museum, Karachi, for which women shall also be eligible.

9. A candidate must either be:—

- (i) a citizen of Pakistan, or
- (ii) a British subject or Commonwealth citizen without domicile in Pakistan in whose favour a certificate of eligibility has been issued by the Central Government, or
- (iii) a person in whose case a declaration has been made under section 262 of the Government of India Act, 1935.

10. A candidate for appointment to the service—

(1) must not be less than 23 and not more than 35 years of age on the last day of December in the year in which appointment to the service is to be made, provided that a candidate who is over the age of 35 or under the age of 23 on that date may apply for the post if—

- (a) he holds substantively a permanent post under the Central or a Provincial Government; and
- (b) is recommended by the head of the Department in which he is serving.
- (c) The maximum age-limit will be relaxed by 3 years in the case of Scheduled Castes candidates and candidates belonging to the tribal areas of the North-West Frontier Province and Baluchistan, the Frontier States and Baluchistan States and the tribal areas adjoining the Dera Ghazi Khan District of the Punjab, and by 2 years in the case of candidates belonging to the excluded areas of East Pakistan.

(2) "must possess a good degree in ancient or medieval history or Archaeology and some knowledge of at-least one of the oriental classical languages. Experience in Archaeology will count as an additional qualification."

(3) must satisfy the Government that his character and antecedents are such as to make him suitable for appointment under Government.

11. (a) Applications for direct appointment shall be submitted to the Commission in such form, on such date and in such manner as the Commission may prescribe.

(b) Persons already in service can also apply provided they fulfil the prescribed conditions and

are permitted to apply by the Head of their Departments/Offices. They must submit their applications through proper channel. Candidates who join Government service after submitting their applications should also submit the departmental permission immediately thereafter.

(c) The decision of the Commission as to the eligibility or otherwise of a candidate shall be final.

12. A candidate for direct appointment must be in good mental and bodily health and free from any physical defect likely to interfere with the discharge of his duties as an officer of the Service. A candidate who (after such medical examination as Government may prescribe) is found not to satisfy those requirements will not be appointed.

13. (a) Appointment shall be made on probation for a period of two years.

(b) If in the opinion of Government the work or conduct of an officer on probation is unsatisfactory or shows that he is unlikely to become efficient, Government may discharge him forthwith.

(c) On the conclusion of his period of probation, Government may confirm the officer in his appointment, or, if his work or conduct has in the opinion of Government been unsatisfactory, Government may either discharge him from the service or may extend his period of probation for such further period, not exceeding one year, as Government may think fit.

(d) If no action is taken by Government under sub-rule (b) or (c) of this rule, the period after the prescribed period of probation shall be treated as an engagement until further orders.

Draft amendment

In Form S. T. 14, prescribed under sub-rule (1) of rule 45 of the Sales Tax Rules, 1951, the following shall be added at the top, namely :—

"TO BE PAID ON OR BEFORE....."

INCOME TAX

ESTATE DUTY

Karachi, the 8th January 1954

No. E.D. 1.—In exercise of the powers conferred by section 75 of the Estate Duty Act, 1950 (X of 1950), the Central Board of Revenue directs that the following further amendments shall be made to the Estate Duty Rules, 1950, the same having been previously published as required by the said section namely :—

In the said Rules,—

(I) in sub-rule (4) of rule 3, for the words "Board may at its discretion", the words "Controller may in his discretion" shall be substituted;

(II) in rule 7, for the words "Board in Karachi", the words "Controller" and for the words "the Board", the words "the Controller" shall be substituted;

(III) in the following rules, for the word "Board" wherever occurring, the word "Controller" shall be substituted :—

Rules 8, 18, 19, 22, 30, sub-rules (3) and (4) of rule 31, 34 and 36;

(IV) after rule 28, the following new rule shall be inserted, namely :—

"28A. Notice of demand.—the notice of demand under section 58 D shall be in Form E.D. 11";

(V) in clauses (a) and (b) of sub-rule (1) of rule 31, for the words and comma, "Central Board of Revenue, Karachi", the word "Controller" shall be substituted;

(VI) in sub-rule (i) of rule 34—

(a) after the words "in order to" the word "effect" shall be inserted; and

(b) the words 'an officer authorised by' shall be deleted;

(VII) after Part X, the following new Part X-A shall be inserted, namely :—

Part X-A—Receiver.

35. Form of order of appointment.—An order appointing a receiver may be in Form E.D. 6 or in such other form as the Board may direct.

35-A. Register of receivers.—On an order for the appointment of a receiver being drawn up and filed, an entry shall be made in a register in Form E.D. 7, to be kept for the purpose. A copy of the order of appointment shall be sent to the receiver.

35-B. Receiver to give security.—Where an order is made directing a receiver to be appointed, the person appointed shall, unless otherwise ordered, first give security to the satisfaction of the Secretary, Central Board of Revenue, for the due performance of his duties as receiver. Unless the Board otherwise orders, the Secretary shall take the recognizance of the receiver himself and two sureties and the amount of the bond shall be double the annual rental of any immovable property, or the value of the movable property, which is likely to come into the hands of the

receiver. Such annual rental or value shall be estimated after notice to the accountable persons and the receiver, and in case of disagreement the matter shall be placed before the Board for orders. The bonds to be executed by the receiver and the sureties shall be in Forms E.D. 8 and E.D. 9 respectively or such other forms as the Board may direct.

35-C. Surety may point out omission or neglect of duty cast on receiver.—If the security mentioned in rule 35-B be furnished by the receiver by his executing a bond with a surety or sureties (including in the latter term a Guarantee Society), the surety or sureties shall be entitled, by an application, to bring to the notice of the Board any act, omission or neglect of any duty cast on the receiver by law or any other circumstances, which would entitle the surety or sureties to be discharged from the obligation created by such bond and the Board may thereupon make such order and on such terms as it may think fit.

35-D. Notice to surety of application affecting surety's risk.—The surety or sureties mentioned in rule 35-C shall be entitled to notice of any application to the Board on the part of the receiver or any other party interested relating to any property in the management or under the control of the receiver which may affect the risk undertaken by the surety or sureties under the security bond furnished by the receiver and the Board upon hearing the said surety or sureties may make such order as to his or their cost of appearance in such application as it may think fit.

35-E. Powers of a receiver.—In the absence of any order in that behalf every receiver of immovable property shall have all the powers of an owner specified in Order XL, rule I (d) of the Code of Civil Procedure (V of 1908), except that he shall not, without the leave of the Board (i) grant leases for a term exceeding three years, or (2) bring suits, except suits for rent, or (3) institute an appeal in any Court (except from a decree in a rent suit), where the value of the appeal is over Rs. 1,000, or (4) expend on the repairs of any property in any period of two years more than half of the net annual rental of the property to be repaired, such rental being calculated at the amount at which the property to be repaired would let when in a fair state of repairs.

35-F. Receiver's remuneration.—A receiver shall be allowed such remuneration not exceeding the following rates as the Board may order, and may also be allowed the necessary expenses of management :—

(1) On rents recovered or on interests earned on investments:	5 per cent. subject to a minimum of eight annas.
(2) On outstandings recovered—	
On the first Rs. 10,000 or fraction thereof:	5 per cent.
On the next Rs. 15,000 or fraction thereof:	3 per cent.
On the next Rs. 25,000 or fraction thereof:	2 per cent.
On the next Rs. 50,000 or fraction thereof:	1 per cent.
On any further sum	1 per cent.
(3) On sales of properties, movable or immovable calculated on the total value realised in any one estate—	
On the first Rs. 10,000 or fraction thereof:	3 per cent.
On the next Rs. 15,000 or fraction thereof:	2½ per cent.
On the next Rs. 25,000 or fraction thereof:	2 per cent.
On the next Rs. 50,000 or fraction thereof:	1 per cent.
On any further sum	1 per cent.
(4) For taking charge of movable property which is not sold, on the estimated value.	1 per cent.

(5) For taking custody of moneys or of Government Securities, or of Stocks, Shares, Debentures, Debenture-stock or other Securities.

½ per cent. (in the case of Govt. Securities or of Stock Shares, Debenture-Stock or other securities, the percentage shall be calculated on their face value).

(6) For any special work not provided for above, such remuneration as the Board on the application of the receiver shall think reasonable.

(7) Receiver's remuneration and expenses of management shall be a charge on the estate of the deceased and shall be recovered in the same manner as duty.

35-G. Establishment and costs therefor to be detailed in the appointment order.—The establishment, clerical or otherwise, required by a receiver in addition to his ordinary establishment, if any, and the cost thereof chargeable to the estate or property of which he is appointed receiver, shall, as far as possible, be detailed in the order of appointment or subsequent order.

35-H. No charge for additional establishment allowed.—Unless otherwise ordered, no charge for any establishment in addition to his ordinary establishment, if any, shall be allowed to the receiver.

35-I. Receiver to file half yearly accounts.—Every receiver shall, unless otherwise ordered, file his half-yearly accounts with the Board, the first of such accounts to be filed within one month after the expiration of six months from the date of his appointment, and every subsequent account within one month after the expiration of each succeeding period of six months, or in a case where the purpose for which the receiver was appointed has been carried out or completed before the expiry of six months from the date of appointment, within one month from the date of carrying out or completion.

35-J. Account to show balance in hand and how much may be paid into Central Board of Revenue etc., to be filed with affidavit Form of affidavit.—Unless otherwise ordered, every such account shall show that the balance in hand, is, whether any, and if so, what portion thereof is required for the purposes of the estate, and how much may be paid into the Board or invested, and shall be filed together with an affidavit verifying the same in form E. D. 10.

35-K. Examining and vouching of accounts by officers.—Every such account, before being submitted to the Board shall be examined and vouched for by the Secretary, Central Board of Revenue or such other officer as the Board may either generally from time to time, or particularly with reference to a particular estate or account, appoint for that purpose. Such officer may require the attendance of the receiver or his explanation or his evidence upon oath or affirmation, the production of any document by him and decide objections to the account and shall embody the result of his examination in a report.

35-L. Appointment for passing accounts Notice thereof.—After the officer shall have submitted his report to the Board under rule 35-K, he shall obtain a date from the Board for passing such accounts, of which date notice shall be given to the accountable persons the sureties and to the receiver.

35-M. Objections to report to be filed.—Objections, if any, to the report shall be filed with the Board one week before the day fixed for the passing of the accounts or within such further time as may be allowed by the Board. They shall specify in a concise form the nature of the objections and shall be signed and verified.

35-N. Passing of accounts by Central Board of Revenue.—Where no objections are filed, the Board shall, if otherwise satisfied, pass such accounts.

Where objections have been filed, the Board shall subject to rule 35-L, after hearing the objections make such order as it may think proper.

35-O. Procedure as to hearing of objections.—The Board may, from time to time, adjourn the hearing of any objections or may refer them to an officer of the Board, or to any other person, with such directions as the Board may deem fit.

35-P. Auditing of difficult and complicated accounts.—In any case where the accounts are difficult and complicated, the Board may order such accounts to be audited, at the expense of the estate by a Registered Accountant enrolled on the Register of Accountants maintained by the Central Government under the Auditors Certificate Rules, 1950.

35-Q. Order as to payment of balance.—The Board on the passing of the accounts, may make such order as to the payment of the balance, or any part thereof, either to the Board or in such other manner as may seem proper.

35-R. Consequence of receiver's negligence to file accounts or pay the balance, etc.—Where any receiver neglects to file his accounts, or to pass the same or to pay the balance or any part thereof as ordered, the matter shall be reported by the Secretary, Central Board of Revenue, and the Board may, from time to time, when the accounts of such receiver are produced to be examined and passed, not only disallow the remuneration therein claimed by such receiver but also charge him with interest not exceeding nine per cent. per annum upon the balance, if any, so neglected to be paid by him during the time such balance shall appear to remain in the hands of such receiver.

35-S.—Where any receiver fails to file any account or affidavit, or to make any payment, or commits any other default, the receiver or the parties, or any of them, may be required by notice to attend before the Board to show cause why such account or affidavit has not been filed or such payment, or any other proper proceeding taken, and thereupon the Board may give such directions as may be proper, including the discharge of any receiver and appointment of another and also the payment of costs by the defaulter";

(VIII) in Forms E. D. 1, E. D. 2, E. D. 3, and E. D. 4 appended to those Rules,—

- (a) the words "Government of Pakistan" shall be deleted,

REMARKS

During the week ending the 28th November, 1953, in 15 towns in Pakistan (excluding 9 towns in Punjab, 6 in Sind and 15 towns in East Bengal) having a population of 30,000 and over, the total number of deaths recorded was 535. The 1951-Census population of these towns was 2,607,517 and the death rate per thousand was 10·6. The births in the same towns numbered 2,034 giving a birth rate of 40·5 per thousand of population.

In the above-mentioned 15 towns there were 4 deaths from smallpox. The four deaths from smallpox were recorded in Rawalpindi town in the Punjab.

Cholera and Plague remained absent during the week under report.
