

No. F. 37-21/53.—The Governor-General is pleased to direct that the following further amendments shall be made in the Post Office Insurance Fund Rules (hereinafter referred to as the "said rules"), namely:—

1. After sub-rule (17) of rule 2 of the said rules, the following shall be inserted as sub-rule (18), namely:—

"(18) All permanent employees of Government aided educational Institutions."

2. For rule 3 of the said rules, the following shall be substituted, namely:—

"3. Any person who is admissible to the benefits of the Post Office Insurance Fund under rule 2 or exceptions below rule 2-A—

(a) may effect an insurance on his life for any sum being a multiple of Rs. 100 payable at death;

(b) may purchase an endowment assurance policy for any sum being a multiple of Rs. 100 payable on his attaining the age of 45, 50 or 55 or at death, if death occurs before he attains the specified age."

3. For rule 26 of the said rules and the exception thereto, the following shall be substituted, namely:—

"26. No life can be insured in the Fund for any sum which is not a multiple of Rs. 100.

Exception:—A reduced, paid up or converted policy issued under rule 33 need not be for a multiple of Rs. 100 but it will not be issued for a sum less than Rs. 100."

4. For the note below rule 27 of the said rules, following shall be substituted, namely:—

"Note:—A person who has effected an insurance on his life may also purchase an endowment assurance policy, and a person who has purchased an endowment assurance policy, may also effect an insurance on his life".

No. F. 8-3/50-L.S.G.—In exercise of the powers conferred by clause (d) of sub-section (2) of section 138 of the Karachi Improvement Trust Act, 1950 (XLVIII of 1950), the Central Government is pleased to make the following rules, a draft of the same having previously been published as required by section 140 of the said Act :—

INTRODUCTION

1. These rules may be called the Karachi Improvement Trust Pay, Allowances and Leave Rules.
2. They apply to all officers and servants of the Board, whether temporary or permanent, paid from the revenues of the Board.
3. In any case or matter not specifically provided for in these Rules, the rulings in the Fundamental and Supplementary Rules of the Central Government will generally and in so far as they can be adopted to the Board's requirements, be held to apply, provided that any matter in the said Rules left to be decided by the discretion, option, special rule or order of the Central Government shall be decided by the Board.
4. Any case not covered by these rules or the Fundamental and Supplementary Rules of the Central Government referred to in rule 3 shall be dealt with by the Board on its merits.
5. Every order made by the Board under these rules, shall so far as it related to posts whereof the monthly salary or the maximum monthly salary exceeds one thousand rupees and to officers and servants holding such posts, be subject to the previous sanction of the Central Government.

## PART I

## PAY AND GENERAL CONDITIONS OF SERVICE

## DEFINITIONS

6. Unless there be something repugnant in the subject or context, the terms defined in this part are used in the rules in the sense here explained:—

- (1) "Act" means the Karachi Improvement Trust Act, 1950;
- (2) "Average pay" means the average monthly pay earned during the 12 complete months immediately preceding the month in which the event occurs which necessitates the calculation of average pay;
- (3) "Board" means the Board of Trustees of the Improvement Trust of Karachi;
- (4) "Chairman" means the Chairman of the Board;
- (5) "Cadre" means the strength of a service or part of a service sanctioned as a separate unit;
- (6) "Compensatory allowance" means an allowance granted to meet personal expenditure necessitated by the special circumstances in which duty is performed, and includes a travelling allowance;
- (7) "duty" includes (i) service as a probationer or apprentice provided that such service is followed by confirmation (ii) joining time;
- (8) "fee" means a recurring or non-recurring payment to an officer or servant from a source other than the Board's revenues, whether made directly to an officer or servant or indirectly through the intermediary of the Board;
- (9) "honorarium" means a recurring or non-recurring payment granted to an officer or servant from the revenues of the Board as remuneration for special work of an occasional or intermittent character;
- (10) "leave on average (or half or quarter average) pay" means leave on leave salary equal to average (or half or quarter average) pay;
- (11) "leave salary" means the monthly amount paid by the Board to an officer or servant on leave;
- (12) "lien" means the title of an officer or servant to hold substantively either immediately or on the termination of a period or periods of absence, a permanent post to which he has been appointed substantively;
- (13) "month" means a calendar month, provided that in calculating a period expressed in terms of months and days, complete calendar months irrespective of the number of days, in each, shall first be calculated and the odd days shall be calculated subsequently;

- (16) "pay" means the amount drawn monthly by an officer or servant as—
  - (i) the pay, other than special pay or personal pay, granted in view of his personal qualifications, which has been sanctioned for the post held by him substantively or in officiating capacity, or to which he is entitled by reason of his position in a cadre, and
  - (ii) technical pay, special pay and personal pay, and
  - (iii) any other emoluments which may be specially classed as pay by the Board
- (17) "permanent post" means a post carrying a definite rate of pay sanctioned without limit of time and included in the statement of sanctioned posts required by section 24 of the Act;
- (18) "personal pay" means additional pay granted to an officer or servant—
  - (a) to save him from a loss of substantive pay in respect of permanent post due to a suspension of pay or to any reduction of substantive pay otherwise than as a disciplinary measure; or
  - (b) in exceptional circumstances, on other personal consideration;
- (19) "presumptive pay of a post" when used with reference to any particular officer or servant means the pay to which he would be entitled if he held the post substantively and were performing its duties, but it does not include special pay unless he performs the work or discharges the work or responsibility, or is exposed to the unhealthy conditions, in consideration of which the special pay was sanctioned;
- (20) "special pay" means in addition of the nature of pay to the emoluments of a post or of an officer or servant granted in consideration of—
  - (a) the specially arduous nature of the duties or
  - (b) a specific addition to the work or responsibility; or
  - (c) the unhealthiness of the locality in which the work is performed;
- (21) "subsistence grant" means a monthly grant made to an officer or servant who is not in receipt of pay or leave salary;
- (22) "substantive pay" means the pay other than special pay, personal pay or emoluments classed as pay by the Board under sub-clause (iii) of clause (16) of this rule, to which an officer or servant is entitled, on account of the post to which he has been appointed substantively or by reason of his substantive position in a cadre;
- (23) "technical pay" means pay granted to an officer in consideration of the fact that he has received technical training outside Pakistan;
- (24) "temporary post" means a post carrying a definite rate of pay sanctioned for a limited time;
- (25) (a) "time scale pay" means pay which is subject to any conditions prescribed rises in periodical increments from a minimum to a maximum;
- (b) time-scales are said to be identical if the minimum, the maximum, the period of increment and the rate of increment of the time scales are identical;

(c) a post is said to be on the same time scale as another post on a time-scale if the time-scales are identical and the posts fall within a cadre, or a class in a cadre, such cadre, or class having been created in order to fill all posts involving duties of approximately the same character or degree of responsibility in a service or establishment or group of establishments; so that the pay of the holder of any particular post is determined by his position in the cadre or class and not by the fact that he holds that post;

(26) "travelling allowance" means an allowance granted to an officer or servant to cover the expenses which he incur in travelling in the interests of the Board's service. It included allowances granted for the maintenance of conveyances.

GENERAL CONDITIONS OF SERVICE

7. Except as provided by this rule no person may be substantively appointed to a permanent post in the Board's service without a medical certificate of health from the Board's Medical Officer which must be forwarded to the office of the Accountant of the Board for record as part of the recommendation for appointment. The Board may, in individual cases dispense with the production of a certificate.

8. Unless in any case it is otherwise provided, the whole time of an officer or servant is at the disposal of the Board and he may be employed in any manner required, without claim for additional remuneration.

9. (a) Two or more officers or servants cannot be appointed substantively to the same permanent post, at the same time.

(b) An officer or servant cannot be appointed substantively except as a temporary measure, to two or more permanent posts at the same time.

(c) An officer or servant cannot be appointed substantively to a post on which another officer, servant holds a lien.

10. Unless in any case it is otherwise provided, an officer or servant on substantive appointment to any permanent post acquires a lien on that post and ceases to hold any lien previously acquired on any other post.

11. An officer or servant holding substantively a permanent post retains a lien on that post—

- (a) while performing the duties of that post;
- (b) while on leave;
- (c) while holding a temporary post or officiating in another post;
- (d) while under suspension.

12. An officer or servant shall not, save in cases of inefficiency, or misbehaviour, be transferred substantively to a post carrying less pay or to a lower time scale of pay.

13. Unless in any case otherwise directed, an officer or servant shall begin to draw the pay and allowances attached to his tenure of a post with effect from the date when he assumed the duties of that post and shall cease to draw them as soon as he ceases to discharge those duties.

14. After three year's continuous absence from duty whether with or without leave, an officer is considered to be out of the Board's employ. But this rule may, on public grounds and with the sanction of the Board, be relaxed.

15. No person whose age exceeds 25 years will ordinarily be admitted to the Board's service on superior establishment without the special sanction of the Board which will be relaxed in exceptional cases by the Board.

16. (1) The initial substantive pay of an officer or servant who is appointed substantively to a post on a time scale of pay is regulated as follows:—

(a) If he holds a lien on a permanent post—

(i) When appointment to the new post involves the assumption of duties or responsibilities of greater importance (as interpreted for the purpose of rule 23) then those attaching to such permanent post, he will draw as initial pay the stage of the time scale next above his substantive pay in respect of the old post;

(ii) When appointment to the new post does not involve such assumption he will draw as initial pay the stage of the time scale which is equal to his substantive pay in respect of the old post, or, if there is no such stage, the stage next below that pay, plus personal pay equal to the difference and in either case will continue to draw that pay until such time as he would have received an increment in the time-scale of the old post or for the period after which an increment is earned in the time scale of the new post, whichever is less. But if the minimum pay of the time-scale of the new post is higher than his substantive pay in respect of the old post, he will draw that minimum as initial pay;

(b) If the conditions prescribed in clause (a) are not fulfilled he will draw as initial pay the minimum of the time-scale:

Provided, both in cases covered by clause (a) and in cases of reemployment after resignation from the Board's service, covered by clause (b), that if he has previously held substantively or officiated in—

- (i) the same post, or
- (ii) a permanent or temporary post on the same time-scale, or
- (iii) a permanent post on an identical time-scale or a temporary post on an identical time-scale, such post being on the same time-scale as a permanent post,

then the initial pay shall not be less than the pay, other than special pay, personal pay or emoluments classed as pay by the Board under clause (iii) of sub-rule (16) of rule 6, which he drew on the last such occasion, and he shall count for increments the period during which he drew that pay on such last and any previous occasion.

(2) Increments in the case of all officers and servants will accrue on and from the day on which they are earned.

17. The holder of a post, the pay of which is changed, shall be treated as if he were transferred to a new post or the new pay; provided that he may, at his option, retain his old pay until the date on which he has earned, his next or any subsequent increment on the old scale, or until he vacates his post or ceases to draw pay on that time-scale. The option once exercised is final.

18. An increment shall ordinarily be drawn as a matter of course, unless it is withheld. An increment may be withheld from an officer or servant by the Chairman or the Board if his conduct has not been good or his work has not been satisfactory. In ordering the withholding of an increment, the withholding

44. An officer not in permanent employ appointed without interruption of duty substantively to a permanent post will be credited with the earned leave which would have been admissible for his previous duty had it been duty as an officer in permanent employ diminished by any earned leave already taken. Leave is not an interruption of duty for the purpose of this Rule.

45. Leave on private affairs may be granted only to an officer in permanent employ in superior service and to the following extent, namely—

- (a) if he is an officer for 18 months in all and on any one occasion for not more than 3 months if spent wholly in Asia or for not more than 9 months if spent wholly outside Asia; if the leave is spent partly in and partly outside, the period shall be 3 months plus such time as is actually spent outside Asia subject to the maximum total period of 9 months;
- (b) if belonging to a subordinate service for 12 months in all, and on any one occasion for not more than 3 months if spent wholly inside Asia, or for not more than 6 months if spent wholly outside Asia.

46. Leave on medical certificate not exceeding 12 months in all during an officer's service may be granted to an officer in permanent employ. Such leave shall be given only on production of a certificate from such medical authority as the Board may by general or special order specify in this behalf and for a period not exceeding that recommended by such medical authority;

Provided that when the maximum period of 12 months is exhausted further leave on medical certificate not exceeding 6 months in all may be granted in exceptional cases on the recommendations of a Medical Board.

47. (1) Extraordinary leave may be granted to any officer in special circumstances:—

- (a) when no other leave is by rule admissible, or
- (b) when other leave is admissible, but the officer concerned applied in writing for the grant of extraordinary leave.

(2) Except in the case of an officer in permanent employ the duration of extraordinary leave shall not exceed 3 months on any one occasion.

(3) The authority empowered to grant leave may commute retrospectively periods of absence without leave into extraordinary leave.

#### CASUAL LEAVE

48. (a) Casual leave is not recognised and is not subject to any rule. Technically, therefore, an officer on casual leave is not treated as absent from duty and his pay is not intermitted.

(b) Casual leave, however, must not be given so as to cause evasion of standing rules or so as to extend the term of privilege or other leave, beyond the time admissible by rule.

(c) Casual leave or a short occasional absence on full pay is not admissible but is granted as a favour.

(d) Casual leave means absence with the previously obtained consent and on the responsibility of a superior. It may be given by the Heads of Departments or officers to their subordinates of whatever rank or grade without further sanction.

(e) The limit of casual leave is 20 days in the calendar year.

(f) Short holidays and Sundays may be allowed to be prefixed and affixed to casual leave subject to the condition that the period of casual leave plus holidays

does not exceed 7 days at one time or in very special cases 10 days. Such holidays will not be counted as casual leave.

(g) Casual leave counts as duty for all other kinds of leave.

(h) Persons on casual leave may leave the station for the time with the knowledge and consent of the authority who sanctions the leave. Authentic memoranda of the periods of absence on casual leave by the members of the Department should be kept in each office and an officer disposing of an application for casual leave should refer to such memoranda to see that the limit in the period has not been exceeded.

49. Inferior members of the permanent staff may also be allowed casual leave by Heads of Departments provided their services can be spared. Peons are not expected to bring medical certificates that they are ill in all cases but the Head of the Section must be satisfied that the peon was really ill before pay can be allowed.

### PART III

#### MISCELLANEOUS

50. The Board may provide any class of its servants with uniforms if in the opinion of the Board the nature of duties of such servants requires the use of uniforms.

### CONDUCT OF OFFICERS AND SERVANTS OF THE BOARD

#### I.—OUTSIDE EMPLOYMENT

Officers and servants are prohibited from accepting any pay or employment outside the sphere of their duties under the Board.

An exception to this rule can be made, in special cases, by the Chairman in case of those drawing Rs. 100/- and under p.m. or by the Board in the case of those drawing over Rs. 100 p.m. provided that the outside work is undertaken outside working hours of the officer or servant concerned and that it does not interfere with his responsibilities to the Board.

The sanction of the Chairman or the Board must not be anticipated. In emergency, where it is not possible to obtain sanction in time, the Chairman may, if he thinks fit, accord sanction in anticipation of the Board's sanction but until the sanction is obtained no work must be undertaken.

In cases where special sanction is accorded to undertake outside work a portion of the fee received by an officer or servant should be credited to the funds of the Karachi Improvement Trust, in accordance with the rules in force at the time. The Chairman in the case of a servant drawing Rs. 100 and under p.m. and the Board in the case of one drawing less than Rs. 500 p.m. may, however, accord sanction to the retention of the fee in full for reasons deemed sufficient by them to warrant such special treatment.

Note. 1. The words "employment" and "work" used in the above rule do not include honorary work of a social or charitable nature or occasional work of a literary or artistic character subject to the conditions that the official duties do not thereby suffer and that servants shall not undertake or shall discontinue such work if so directed by the Chairman or the Board as the case may be.

2. No officer or servant may stand for election to, or take his seat on, a Provincial Legislature or a Local body without the permission of the Board.

II.—ILLEGAL GRATIFICATION

The acceptance of illegal gratification renders the acceptor liable to dismissal.

III.—PETITIONS AND APPEALS

Anonymous petitions shall not be taken notice of but shall be destroyed unread. If an employee has a complaint to make he shall do so in writing and sign his name.

No action shall be taken by the Chairman on appeals or petitions to him from or on behalf of any officer or servant unless the officer or servant has first appealed to the Head of his Department.

Every appeal or petition to the Chairman from or on behalf of any officer or servant must be accompanied by a copy of the appeal or petition made to the Head of the Department concerned and his reply thereto. Such appeal or petition by an officer or servant himself shall invariably be submitted through the proper channel.

Applications of the nature of a round robins are not permitted and taken notice of but shall be destroyed unread. If an officer or servant has a grievance he should represent his case to the Head of his Department who can deal with the matter.

IV.—SECRECY

Officers and servants are forbidden to discuss official matters coming to their knowledge with outsiders or to give any information whatever as to official correspondence.

V.—INDEBTEDNESS

No officer or servant may accept a loan from any other officer or servant or contractor of the Board either in his or any other Department.

No officer or servant is allowed to stand as surety or give security for any other officer or servant who may be working over him in the same department.

When an officer or servant is adjudged or declared an insolvent or when a moiety of salary of such servant is constantly being attached or has been continuously under attachment for a period exceeding two years or is attached for a sum, which, in ordinary circumstances cannot be repaid within a period of two years, he will be liable to dismissal.

VI.—COURT PROCEEDINGS

No officer or servant shall be allowed to take proceedings in any court against any fellow officer or servant in respect of any dispute or offence non-cognizable by the police that may happen on the premises of the Board or in connection with their work without obtaining previous sanction of the Chairman.

VII.—ELECTIONS

No officer or servant may take an active part directly or indirectly in connection with elections to a Legislature or a Public Body beyond recording his votes.



## AUDIT REPORTS ON THE ACCOUNTS OF THE KARACHI MUNICIPAL CORPORATION FOR THE YEAR 1950-51 (1ST APRIL 1950 TO 31ST MARCH 1951).

In compliance with the provisions of Section 95 of the Karachi Municipal Act, 1933, below is report of the Auditor, Karachi Municipal Corporation, on the Accounts of the Karachi Municipal Corporation for the year 1950-51. There was concurrent pre-audit of the expenditure of the year and scrutiny of resolutions, orders, leave, gratuity and pension reports, etc., involving expenditure and/or revenue during the year and also post-audit of revenue receipts.

2. The Accounts for the year 1950-51, were completed and finally closed by the new Accountant Mr. Irshad Hussain, on 15th April 1952, instead of at the end of June 1951, as per Article 29, *ibid.* The total Revenue and expenditure (chargeable to revenue) amounted to Rs. 105.08 Lakhs and Rs. 115.43 Lakhs respectively (as compared to Rs. 93.69 Lakhs and 76.54 Lakhs, respectively in the preceding year 1949-50), resulting in a deficit of Rs. 10.35 Lakhs.

NOTE.—Figures against items (a) (c) and (n) are still awaited from Departmental Heads.

4. *Loans and Sinking Fund.*—No fresh loan was raised during the year under report. A statement showing the loans outstanding and the value of the Sinking Fund Account as on 31st March 1951 according to the prescribed rates of interest and the yearly contribution is appended as Annexure 'A' to the report. The actual amount required for "Sinking Fund" as per rates sanctioned by Government should be Rs. 61,99,833 against which the actual accumulations in the Fund as on 31st March 1951 stand at Rs. 66,88,174-10-0.

5. *Securities.*—A statement showing the total securities of the book-value of Rs. 1,32,82,008-10-0 including sterling Securities of the face value of £. 26100 held by the Corporation as on 31st March 1951, is given as Annexure 'B'.

The securities deposited by the various contractors and held by the Corporation as on 31st March 1951 amounted to Rs. 86,225.

6. *Provident Funds 'A' Sch. Staff.*—The Provident Fund Ledger of 'A' Sch. staff for the year 1950-51 has been completed as regards monthly postings and calculations of interest, but as already reported last year, no attempt has been made by the Accounts Department to reconcile the total of balances standing to the credit of individual employees as on 31st March 1951, with the figure as per financial books which stands at Rs. 7,02,094. It is important that an abstract of the Provident Fund balances as shown in the Ledger accounts should be prepared annually by the Accounts Department and the total reconciled with the figure shown in the financial books.

7. *Provident Fund 'B' Sch. Staff.*—The Provident Fund Ledgers of 'B' Sch. staff as pointed out in the previous Audit-Notes continue to be in a mess. No reconciliation of balances standing to the credit of individual employees with the figures appearing in the Balance Sheet, has been made so far and it

time that some responsible man in Accounts Department is put in charge of this work to bring it up to date. No Provident Fund slips have been issued to the subscribers so far, though the Accounts Department was expedited by Audit in this respect as early as 23rd January 1951.

8. *Provident Fund of School Board Teachers.*—The Government took over control of the School Board with effect from 1st March 1949. The Deputy Education Inspector, was requested to forward a statement showing the total amount of Provident Fund standing to the credit of each employee on 31st March 1950 duly certified by the Government Auditor to enable the Corporation to refund the amount.

A sum of Rs. 1,60,000 has recently been paid in this connection, in addition to a sum of 1,45,000 already paid upto 28th January 1952, aggregating Rs. 3,05,000.

9. *Income Tax.*—A sum of Rs. 36,307-15-8 as reported in the last year's Audit Note is still outstanding in respect of Income Tax deducted by the Income Tax Authorities on securities held by the Corporation, which are under the law exempt from Income Tax. The recoupment of the amount may please be expedited by the Accountant by personal appeal.

10. *Dishonoured Cheques.*—The total No. of cheques returned dishonoured by the Bank and awaiting recoupment as on 31st March 1951 amounted to Rs. 1,54,079-9-0 as against Rs. 71,626-1-0 on 31st March 1950. The Audit Department has pressed the Accountant for early clearance of the outstanding cheques on more occasions than one, but to little effect. It appears that the Departmental Heads, to whom the aforesaid cheques are returned by the Accountant for recoupment of the amounts, are sleeping over the matter. As the heavy accumulation of dishonoured cheques vitally affects the finances of the Corporation, the matter is brought to notice for necessary action.

11. *Unserviceable Stores.*—The Sale proceeds of unserviceable stores during the year amounted to only Rs. 45,948 as against Rs. 71,626-1-0 in the preceding year.

Lots of unserviceable stores occupying much space in various yards require early disposal by regular public auctions every year.

12. *Grants and Contributions.*—The amounts due to the Corporation on account of grants, contributions etc., for the year 1950-51 and the outstanding for the previous years are listed below:—

- (a) *T. B. Dispensary.*—A sum of Rs. 9,000-0-0 was received for the year 1947-48. But the amount due for the subsequent period upto 31st March 1951, has not yet been received and credited into the Municipal Treasury, though a sum of Rs. 21,646-7-6 representing arrears of Government grant for the periods from 23rd July 1948 to 31st March 1949, 1949-50 and 1950-51, has been sanctioned by the Ministry of Health and Works (Health Division). Similarly a sum of Rs. 2,782-4-0 being the Sind Government share of contribution from 1st April 1948 to 22nd July 1948 also remains unpaid. Early remittance of the amount may please be expedited.

The Control of T. B. Dispensary was taken over by Pakistan Government, with effect from 1st April 1951.

- (b) *Stray Dogs.*—Rs. 214 were received for the year 1945-46. No amount due for the subsequent period from 1st April 1946 onwards has been received so far.
- (c) *Garden Road.*—Rs. 1,366 were received for the year 1947-48. No amount has been received for the remaining period since 1st April 1948 up to date. A speedy settlement could only be arrived at by personal contacts.

- (d) *Epidemic Diseases Hospital, Contribution payable by Karachi Port Trust.*

Rs. 3,000 were received for the year 1947-48. It is intimated by the Karachi Port Trust that the contribution is not sanctioned by the Board since 1st April 1948 and the amount cannot be paid to us. The Corporation representatives on the Board may be approached with a request to use their good offices to expedite requisite sanction and assure credit upto date to the Corporation of its outstanding dues.

- (e) *District Local Board (Cess).*—Rs. 7,994-13-8 were received for the period from 1st April 1946 to 29th February 1947. No payment has been received so far, for the subsequent period since 1st March 1947 to 22nd July 1948. The matter should be expedited.

From 23rd July 1948 the control of the Federal Area has been taken over by the Karachi Administration.

- (f) *Public Conveyance Fees.*—Rs. 2,905-13-5 were received for the year 1944-45. No payment has been received since 1st April 1945 upto date.

- (g) *Share of fines under Sind Shops and Establishment Act of 1940.*

Rs. 20,730-8-0 were received for the year 1946-47. No payment has been received for the subsequent period since 1st April 1947 upto date.

- (h) *Shares of fines under Adultration Act, and other Acts.*

Rs. 54,962 were received for the year 1946-47. No amount has been received for the subsequent period since 1st April 1947 upto date.

13. As the receipts from the above items form a regular source of income for the Corporation it is suggested that action may be taken by personal contacts at higher level, to ensure speedy collection of the Municipal dues.

14. *Advances.*—As already pointed out in the last year's Audit Note, the outstandings awaiting clearance in respect of "Advances" made for purchase of materials, etc., are mounting from year to year, and no fruitful attempt is made to adjust the same. The Heads of Departments asking for such advances, are primarily responsible for seeing that on receipt of goods and the Supplier's Bills, the Accountant is forthwith advised to adjust the latter against the amount originally advanced, so that necessary debits against the Expenditure Heads are raised and accounted for in the accounts of the year, so as to show the correct financial position at the close of the year as regards the surplus or deficit.

The total "advances" outstanding on 31st March 1951, amounted to 21.33 lakhs, vide para. 5 of the Audit Note, and had these been cleared in time, the deficit at the close of the year would have been much more than (minus) Rs. 10.35 lakhs shown in the final printed account.

A list of major items awaiting recoupment as on 31st March 1951, is attached as Annexure 'C' to this report.

15. *Defalcations.*—During the year no less than 10 instances of defalcations occurred. The details are given as Annexure 'D' to this report.

16. *Chief Assessor and Collector's Department—Annual Reassessment of Properties.*—The Assessor and Collector's Department, in addition to the assessment of properties newly constructed and completed during the year or to which additions and alterations are carried out in the year, undertakes general revision of various quarters in the City by rotation every

year. The assessment of lands and buildings situated in the following quarters was revised in the year under report :—

The revision instead of being completed at the beginning of the year as usual was completed as late as on 15th February 1951, when public notice of the value and time of manner of filing appeals between 15th February 1951 to 14th March 1951, was given in the Press as required by rule 4 (1) and (2) of Chapter II, Sch. VIII of the City of Karachi Municipal Act, 1933—The result was that a large No. of property tax bills in respect of the revised quarters mentioned above had to be issued at the fag end of the year and carried forward as "arrears" to next year's account.

17. A comparative statement showing the cumulative effect of revisions for 3 years ending 31st March 1951 is given below :—

18. *Assessment of Port Trust Properties.*—The last quinquennial agreement mutually agreed upon by the Municipal Corporation and the Karachi Port Trust authorities provided for payment of general tax and Fire Brigade tax, if any, in respect of properties vesting in the Board on the percentage basis at the rate of 2.25% of the total receipts of Karachi Port Trust excluding pilotage account, interest on investments on Revenue Reserve, Provident and Fire Insurance Funds—this agreement expired on 31st March 1949 and since then the Corporation in their Resolution No. 266, dated 12th November 1949, resolved "to fix the percentage of Municipal taxes payable by the Karachi Port Trust at 4% of total receipts of Port Trust less excepted items for the quinquennium from 1st April 1949 to 31st March 1954, as the taxes calculated last time excepting water tax were 10% which have now increased to 17½% in the case of ordinary rate papers". The Port Trust authorities, however, are reported to be averse not only to the proposed revised rate of 4%, but they also seek to claim exemption on the income derived from "Demurrage" which does not fall under the "excepted" items originally agreed upon by the Corporation and the Board. The basis of payment has not yet been finalised and the Board is provisionally paying the amount at the old rate of 2.25%. A sum of Rs. 2,97,541-2-0 has been provisionally paid by the Board for the year 1950-51, pending final decision, which is still awaited.

19. *Assessment of Government and North Western Railway Properties.*—The Property taxes on these buildings are being provisionally levied on the basis of valuation list received for the quinquennium commencing from 1944-45 and ending with 1948-49. The valuation list for the subsequent quinquennium commencing from 1st April 1949, for which the Government of Pakistan have appointed the Superintending

Engineer, Central Circle, Pakistan Public Works Department, Karachi, has not been received as yet. The matter requires to be expedited and bills for difference issued and recovery effected.

20. *Statement of Demand, Collection and Balance.* It may also be mentioned that hitherto the Assessor and Collector's Department use to furnish to the Accountant every month a statement of the demand raised under various heads and the Accountant is to prepare, as required by paragraph 13, of the statement of duties of the Municipal Accountant, a statement of Demand, Collection and Balance for submission to the Standing Committee every month. Such statement was prepared by the Accountant during the year 1950-51 nor has any annual statement been prepared so far. This is a serious irregularity which is brought to notice.

21. A comparative statement of net Demand, Collection and Balance under various heads as per Assessor and Collector's Jamabandies for the preceding year and the year under report as was attached to the last year's Audit Note, is not made available owing to non-tally of the figures of Jamabandies for the year 1950-51.

22. The following is a classified Summary of items in dispute and the subject matter is under correspondence with the authorities concerned :—

23. *Law suit against Dalmia Cement Co.*—A large sum is outstanding against the Dalmia Cement Co. account of Water Supply Charges. A sum of Rs. 2,000 was sanctioned by the Corporation for expenses for filing a civil suit against Dalmia Cement Factory for recovery of water supply charges, in Corporation Resolution No. 150, dated 6th September 1950.

The actual date of sanction to file legal proceedings was 30th November 1949. Full accounts of the amount spent are awaited and the suit filed in 1951 is still pending despite lapse of over two years.

The matter may be expedited by the Municipal Advocate.

24. *Exemption of General Tax.*—The Corporation in its Resolution No. 116, dated 11th July 1950 granted exemption under section 105 (1) of the City of Karachi Municipal Act, to certain residential premises occupied by officers of the Diplomatic Corps as per list sent by the Ministry of Foreign Affairs under letter No. D. 2020-P/99, dated 25th May 1949, subject to the condition that the value of exemption in respect of general tax be recovered from the Government of Pakistan.

The period upto which the amount so recovered is credited, may please be pointed out for Audit verification.

25. *Terminal Tax Department.*—A test audit of Railway invoices of T. P. X. Invoice Register and Declaration forms for April, 1950, was carried out. The following irregularities were noticed :—

227. As per Default Register of T. P. X., there were 14 cases of default during April 1950, out of which 4 items of terminal tax in respect of 4 items only has been recovered so far, and the remaining 10 items are still being unpaid, although more than 2 years have elapsed since the removal of goods from the station.

228. The default registers of City, Keamari and the Dues Office for the year 1950-51 were also checked and it was observed that a large number of items under Annexures F, G and H, respectively are still being unpaid.

229. The Superintendent, Terminal Tax has been requested to effect recovery of the outstanding dues and the result is awaited.

230. *Embezzlement of Rs. 1,260-1-0.*—As already reported in the last year's Audit Note, Naka Munshi Mirza Khan had embezzled Municipal Terminal Tax amounting Rs. 1,260-1-0 out of which a sum of Rs. 919 has been recovered so far from the employee's subsistence allowance and pay, etc. The balance of Rs. 341-1-0 is still outstanding for which necessary action requires to be taken against the sureties of Mirza Khan.

231. The income from Terminal Tax during the 3 years ending 31st March 1951, as shown in the final accounts, is as under:—

After the advent of Pakistan, the Trade and Commerce especially in the Federal Capital has risen by leaps and bounds. The above figures of Indirect Taxation would appear to show that there is a great scope for increasing the income of the Corporation from this source by revising the Terminal Tax Schedule.

The matter is brought to notice.

232. *License Department.*—The total realization of fees from Licenses under Revenue Head No. VA—during the year, amounted to Rs. 1,09,172 as against Rs. 1,11,903 in the preceding year, i.e., less by Rs. 2,731.

233. The result of scrutiny of Demand Register (License) for 1950-51 showed that in a number of cases, Inspectors had not attested to the correctness of the amount, and receipt No. and date recorded

therein. The Department also failed to prepare the usual Demand—Collection and Balance statement for the year 1950-51, though repeatedly requested by Audit.

34. A statement of arrears outstanding on 31st March 1951 as per Departmental Registers is appended below:—

35. No tangible efforts appear to have been made by the Department to collect the huge outstandings in respect of the previous years. In one particular case the Arrear Register for 1947-48 could not be produced though repeatedly called for and it was only on 8th June 1951 that the book was found pigeonholed in the License Department. This shows that no attention was being paid by the Department towards clearance of arrears, and unless some drastic action is taken against the Collecting Staff, it is feared, a huge portion of arrears may have ultimately to be written off as irrecoverable.

#### HEALTH DEPARTMENT

36. *Annual Contribution of Rs. 2,000 payable to the Government Sanitary Laboratory.*—The Municipal Corporation are annually paying a lump sum contribution of Rs. 2,000 to Government Chemico Bacteriological Laboratory for examination of water samples and reports as to the fitness of water for human consumption from time to time. It was pointed out by Audit that as from 1st November 1949, when the Karachi Joint Water Board took over control of the Dumlottee Water Works including the conduits and the Reservoirs, the payment of water analysis fees was a proper charge on the Karachi Joint Water Board and not the Karachi Municipal Corporation. In view of the above, the Chairman, Karachi Joint Water Board has been requested that the *pro-rata* charges for the period from 1st November 1949 to 31st March 1950, viz., Rs. 833-5-0 and full contribution for the year 1950-51, viz., Rs. 2,000 already paid to the Chemico Bacteriological Laboratory may be reimbursed to the Corporation. The result of the correspondence and recovery of the amount are being watched.

37. *Pauper Funeral Charges.*—The expenditure incurred by the Corporation on the funeral charges of paupers in the City is being debited to the Suspense head "Advances" in the first instance and then recovered from Government and the "Advance" cleared.

38. It has been observed that such bills for burial of paupers are received by the Health Officer from certain local Public Institutions, e.g., Anjuman-e-Musalmanan-e-Punjab. After verifying the deaths from the entries recorded in the Municipal Death Register, the Health Officer forwards the claim to the Accountant for payment to the parties concerned. Thereafter the Accountant forwards consolidated lists of amounts thus paid from the Municipal Funds to the Government Treasury Officer for reimbursement to the Corporation. This triangular transaction results in long delay in the final refund of moneys to the Corporation. With a view to simplify the whole procedure of payment and recovery it was suggested by Audit as early as on 23rd March 1950 that with effect from 1st April 1950 all such pauper bills should be duly verified and certified by the Health Officer and forwarded to the Treasury Officer, Karachi for payment direct to the party concerned. As no action appears to have been taken

the M. R. V. P. have not yet decided about this land, the question of sale of the remaining area of this land to be kept in abeyance.

The action taken in this respect by the Land Manager and how the matter stands at present may be communicated.

59. *Auction sale of Plots Nos. 100 and 102, C. F. 1/5, Clifton Quarter.*—The delay of 23 days, i.e., from 5th November 1949 to 29th November 1949 in payment of the balance of occupation value, etc., in respect of the above two open plots of Municipal land was condoned as a special case, as per Corporation Resolution No. 369 of 8th March 1950 with the sanction of the Administrator of Karachi.

The credit of interest at the rate of 6% per annum, if since recovered by the Land Manager, from the owners concerned, may be pointed out for audit verification.

60. *Lease of Plot No. 2-A, R. B. 2, Rambagh Quarter.*—The above plot was granted to the Karachi Ladies Association in 1926, free of charge and on payment of a nominal land rent of Re. 1 p. a. The Association put up their buildings which was taken over as R. A. F. Base Post Office during the War, on a monthly rental of Rs. 135 from 1st September 1943. The property taxes and land rent totalled Rs. 272-13-0 p. a. As per Municipal Legal Adviser's opinion, it was decided as per Corporation Resolution No. 373 of 14th March 1950 that rent at Rs. 135 p. m. be recovered from the Military Authorities from 1st October 1948, and to write off as "irrecoverable" the amount of Rs. 6,615 being rent from 1st September 1943 to 30th September 1947 under Section 120 of the Municipal Act.

The recovery of rent from 1st October 1947 upto date may be pointed out for audit verification.

61. *Grant of Plot No. 17, F. T. 3, Frere Town.*—The office of Messrs. Mercantile Bank of India, Ltd., to pay additional Rs. 5 per sq. yd. for the whole area of 46,085 sq. yds. of the above plot sold to them for allowing construction of a second floor also, was accepted as per Corporation Resolution No. 8 of 6th April 1950, subject to sanction of Administrator of Karachi.

The recovery of the total amount may be pointed out.

62. As per Corporation Resolution No. 75 of 5th June 1950, Lease of plots 70, 71, 114, 126, 133 and 156 M-5-Baba Bhit islands were renewed for 5 years from 1st April 1950 to 31st March 1955 in favour of Cowasji & Sons @ 0-4-0 per sq. yd. p. a. as land Rent.

Credit of the amount realized may be pointed out for audit verification.

#### PUBLIC WORKS DEPARTMENT.

63. Mr. M. K. G. Shaikh, Executive Engineer, Karachi Municipal Corporation, was granted by the Corporation, vide Resolution No. 194, dated 26th October 1950, three months privilege leave on the condition that during the leave period he will not leave the station and will make himself available to answer questions arising from any explanation he may give in regard to matters from which he had been charge-sheeted. This leave was further extended periodically to end of the year 1950-51, under report. The Executive Engineer was removed from Municipal service subsequently.

64. *Karachi Joint Water Board—Loan Liability of Rs. 95 Lakhs.*—As a result of the issue of ordinance No. XIII of 1949, by the Central Government, viz. the Karachi Joint Water Board ordinance 1949, the organization of the Haleji Water Storage Scheme along with the Dumlottee Water Works was taken over by the Board with effect from 1st November 1949.

Under Section 18 (2) (a) of the ordinance, the Karachi Joint Water Board shall pay to the Corporation a sum equivalent to the contribution paid by the Corporation towards the cost of the Haleji Water Storage Scheme. A proposal in this behalf to take over the liability of loan of Rs. 95 lakhs raised by the Corporation to pay its share of expenditure of the original Indus Water Supply Scheme was made by the Board and placed before the Corporation by the Municipal Commissioner exercising the powers of the Corporation under section 280 (2) (as amended) of the Municipal Act, resolved as under (see Corporation Resolution No. 130, dated 15th August 1950) :—

"That as recommended by the Advisory Committee in their Resolution No. 376, dated 15th August 1950 the Corporation is pleased to resolve that they agree to the proposal of the Karachi Joint Water Board taking over the Rs. 95,00,000 loan raised by the Corporation and making re-payment direct to the Debenture Holders when the loan matures subject to the condition (1) that the Corporation shall re-imbursed the interest charges so far paid by the Corporation amounting to Rs. 23,20,000 and (2) the right of the Corporation to retain the amount of premium derived by them on this loan. (3) interest would be paid by the Water Board."

It appears that no agreement has yet been finalized arrived at with the Karachi Joint Water Board in this behalf and in the meantime the interest on the Loan Debentures of Rs. 95 lakhs continues to be paid by the Corporation.

A final settlement is awaited.

65. *Compensation for Transfer of Dumlottee Water Works to K.J.W.B.*—Section 19 of the ordinance provides that the Corporation, if so required by the Central Government, shall transfer to the Karachi Joint Water Board all property, moveable and immovable connected with or ancillary or appurtenant to the Dumlottee Water Works and a Committee shall be appointed to make recommendation as to the amount and manner of compensation to be paid to the Corporation in respect of the property as transferred. Accordingly on transfer of the Dumlottee Water Works the Corporation forwarded its claim for compensation to the Chairman, Karachi Joint Water Board, but it appears that this vital question has not yet been decided finally, despite lapse of over 2 years.

66. *Payment by Corporation of Water Supply Charges.*—With regard to the payment of water supply charges to the Corporation, in accordance with the method of calculation provided in Section 22 of the Ordinance, the Corporation have been obliged to make several payments "on account" to the Karachi Joint Water Board, in the absence of bills and statements of the total quantity of water pumped and that supplied to the Karachi Municipal Corporation and the other Constituent Bodies and the remaining consumers. In this connection a reference is invited to the memo. No. E/DEE-1/433/51, dated the 8th Oct., 1951 and memo. No. E/DEE-1/345, dated 1st Feb., 1952 addressed to Municipal Commissioner by the Dy. Executive Engineer, Karachi Municipal Corporation, reproduced below :—

1. Memo. No. E/DEE-1/433/51, dated 8th October 1951.

"The Karachi Joint Water Board authorities have not as yet forwarded to us the statement of the total quantity pumped and that supplied to the other Constituent Bodies and other consumers as they were requested to do. Consequently their water supply bills for July and August are pending.

"There is a 6" water main taking off from the Temple and Currie Reservoir through which

the Board is supplying water to 600 aluminium Houses formerly known as "600 Tented Accommodation" belonging to the Pak Government beyond Abyssinia Lines. This main is open for all the 24 hours of the day and so a huge amount of water must be consumed.

On enquiries I learnt that the Karachi Joint Water Board is not recovering any charges from the Pakistan Government for the water supplied through this main.

It is feared that the Board is charging us for this water since in the absence of meters which the Board has failed to provide, we are being billed for total water pumped from both Dumlottee and Haleji sources less than for which the other consumers are billed.

A refund of several thousands of rupees will therefore be due to us for the period of about 2 years during which the Board is issuing bills to us.

The matter may therefore kindly be taken up with the Karachi Joint Water Board Authorities requesting them to apprise us of the correct position.

There may be other instances of this nature and it is therefore absolutely necessary that the statement asked for should be supplied to us by the Board without further delay."

67. Memo. No. E|DEE|1|345, dated 1st February 11952.

"From the statement received from the Karachi Joint Water Board for the months of Sep. and Oct., 1951 in respect of water supply drawn by the various constituent and non-constituent bodies and others, it is seen that during the month of Oct. 1951, the Military (Defence Department) consumed 512.38 lakhs gallons of water whereas in the previous month of Sept. 1951 the quantity was 487.31 which is about 25 lakhs less.

The Military authorities are drawing water at Malir Cantonment from two connections direct from the Dumlottee conduit.

As against this, water is being pumped and discharged by them into the conduit at Dumlottee, which is recorded by the weir on the conduit down stream.

Thus the actual quantity of water for which the Military authorities are charged by the Board is that drawn by the Military authorities in excess of that pumped by them.

It appears that in the figure given in the column No. 3 of the statement this quantity is included which is not correct as it results in our having to pay for water drawn by the Military equivalent to the quantity pumped by them. The quantity included in column No. 3 should be the total quantity drawn by the Military authorities at Malir Cantonment irrespective of the quantity pumped and discharged by them into the conduit.

As the quantity of water pumped by the Military is some lakhs of gallons every day, it would probably mean that we have paid several thousands of Rupees in excess to the Karachi Joint Water Board during the past two years."

68. "The Karachi Joint Water Board may therefore kindly be informed of the position and requested to clarify the matter and if any mistake has occurred, to give us credit for the excess amount recovered.

The two statements referred to are enclosed."

69. It would be seen from the above, that the Corporation is also made to pay for water drawn by the

Military Authorities equivalent to the quantity pumped by them into the conduit at Dumlottee, and that a refund of several thousands of Rupees is due to the Corporation on account of excess payments made to the Karachi Joint Water Board on this and similar other accounts during the past 2 years.

70. As the question of correct charges payable by the Corporation after proper verification of the water supply bills by our Public Works Department cannot be indefinitely held over, it is requested that this important matter may be brought on the Agenda of the Board's meetings and the Karachi Joint Water Board Authorities informed of the position and asked to clarify the same and give us credit for the excess amounts recovered so far, if any.

71. The urgent installation by the Karachi Joint Water Board of the Water Meters as enjoined in the Ordinance is long overdue.

72. 36" Rising Main and Additional Sewage Pumping Sets at Barnes Street Station.—A cheque for Rs. 4,86,000 towards the cost of C. I. Pipes, Pulsometer pumps, 125 Sluice valves and 8,000 Fittings was sent to Accountant-General, Pakistan Revenues, under Corporation letter, dated 29th June 1949. Somehow the cheque was not cashed and it became time-barred. In the meantime the Director General, Supply and Development acting on the above letter had placed an order with M/s. Societies Des Fonderies, Nance (France) for the supply of C. I. Pipes and Specials valued at £. 3,291-16-4. There was devaluation of the Pound Sterling and the Corporation consequently requested Director General to allow payment in Sterling. Director General replied that necessary credit had already been opened and that Corporation should pay Rs. 4,65,000 immediately, the Suppliers declared a discount of 5% off their original contract price. The Director General could not also give the date of opening of the credit which was said to be established by the High Commissioner for Pakistan in U. K. at the time of placing the Contract price. The final adjustments would be made on receipt of London accounts. Accordingly as advised, Rs. 4,65,000 was paid to Accountant-General, Pakistan Revenues, vide Corporation Resolution No. 4 of 5th April, 1950.

73. The above consignment has apparently been delivered. If so, the transaction may be completed and the exact total cost adjusted finally.

74. The Accountant-General, Pakistan Revenues may be consulted to intimate from the relevant London Account (since received) the exact date and the total amount of contract price in sterling.

75. Disposal of Sewage at Nazimabad.—Estimates amounting to Rs. 2,05,991 for laying 18" Rising Main from Nazimabad to Sewage Farm No. I and to instal an Electric pump and Pump room for disposal of sewage of Nazimabad (Golimar Colony) was sanctioned by Corporation vide their Resolution No. 6 of 5th April 1950. The Chief Engineer, Pak. P.W.D. in his letter No. 741|121, dated 21st March, 1950 wrote that this Estimate has been incorporated in their estimates for Rs. 88,64,000 for the entire development Scheme of Nazimabad and that the Corporation should go ahead with the execution of this work. The total amount thus spent would be re-imbursed to Corporation by the Central Government.

A further report as to how the matter stands at present is awaited.

76. Karachi Cantonment Board.—An agreement existed between the Karachi Cantonment Authority regarding disposal of Cantonment area sewage through Municipal Sewers. The payment has been stopped since 1942, although this had been actually agreed to first by this Board and there is no reason whatsoever for backing out.

2. As per Corporation Resolution 88, dated 14th June 1950, it was decided that the Karachi Cantonment Board should pay the revised charges of

Rs. 3,000 p.a. for the discharge of sullage into the Municipal Sewers from Cantonment Tipping Station from 18th August 1942, the date on which the agreement ended, up-to-date.

As this involves recurring loss of Municipal revenue, a decision may be arrived at as soon as possible.

77. *Annual Contracts for Roads and Footpaths.*—As recommended by the Advisory Committee in its Resolution No. 406, dated 25th November 1950, the Corporation (Resolution No. 219 of 30th November 1950) accepted the lowest tender of M/s. Husain D'Silva for construction of footpaths and roads for the year 1950-51, and further sanctioned the works already executed in anticipation of acceptance of the tender. The non-framing out of annual contracts well in advance of the commencement of the new financial year, so as to enable contractors to execute work from 1st April onwards, is brought to notice.

78. *Annual Tender for Kerosene Oil and Petrol for 1950-51.*—As per Audit observations the actual total cost of supply of Kerosene oil and Petrol by each of the three big local oil companies, i.e., Standard Vacuum Oil Co., Burmah Shell and Caltex, during 1950-51, was corrected from Rs. 23,414|1|- to Rs. 40,080|12|- excluding sales tax, as per Corporation Resolution No. 228, dated 12th December 1950, issued in modification of Corporation Resolution No. 24, dated 21st April 1950. Such clerical mistakes in calculation of total cost of purchases involving nearly Rs. 50,000 may be avoided.

79. *Loss of Measurement Book No. 12.*—A Municipal P.W.D. Carpenter Ibrahim Nawab, after quitting service was commissioned departmentally for supplying and fitting Counters in Accounts Branch. The final bill was held up in Audit, as the Measurement Book was not forthcoming and later reported to be lost.

80. The Corporation while sanctioning write off of the loss of Measurement Book No. 12, in which first measurements were recorded ordered:

- (i) payment of the final bill in another Measurement Book after recording complete measurements; and
- (ii) fixing responsibility for the loss of Measurement Book and action taken (Corporation Resolution No. 327, dated 25th January 1950).

But no action has been taken so far. The services of the then Executive Engineer have since been dispensed with.

81. *Register of Measurement Books.*—The Register of Measurement Books is not maintained up-to-date. The entries are not attested by any responsible officer, with the result that new Measurement Books are being issued when a large number of old Measurement Books are still under use. New Measurement Books should in future be issued only when the old ones are completed and duly returned for permanent record.

The position will again be reviewed and reported in next Audit Report.

82. *Purchase of Cement through Government Agency.*—Future supplies of Cement for Municipal works at cheaper rates than market quotations as approved by Corporation (Corporation Resolution No. 307 of 5th January 1950) are to be obtained at the Government control rates through Director, Supplies and Development.

In case it is not possible to follow the procedure outlined, as above, due to unforeseen circumstances, fresh orders of Corporation may be obtained.

83. *Register of Municipal Buildings.*—Plans and Estimates amounting to Rs. 10,000

Office Compound. The work has been completed. This structure should be recorded in the Register of Buildings maintained by Public Works Department but so far the register has not been produced for Audit verification.

As already reported in the last year's Audit Report no up-to-date Register of Municipal Building and properties showing details of area, construction, etc., is maintained by the Public Works Department. A report of compliance is still awaited.

84. *Stores Ledger of Electric Section.*—No store ledger is maintained by the Electric Section of Building Department. Few entries in pencil are made in an unbound Note Book, and no receipts, issues and balances are recorded, nor are entries authenticated by the head of the Department.

This is a serious irregularity and accordingly brought to notice.

85. *Stores Ledger in Municipal Workshop.*—The stores ledger maintained by the Municipal Workshop is incomplete in many respects and the same irregularities are observed in it as pointed out in the previous paragraph.

Instructions may kindly be issued to complete the Register in all respects and forward the same to Audit for check and verification.

86. *Schedule of Rates.*—No schedule of revised rates for various works and supply of materials has been compiled by the Public Works Department yet, in spite of Audit reminders issued from time to time.

A report of compliance will be awaited.

87. *Electric Light Register.*—The non-maintenance of a complete register showing the electric lights, equipment, fittings and fixtures within Municipal limits by the Roads Department is brought to notice.

#### AGRICULTURE DEPARTMENT

88. *Under-developed area of Sewage Farm No. I for Cultivation.*—The Ex-Chief Officer was authorized by the Corporation vide their Resolution No. 1 of 1st April 1950, to invite public quotations for leasehold rights for three years of the reclamation and development of the adjoining Kalarish area of 4 acres of Sewage Farm No. II for utilization and sanitary disposal of additional surplus Sewage.

Action taken on this scheme may be communicated.

#### GENERAL DEPARTMENT

89. *Delegation of Powers.*—In March 1950 the then Municipal Commissioner ordered that as most of the Licenses in respect of various licenseable trades, etc. were being granted under Section 155 of the Municipal Act, which forms a part of "Public Health and Safety", it was essential that the power of granting licenses for these trades should be delegated to the Health Officer, who is responsible for such matters pertaining to the Public Health and also possesses the necessary qualifications.

90. Accordingly in supersession of the previous orders delegating the powers of Chief Officer in connection with License Department to the Deputy Chief Officer the Municipal Commissioner approved the proposal of the Standing Committee to delegate such powers under Section 38(4) of the Karachi Municipal Act, 1933, to the Health Officer (vide Standing Committee Resolution No. 130, dated 12th August 1950).

The further delegation of powers, under Section 38(4) of the Act, made during the year are detailed below:—

Resolution No. 211, dated, Section detailed

"For the time being estimate for sums of less than Rs. 500 may be sanctioned by Deputy Chief Officer on my behalf".

Standing Committee Resolution No. 214, dated 20th November 1950.

"Deputy Chief Officer may sanction non-recurring expenditure up to Rs. 100 at a time".

The delegation of power to Deputy Chief Officer to sanction non-recurring expenditure up to Rs. 100 at a time is not clear and requires to be amplified so as to prevent splitting up of purchases of same item at different times which would otherwise require sanction of higher authority.

91. *Accounts Department.*—The Karachi Municipal Corporation was without a full-fledged Accountant from 1st April 1950 to 17th October 1950 when the present incumbent Mr. Irshad Husain, M.A., LL.B., was appointed on Rs. 460 p.m. in the enhanced time pay scale of Rs. 400—20—600.

92. *List of Approved Banks.*—The National Bank of Pakistan was brought on the approved list of Banks for purposes of investments of surplus moneys of the Corporation (*vide* Corporation Resolution No. 173, dated 25th September 1950).

93. *Opening of Current Accounts.*—With effect from 1st May 1950, current account and coupon account with the Imperial Bank of India was closed and opened with the State Bank of Pakistan and Habib Bank Limited respectively. (Corporation Resolution No. 335, dated 31st January 1950.)

94. *Mayors Thar Relief Fund.*—At the instance of Audit, a sum of Rs. 248|10|9 left over since 31st December 1948 with the Sind Provincial Co-operative Bank, towards Mayors Thar Relief Fund was withdrawn and credited into the Municipal Funds.

95. *Services rendered at Government Colonies and Refugee Camps.*—As recommended by the Municipal Advisory Committee in Resolution No. 381 of 5th September 1950, the Corporation, *vide* resolution No. 544, dated 9th September 1950, resolved that the amounts of Rs. 4,55,989|6|— and Rs. 1,89,854|5|— outstanding on account of services rendered to the Government colonies and the Refugee camps should be paid by Government to Karachi Municipal Corporation in view of its slender resources. And to request the Government to settle the accounts soon, in the meantime these essential services should be continued. If recoveries have been effected in full, corresponding credits may be shown. If not, final decision of Government be obtained.

96. *Transfer of Tuberculosis Dispensary.*—One of the conditions of transfer of the Tuberculosis Dispensary to Government as agreed to by Corporation, *vide* resolution No. 168, dated 21st September 1950, was that Government should pay to the Corporation a sum of Rs. 6,500 to meet the cost of construction of a new Municipal Drug Store Room in place of one located in the T. B. Dispensary. The recovery may be pointed out to verify credit of the amount if since realized.

97. *Grant of Honoraria.*—On 17th November 1950 the Municipal Fire Brigade staff extinguished the fire at near by Tatta Town. On 21st November 1950 the Superintendent, Fire Brigade's request for grant of Honorarium of Rs. 255 was sanctioned by the Corporation, *vide* Corporation Resolution No. 229, dated 12th December 1950.

98. A sum of Rs. 1700 was paid to the Corporation for hire charges of fire engines by the organizers of the Pakistan International Industries Fair held from 1st September 1950 to 5th October 1950. As proposed by the Superintendent, Fire Brigade, an Honoraria of Rs. 445 was paid out of this sum to the Fire Brigade Staff for performing extra duties, *vide* Corporation Resolution No. 206, dated 19th November 1950.

99. *Payment of Water Supply Bills to Karachi Joint Water Board.*—The Corporation (Resolution No. 169, dated 22nd September 1950) resolved that Government be moved to waive the recovery of the difference between the amount of the bills received from the Karachi Joint Water Board and the amount available with the Corporation for payment of the water supply charges in view of the legal difficulty of recouping the increased cost for the period intervening between the actual levy of increased water tax and the date from which the Karachi Joint Water Board took charge of water supply. The Municipal Commissioner remarked that "This must be dealt with most expeditiously as every day delayed means loss of thousands of tax money." The final decision of the Government in this respect may be communicated, if since received.

100. *Authorization of Excess Payments by Accounts Department.*—(a) During the year 1950-51, as a result of "pre-audit system" no less than 75 instances were detected involving excess payments aggregating of Rs. 4,686|8|—. These amounts were "retrenched" from the pay orders authorized for payment by the Accounts Department as these were inadmissible. Out of these, only 7 cases were for higher amounts, totalling Rs. 3,718|8|—, as per details given in Annexure 'I' to this Report. The remaining 68 cases pertained to smaller amounts to the extent of Rs. 968.

(b) Apart from Cash vouchers, cases of wrong adjustments on account of inter-departmental debits and wrong postings in the Monthly Revenue and Expenditure Abstracts were also rectified. There was absolutely no supervisory check over the classification and posting of challans in the Revenue Abstracts and the Revenue Accountant was content with the mere signing of challan receipts.

(c) The Deposit ledgers for the year 1950-51 have not so far been completely totalled and tallied with the corresponding figures appearing in the Revenue-Abstracts, not has the usual reconciliation statement of receipts, payments and balance in respect of Deposits prepared by the Accounts Department. This is a serious irregularity, which is brought to notice and its early compliance is awaited.

101. *Continuation in Service of Superannuated Employees.*—As per rule I, Chapter V-G. Sch. I of the Municipal Rule Book, no officer or servant should be continued in service after he has completed 55 years of his age.

102. The Departmental Heads as well as Accounts Department again failed to submit the list of such employees on 1st September, each year, as required *vide* Rule II of Chapter V. F. Sch. I, though this omission was pointed out as far back as on 26th March 1949 and subsequently on more occasions than one. The result was that several superannuated employees, as per list appended below, were continued in service without sanction of the Corporation, involving excess expenditure due to higher salary drawn by these people as against the minimum to which the new employees would have otherwise been eligible.

103. In the following typical cases, sanction of the Corporation was obtained to regularise continuance in service, at the instance of Audit:—

### "ALL PAKISTAN" SECOND FORECAST OF RICE CROP FOR THE YEAR 1953-54

No. F. 4-11-Stat-53-54.—The second forecast of the area under rice crop for the year 1953-54 is 23,568,000 acres as against 22,157,000 acres reported in the second forecast of the previous year, and shows an increase of 6.4 per cent. The acreage reported in the final forecast of last year was 23,016,000 acres.

With the exception of N.-W.F. Province, there has been a general increase in the acreage of this crop throughout Pakistan, which is attributed partly to favourable weather conditions and sufficient supply of water at the time of sowing and partly to high prices of rice, and the Grow More Food Campaign. In East Bengal, where the largest increase in acreage has occurred, the increase is largely due to reduction in jute cultivation.

The condition of the crop is good.



## REMARKS

During the week ending the 2nd January 1954 in 16 towns of Pakistan (excluding Sind, East Bengal and 8 towns of the Punjab Province) having a population of 30,000 and over, the total number of deaths recorded was 522. The 1951-Census population of these towns was 2,656,906 and the death rate per thousand was 10. The births in the same towns numbered 1,990, giving a birth rate of 38.9 per thousand of population.

In the above-mentioned towns of Pakistan cholera, smallpox and plague remained absent during the week under report.
