PART I

Notifications relating to Rules, Regulations and Orders issued by the Ministries of the Government of Pakistan, other than the Ministry of Defence, and by the Federal Court of Pakistan

MINISTRY OF AGRICULTURE

Karachi, the 13th July 1955

No. F. 9-6/55-M. & P.P.—In exercise of the powers conferred by sub-section (1) of section 3 of the Destructive Insects and Pests Act, 1914 (11 of 1914), the Central Government is pleased to direct that the following further amendment shall be made in the late Government of India, Department of Agriculture, Notification No. 1581-Agr., dated the 1st October 1931, namely:—

In the said Notification in paragraph 2, after sub-paragraph (d), the following new sub-paragraph (e) shall be added, namely:—

“(e) No vessel carrying American Cotton shall enter the territorial waters of Pakistan without the previous permission in writing of the Director of Plant Protection, Government of Pakistan, Karachi, for which application shall be made to the said officer at least fourteen days before the expected arrival of the vessel”.

No. F. 3-138/51-C.S.—The following Rules for Recruitment to the Class I and Class II Technical Services in the Cooperation and Marketing Department, are published for general information:—

PART I

METHOD OF RECRUITMENT

1. These rules may be called Cooperation and Marketing Department Class I and Class II Technical Services Recruitment Rules.
2. For the purpose of these rules—
 - (a) ‘Government’ means the Governor-General.
 - (b) ‘The Commission’ means the Pakistan Public Service Commission.
 - (c) ‘The Service’ means the Cooperation and Marketing Department Class I and Class II Technical Service which includes the posts mentioned in Schedule I.
 - (d) ‘Direct recruitment’ means recruitment otherwise than by promotion or by transfer.

3. Recruitment to the Service shall be made by the following methods:—

- (i) By promotion in accordance with Part II of these rules.
- (ii) By direct recruitment in accordance with Part III of these rules.

4. Subject to the provisions of rule 3, Government shall determine the method or methods to be employed for the purpose of filling any particular vacancy or vacancies as may require to be filled during any particular period and the number of candidates to be required by each method.

5. Vacancies which are filled by direct recruitment shall be distributed between the various Provinces of Pakistan in accordance with the Establishment Division's office memorandum No. 25|10|50|SE. I, dated the 6th October 1950 and office memorandum No. 25|68|50-SE. I, dated the 22nd January 1952 and the supplementary instructions issued from time to time.

PART II

RECRUITMENT BY PROMOTION

6. Recruitment by promotion to the posts in the various categories as detailed in Schedule II shall be made by selection from among the class of Government servants as mentioned below:—

- (1) Senior Marketing Officer, from Marketing Officers.
- (2) Marketing Officer, from Assistant Marketing Officers.
- (3) Deputy Director (Cooperation), from Assistant Director (Cooperation).
- (4) Chief Chemist, from Senior Chemist.
- (5) Senior Chemist from Junior Chemist.

7. 33-1|3% vacancies in each of the grades mentioned above, viz. Senior Marketing Officer, Marketing Officer, Deputy Director (Cooperation), Chief Chemist and Senior Chemist, shall be filled by promotion based on selection in the light of the Establishment Division's office memorandum No. 15|38|52-SE. II, dated the 29th January, 1954.

8. In case there is only one post of a particular class of service it should be filled once by promotion and twice by direct recruitment.

9. Recruitment by promotion shall be made through the Departmental Promotion Committee of the Ministry of Agriculture, of which the Cooperation and Marketing Adviser shall be a member, and with the approval of the Commission as required by the Pakistan Public Service Commission (Consultation by the Governor-General) Regulation, 1953.

10. All promotions from Class II to Class I shall be made with the approval of the Commission.

11. Only those who have put in at least five years' service in their existing grade shall be eligible for promotion.

12. Promotion from a lower grade to a higher grade shall be restricted to the officers belonging to the particular group in the Cooperation and Marketing Department, in which the vacancy has occurred.

13. If no suitable candidate is available for promotion to any post mentioned in rule 7, such posts shall be filled with the approval of the Commission.

PART III

DIRECT RECRUITMENT

14. Subject to the provisions of Part II of these rules, recruitment to other posts mentioned in

15. Appointment by direct recruitment shall be made on the recommendation of the Commission on an all-Pakistan basis.

16. Every candidate for direct recruitment

(a) shall be:—

- (i) a citizen of Pakistan, or a person domiciled in Pakistan; or
- (ii) a person in whose case a declaration has been made under section 262 of the Government of India Act, 1935 (as adapted for Pakistan);

(b) shall be not less than the minimum age and not more than the maximum age prescribed for the various categories of posts detailed in Schedule III to these rules;

(c) shall have the qualifications prescribed in Schedule III; and

(d) shall satisfy the Government that his character and antecedents are such as to make him suitable for appointment to the Service/Department.

17. The maximum age, wherein prescribed in Schedule III, shall be relaxed as follows:—

(a) by three years in the case of Scheduled Castes and candidates belonging to the Tribal Areas of the N.-W. F. P. and Baluchistan, the Frontier States and Baluchistan States and the excluded Area in the District of Ghazi Khan District of the Punjab;

(b) by two years in the case of candidates belonging to the excluded areas of East Pakistan; and

(c) by three years in the case of candidates who are permanent residents of Azad Kashmir Territory, the Gilgit Agency or Baltistan; candidates who belong to the State of Jammu and Kashmir and are living in these areas or in any other part of Pakistan.

Note 1.—The term 'Scheduled Castes' in this rule means any of the castes mentioned in the Government of India (Scheduled Castes) Order, 1936, as in force in Pakistan. Such candidates shall be required to submit a certificate from the Magistrate of the District in support of their claim.

Note 2.—Only candidates who are permanent residents of the Areas mentioned in clauses (a) and (b) of this rule, and whose families have been living in those areas, shall be eligible for the concession and in each case a certificate from the Political Agent or Deputy Commissioner shall be required to be produced. Members of Tribes belonging to the Tribal Areas who have settled in Settled Districts shall not be eligible for the concession.

Note 3.—Candidates who are permanent residents of Azad Kashmir Territory, Gilgit Agency or Baltistan, or those belonging to the Jammu and Kashmir State who have migrated to the said areas or to any other part of Pakistan, shall be eligible, and the concession shall be admissible in each case on the production of a certificate from the Ministry of Kashmir Affairs.

18. (a) Applications for direct appointment shall be submitted to the Commission in such form, on such date and in such manner as the Commission may prescribe.

(b) Persons in Government service shall, in the matter of applications, be governed by the provisions of the Government Servants Applications for (Central Services) Rules, 1953.

(c) The decision of the Commission as to

19. The Government, in consultation with the Commission, may modify or waive the requirements of rule 16(b) only, when an appointment for work of a special nature is to be made and it is not practicable to obtain a suitable candidate, who fulfils all the requirements of rule 16.

20. No candidate shall be appointed to the Service unless he is in good health and free from any physical or mental defect likely to interfere with the discharge of his duties as an officer in the Service Department. A candidate, (who after such medical examination as Government or the appointing authority, as the case may be, may prescribe) is found not to satisfy this requirement, shall not be appointed.

21. Probation :—

- Appointments shall be made on probation for a period of one year.
- If, in the opinion of Government, the work or conduct of an officer on probation is unsatisfactory or shows that he is unlikely to become efficient, Government may discharge him forthwith.
- On the conclusion of his period of probation, Government may confirm him in his appointment, or if his work or conduct has, in the opinion of Government, been unsatisfactory, Government may either discharge him from service or may extend his period of probation for such further period, not exceeding one year, as Government may think fit.
- If no action is taken by Government under sub-rule (b) or (c) of this rule, the period after the prescribed period of probation shall be treated as an engagement until further orders.

4. The Returning Officer shall hold the scrutiny on the date and hour fixed therefor and shall decide which of the persons so nominated has been validly nominated, such persons being hereinafter called "the candidates".

5. If the number of candidates is one, the Returning Officer shall declare him to be elected and shall return his name in writing to the Chief Commissioner for being communicated to the Secretary of the Constituent Assembly.

6. If the number of the candidates is more than one the Returning Officer shall hold the poll on the date and hour fixed therefor and shall in a notice addressed to the members of the Council of Rulers give a list of the names of the persons in alphabetical order.

7. Any of the candidates may withdraw his candidature on the date and hour fixed therefor, by notice in writing addressed to the Returning Officer. If the number of the candidates who has not withdrawn is one, the Returning Officer shall cancel the poll and take action as provided in Clause 5 above.

8. The poll shall be conducted by the Returning Officer with the assistance of such officers as he may appoint:

- (a) A ballot-paper shall be issued to each person who, under the provisions of the Representation of States and Tribal Areas Act, 1955, is qualified to vote.
- (b) The Poll shall be by Secret ballot by means of ballot-papers containing the names of the candidates in alphabetical order; and the person voting shall cast his vote by placing the mark of a cross against the name for which he wishes to vote.
- (c) The ballot-papers shall be issued from a Book of Ballot-papers with counter-foil, the Ballot paper and each counter-foil being numbered.
- (d) All marked papers shall be deposited in a Ballot-Box to be placed in front of the Returning Officer.
- (e) If a Ballot paper is spoiled by any person he shall return his paper to the Returning Officer who shall issue a second ballot-paper cancelling the first ballot-paper and marking the cancellation on the paper and the counter-foil.

9. The Ballot-paper shall be invalid if—

- (a) there is upon it any word or mark by which the person voting may be identified;

- (b) it does not contain a cross mark against the name of a candidate;
- (c) it contains cross marks against the names two or more candidates; or
- (d) if there is any uncertainty as to the identity of the candidate for whom the vote has been cast.

10. After all the votes have been cast the Ballot-Box shall be emptied in front of the Returning Officer who shall examine the ballot-papers, reject any which may be invalid, and count the number of the ballot papers.

11. (1) After counting the Returning Officer shall declare to be elected the person who has obtained the largest number of votes and shall return in writing under his hand to the Chief Commissioner of Baluchistan for communication to the Secretary of the Constituent Assembly.

(2) In case of an equality of votes the Returning Officer shall declare a candidate to be elected by drawing lots.

REMARKS

During the week ending the 11th June, 1955, in 12 towns of Pakistan (excluding Sind, Karachi, East Bengal Province and all towns of the Punjab Province) having a population of 30,000 and over, the total number of deaths recorded was 408. The 1951-Census population of these towns was 1,543,307 and the death rate per thousand was 13.7. The births in the same towns numbered 927 giving a birth rate of 31.2 per thousand of population.

In the above mentioned towns of Pakistan there were 4 deaths from small-pox. The deaths from small-pox were recorded in Lahore (Punjab Province).

Cholera and Plague remained absent during the week under report.
