

"ALL PAKISTAN" FINAL ESTIMATE OF WHEAT CROP FOR THE YEAR 1954-55.

No. F. 4-5|54-55|A.E.& S.—Area.—The final estimate of the area under wheat crop for the year 1954-55 is 10,661,000 acres, as against 10,651,000 acres reported in the final estimate of the previous year. This shows an increase of 0.1 per cent. With the exception of Punjab, Bahawalpur and East Bengal, the area under wheat declined all over Pakistan, which is attributed to unfavourable weather conditions at the sowing time in Baluchistan and N.-W. F. P., increased acreage under oilseeds and lack of irrigation water at the time of sowing in Sind, and failure of floods in Katcha Region in Khairpur. The slight increase in acreage under wheat in the Punjab, Bahawalpur and East

Bengal is attributed to Grow More Food Campaign and favourable weather at the sowing time.

Yield.—The final estimate of the yield of wheat is 3,172,000 tons, as compared with 3,683,000 tons reported in the final estimate of previous year. It is a decline of 13.9 per cent. The decline in production is primarily due to lower yields in all areas of Pakistan except East Bengal and Bahawalpur. Reduction in yield is also attributable to continued long dry spells and canal closures in Punjab, lack of rains in N.-W. F. P., and untimely rains with cold winds and storms in Baluchistan. The decrease in production in Sind and Khairpur is mainly due to reduced acreage under the crop.

REMARKS

During the week ending 24th September, 1955, in 19 towns of Pakistan (excluding Sind, East Bengal, and 5 towns in Punjab Province) having a population of 30,000 and over, the total number of deaths recorded was 916. The 1951 Census population of these towns was 2,935,623 and the death rate per thousand was 16.2. The birth in the same towns numbered 2,720 giving a birth rate of 41.1 per thousand of population.

Smallpox, Cholera and Plague remained absent during the week under report.
