No. 7(14)-IF. III/57.—The Central Government is pleased to direct that the following amendments shall, with immediate effect, be made in the Post Office Annuities Rules, 1957, namely :—

1. In Rule 11 of the said Rules for the words "one month" occurring after the words "deferred annuities", the words "one calendar month" shall be substituted;

2. In Rule 12 of the said Rules, the following sentence shall be inserted at the beginning of the Rule, namely :—

"A policy relating to a deferred annuity may not be surrendered before the expiry of 12 complete months from the date of its purchase except with the prior sanction of the Director General and subject to such conditions as he may impose before allowing the surrender";

3. For Rule 14 of the said Rules, the following shall be substituted, namely :—

"14. *Conversion of an Annuity Policy.*—A policy holder may, at any time, before the commencement of the policy but after payment of premia for an integral number of years in the case of instalment premia policy or on expiry of an integral number of years in the case of single premium policy, apply for :—

(a) his policy being made paid up for a reduced amount of annuity free from future payments of premia. In a case where the paid up value is not an exact multiple of Rs. 300, a paid up policy for an annuity which is multiple of Rs. 300 next below the paid up value shall be issued and the balance shall be paid to the annuitant on the date of commencement of the annuity and where the paid up value is less than Rs. 300, the paid up value shall be paid to the annuitant on the date of the commencement of the policy;

(b) commutation of future premia by payment of a lump sum;

(c) conversion of the policy involving one or more undermentioned changes:—

- (i) reduction in the amount of the annuity;
- (ii) alteration in the duration of the annuity;
- (iii) alteration in the period of deferment;
- (iv) conversion of a deferred annuity into an immediate one.

PROVIDED that any change under this rule will be subject to such terms, conditions and/or payments as may be communicated by the Director to the policy holders."

PART I.—METHODS OF RECRUITMENT

1. These Rules may be called Recruitment Rules for the post of Studio Executive Class III (Non-gazetted) in Radio Pakistan.

2. For the purposes of these Rules—

- (a) 'Government' means the President.
- (b) 'Director General', means Director General, Radio Pakistan.
- (c) 'Post' means the post of Studio Executive in Radio Pakistan.
- (d) 'Department' means Radio Pakistan.
- (e) 'Direct appointment' means appointment made otherwise than by promotion or transfer from another Service/Department.

3. The posts shall be filled by direct appointment in accordance with Part II of these Rules.

4. Vacancies in the post shall be distributed between the Provinces in accordance with the Establishment Division Office Memorandum No. 25/10/50-SEI, dated 6th October 1950, and Office Memorandum No. 25/68/50-SEI, dated the 22nd January 1952, and the supplementary instructions issued from time to time.

PART II.—RECRUITMENT BY DIRECT APPOINTMENT

5. Recruitment to the post shall be made by direct appointment by Director General, Radio Pakistan after advertising the vacancies in the Press and intimating to the Employment Exchange vide Establishment Division Office Memorandum No. 15/23/52-SEII, dated the 10th February 1956.

6. A candidate for appointment to the post must :

- (a) be a citizen of Pakistan. The President may authorise the temporary employment of a person who is not a citizen of Pakistan.

(b) not be less than 20 years and more than 30 years of age at the time of submission of the application, relaxable in the case of permanent Government servants and those who have put in continuous temporary service for 3 years in Radio Pakistan.

(c) have passed at least the Intermediate Examination of a recognised University.

(d) also possess such special qualifications as Government may prescribe for the post.

(e) satisfy the Director General that his/her character and antecedents are such as to make him/her suitable for appointment to the post.

7. Government may modify or waive all or any of the requirements of Rule 6(b) (c) and (d) when it is not practicable to obtain a suitable candidate who fulfils all the requirements of these sub-rules.

8. (a) Applications for appointment to the post shall be submitted to the Director General in such form, on such date and in such manner as the Director General may prescribe.

(b) Persons already in service shall in the matter applications be governed by the provisions of the Government Servant's Application for posts (Central Services) Rules, 1953. Candidate who join Government service after they have submitted their applications should also obtain in writing the permission of the Head of the Department concerned and forward the same to the Director General immediately thereafter.

(c) The decision of the Director General as to the eligibility or otherwise of a candidate shall be final.

9. The upper age limit laid down in Rule 6(b) and (c) will be relaxed as follows :—

(a) by three years in the case of Scheduled Castes and candidates belonging to the Tribal Areas of the former North West Frontier Province and Baluchistan, the Frontier State and Kalat Division and the excluded areas in the Dera Ghazi Khan District of West Pakistan ;

(b) by two years in the case of candidates belonging to the excluded areas of East Pakistan ;

(c) by three years in the case of candidates who are permanent residents of Azad Kashmir Territory, the Gilget Agency or Baltistan or candidates living in these areas or in any other part of Pakistan who belong to the State of Jammu and Kashmir.

Note 1.—The term "Scheduled Castes" means a scheduled caste determined in accordance with the provisions of Article 204 of the Constitution. Such candidates will be required to submit a certificate from the District Magistrate in support of their claims.

Note 2.—Only those candidates who are permanent residents of the areas mentioned at (a) and (b) above and whose families have been living in those areas will be eligible for the concession and in each case a certificate from the Political Agent or the Deputy Commissioner will be produced. Members of the tribal areas who have settled in the settled districts will not be eligible for this concession.

Note 3.—The concession mentioned at (c) above will be admissible to candidates who produce a certificate from the Ministry of Kashmir Affairs, Government of Pakistan.

10. A candidate for direct appointment to the post must be in good mental and bodily health and free from any physical defect likely to interfere with the discharge of his/her duties as an officer of the service. A candidate who, after such medical examination, as Government may prescribe, is not found to satisfy these requirements, shall not be appointed.

11. (a) Appointment shall be made on probation for period of one year.

(b) If, in the opinion of Government, the work or conduct of an officer on probation is not satisfactory or shows that he/she is unlikely to become efficient, Government may forthwith revert or discharge him/her from the post.

(c) On the satisfactory conclusion of his/her period of probation, Government may confirm the officer in his/her appointment or if his/her work or conduct has in the opinion of the Government been unsatisfactory, Government may either revert or discharge him/her from the post forthwith or may extend his/her period of probation for such further period, not exceeding one year, as Government may think fit.

(d) If no action is taken by Government under sub-rule (b) or (c) of this rule, the period after the prescribed period of probation shall be treated as temporary engagement until further orders.

No. 317/58.—The following bye-laws for the registration and control of dogs and the prevention of rabies in Fort Sandeman Cantonment, framed by the Cantonment Board, Fort Sandeman, in exercise of the powers conferred by Section 119 read with Section 283 of the Cantonments Act, 1924 (II of 1924), are published for general information, the same having been previously published by the said Board and approved and confirmed by the Central Government, as required by sub-section (1) of Section 284 of the said Act, namely :—

BYE-LAWS

In these bye-laws unless there is anything repugnant in the subject or context, "Veterinary Officer"

means any Veterinary Officer in Military or Cantonment Board employed on duty in the Cantonment, of or above the rank of a Veterinary Assistant in Government Service.

2. Every person owning or keeping a dog or dogs or otherwise incharge thereof within Cantonment limits shall, within fifteen days after these bye-laws came into force or within fifteen days after bringing the dog or dogs within such limits, as the case may be, cause such dog or dogs to be registered in a book kept for the purpose

(a) in the case of dogs kept in the lines of a Military Unit, by the Officer Commanding the Unit,

(b) in the case of all other dogs, at the office of the Cantonment Board:

Provided that no registration shall be necessary

(i) if the owner of the dog or dogs is a member of a recognised Kennel Club;

(ii) if the dog or dogs is/are kept within Cantonment limits temporarily for a period not exceeding one month; and

(iii) in the case of puppies of not more than three months of age.

NOTE:—An applicant for the registration shall state:—

(i) the sex;

(ii) the colour; and

(iii) the breed (if known) of the dog or dogs owned or kept by him.

3. Such registration shall hold good up to the 31st March next following on or before the 1st April following every owner or keeper of a dog or dogs already registered shall apply for the renewal of the registration of his dog or dogs to the authorities mentioned in clause (a) or (b) of bye-law 2, as the case may be.

4. A list of all dogs registered by an Officer Commanding a Units shall be forwarded by him to the Executive Officer by the 15th April in each year and in the case of Units arriving at the Station after 15th April within a month after the date of their arrival. Such consequent additions or alterations as may be found necessary in that list shall likewise be communicated by the Officer Commanding to the said Executive Officer, quarterly on the 1st January, 1st July and 1st October, in each year.

5. Every registered dog shall wear a collar to which shall be attached a metal token bearing the number in the register. The token shall be of such pattern as may be determined by the Executive Officer from time to time, and shall be of a size easily distinguishable and shall bear consecutive numbers.

6. Each metal token shall be supplied by the Executive Officer or the Officer Commanding the Unit, as the case may be, on payment of cost as may be notified by the Board from time to time. In the events of the loss of a metal token, a new token shall be supplied on payment of a like amount.

7. No dogs shall be registered, nor shall a metal token be issued in respect of any dog, unless all taxes payable to the Board in respect of that dog have been paid.

8. Any dog which is not registered or which is not wearing a collar and the prescribed metal token shall if found, in any public place, be detained at the Central Cattle Pound, at the Cantonment Office or at any other place set apart for the purpose.

9. A fee of four annas shall be charged for every day or part of a day in respect of every dog detained under the provisions of bye-law 8. Such fee shall be payable in addition to the feeding charges of the dog, the scale of which may from time to time be fixed by the Cantt. Board.

10. Any dog detained at any place mentioned in bye-laws 8 shall, after one week from the date of detention, be liable to be destroyed or otherwise disposed of under the orders of the Executive Officer, unless the same is claimed and detention fee and feeding charges paid in respect thereof within that period.

11. (1) Every dog confined under the provisions of sub-section (3) of section 119 of the Cantonments Act 1924, shall be kept under observation for ten days or such longer period as may be considered necessary by the Executive Officer, after consultation with the Health Officer, Assistant Health Officer or a Veterinary Officer.

(2) If at the end of this period the Health Officer, Assistant Health Officer or a Veterinary Officer certifies that the dog is not suffering from rabies, it shall be returned to the lawful owner or person incharge of it on payment of detention fee and feeding charges which shall be the same as those prescribed in bye-law 9. If, on the other hand, the Health Officer, Assistant Health Officer or Veterinary Officer certifies that the dog shows symptoms of rabies, it shall be destroyed forthwith.

12. Any person bitten by a dog or other animal which is, or is suspected to be, suffering from rabies may, with his consent and if certified by the Health Officer if necessary, be sent to a recognised Hospital for treatment.

Person bitten to give immediate information

13. Who ever has been bitten by a dog or other animal which is, or is suspected to be suffering from rabies shall give or cause to give immediate information of the incident to the Executive Officer.

Steps to be taken to trace the dog which has bitten any person

14. (1) On receipt of the above information the Executive Officer shall forthwith take steps in his power to trace the dog with a view to either having it confined, or destroyed and if it has been destroyed he will make arrangements, where necessary for extraction of brain and examination thereof at the District Laboratory.

15. *Penalty.*—Any person committing a contravention of any of these bye-laws shall, on conviction by a Magistrate, be punishable with fine which may extend to one hundred rupees and, in the case of continuing contravention with an additional fine which may extend to twenty rupees for every day during which such contravention continues after conviction for the first such contravention.

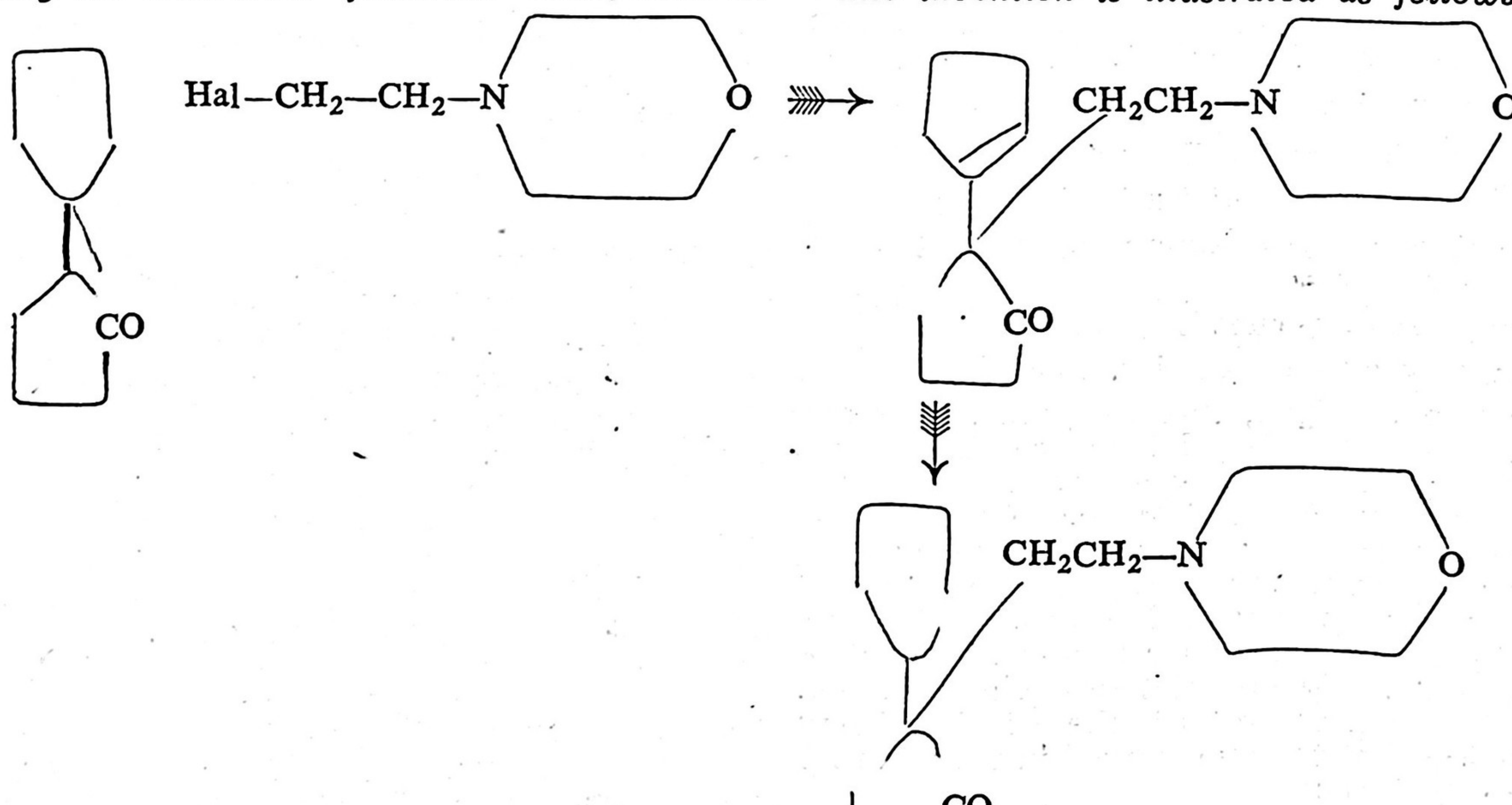

KARACHI MUNICIPAL CORPORATION

No. 783|26 Misc.|58.—The Corporation *vide* its Resolution No. 866, dated 8th February 1958 has finally adopted the following rules, called the Karachi Municipal (Medical Attendance) Rules for the benefit of its employees to be inserted as Chapter V-E Sch. I of the K. M. C. Rule Book. The Provincial Government has also accorded its approval to these rules *vide* its letter No. 1|7|58-LSG, dated 11th March 1958. Amendments made by the Government *vide* letter referred to above have been incorporated:—

1. (1) These rules may be called the Karachi Municipal Corpn. Services (Medical Attendance) Rules.

(2) They shall apply to all Karachi Municipal Corporation 'A' Schedule employees including their wives and children.

Note:—"Wife for the purpose of the above said rule would mean only one legally wedded wife and legitimate children and step children of a Municipal employee residing with and wholly dependent on him, children would mean legitimate sons and un-married daughters wholly dependent on the employee concerned".

2. In these rules, unless there is anything repugnant in the subject or context:—

(a) "Authorised medical attendant" means:—

(i) In case of a Municipal servant whose pay is

Doctors specially appointed by the Corporation to attend its said Officers or in the alternative, the Civil Surgeon, Karachi.

- (ii) In case of a Municipal Servant whose pay is less than Rs. 500 but more than Rs. 150 per mensem, any of the medical officers and Doctors of rank not inferior to that of a Municipal Medical Officer appointed by the Chief Officer to attend its officers in Karachi.
- (iii) In case of any other Municipal servant, Doctor or medical officer of rank not inferior to that of a sub-asstt. Surgeon, appointed by the Chief Officer.

(b) "Municipal Dispensary" includes Municipal and Government Hospitals or any other Hospital with which arrangements are made by the Corporation for the treatment of Municipal servants.

(c) "Medical attendance" means:—

- (i) In respect of Municipal servant specified in sub-clause (i) to clause (a), an attendance in hospital or dispensary or at the residence of the Municipal servant, including such pathological, bacteriological, radiological or other methods of examination for the purpose of diagnosis as are available in any hospital in Karachi, and are considered necessary by the authorised medical attendant, and such consultation with a specialist or other medical officer in the service of the state stationed in Karachi as the authorised medical attendant certifies to be necessary to such extent and such manner as the specialist or medical officer may in consultation with the authorised medical attendant, determine;
- (ii) In respect of any other Municipal servant, attendance at a hospital or dispensary or in case of illness which compels the patient to be confined to his residence, at the residence of the Municipal servant, including such methods of examination for purposes of diagnosis as are available in the nearest Government or Municipal hospital and such consultation with a specialist or other Medical Officer of the state stationed in Karachi as the authorised medical attendant certifies to be necessary to such extent and in such manner as the specialist or Medical Officer may in consultation with the authorised medical attendant, determine;

(d) "Patient" means a Municipal servant and his foresaid dependant to whom these Rules apply and as or have fallen ill.

(e) "Treatment" means the use of all medical and surgical facilities available at the Government or Municipal hospital in which a Municipal servant is treated, and includes:—

- (i) The employment of such pathological, bacteriological, radiological or other methods as are considered necessary by the authorised medical attendant;
- (ii) The supply of such medicines, vaccines, sera or other therapeutic substances as are ordinarily available in the hospital;
- (iii) The supply of such medicines, vaccines, sera or other therapeutic substances not ordinarily so available as the authorised medical attendant may certify in writing to be essential for the recovery or for the prevention of serious deterioration in the condition of the Municipal servant;

(iv) Such accommodation as is ordinarily provided in the hospital or clinic and is suitable status;

(v) Such nursing as is ordinarily provided inpatient by the hospital or clinic, and

(vi) the specialist consultation described in clause (c); but does not include diet, vision at the request of the Municipal Medical Officer of accommodation superior to that described in sub-clause (iv).

3. (1) A Municipal servant shall be entitled of charge to Medical attendance by the authorised medical attendant.

(2) Where a Municipal servant is entitled under sub-rule (1), free of charge to receive Medical attendance, any amount paid by him on account of treatment shall, on production of a certificate in writing by the authorised medical attendant on his behalf, be reimbursed to him from the Municipal funds.

4. (a) If the patient is too ill to travel, the authorised medical attendant shall be entitled to conveyance charges if not included in his fee for journey to and from the place where the patient is.

(b) If the patient is fit enough to be conveyed by the medical attendant the Municipal Authority shall be made available to him.

Applications for conveyance charges under rule (a) shall be accompanied by a certificate in writing by the authorised medical attendant certifying that the medical attendance was necessary, and the application is under clause (b) of that sub-rule that the patient was too ill to travel.

5. (1) If the authorised medical attendant is of opinion that the case of a patient is of such a special nature as to require medical attendance by some person other than himself, or that the patient requires anti-rabic treatment, he may, with the approval of the Chief Administrative Officer of the Corporation (which shall be obtained before unless the delay involved danger to the health of the patient).

(a) send the patient to the nearest specialist or other medical officer as provided in sub-clause (c) of rule 2, by whom, in his opinion, medical attendance is required for the patient or in the case of anti-rabic treatment the place nearest from Karachi where such treatment is available;

(b) if the patient is too ill to travel, send such specialist or other medical officer to attend upon the patient.

(2) A patient sent under clause (a) of sub-rule (1) shall on production of a certificate in writing by the authorised medical attendant in this behalf be entitled to conveyance charges for the journey to and from the headquarters of the specialist or other medical officer or the place where he is sent for anti-rabic treatment.

(3) A specialist or other medical officer sent under clause (b) of sub-rule (1) shall, on production of a certificate in writing by the authorised medical attendant in this behalf be entitled to travel allowance or conveyance charges for the journey to and from the place where the patient is.

6. (1) A municipal servant shall be entitled to treatment free of charge in such Municipal hospital at or near the place where

ill as can, in the opinion of the authorised medical attendant, provide the necessary and available treatment, or

- (b) if there is no such hospital as is referred to in sub-clause (a) in such hospital or clinic at or near that place as can in the opinion of the authorised medical attendance provide the necessary and suitable treatment, the Municipal Corporation in such cases paying the charges for the treatment and also for suitable private accommodation for officers drawing more than Rs. 250 as basic pay.
- (c) to anti-rabic treatment at the nearest Government hospital providing such treatment, the Municipal Corporation paying the charges for the treatment and also for available private accommodation for officers drawing more than Rs. 250 as basic pay.

(2) Where a Municipal servant is entitled under sub-rule (1) to treatment of Municipal expense or anti-rabic treatment in a hospital any amount paid by him on account of such treatment shall, on production of a certificate in writing by the authorised medical attendant in this behalf, be reimbursed to him from the Corporation funds.

7. (1) If the authorised medical attendant is of opinion that owing to the absence or remoteness of a suitable hospital or to the severity of the illness, a Municipal servant cannot be given treatment as provided in clause (a), sub-rule (1) of rule 6, the Municipal servant or his dependant may receive treatment at his residence.

(2) A Municipal servant or his dependant receiving treatment at his residence under sub-rule (1) shall be entitled to receive towards the cost of such treatment incurred by him a sum equivalent to the cost of such treatment as he would have been entitled, free of charge, to receive under these rules if he had not been treated at his residence.

(3) Claims for sums admissible under sub-rule (2) shall be accompanied by a certificate in writing by the authorised medical attendant, stating:—

- (a) his reasons for the opinion referred to in sub-rule (1);
- (b) the cost of similar treatment referred to in sub-rule (2).

8. (1) Charges for services rendered in connection with, but not included in, medical attendance on treatment of, a patient entitled free of charge, medical attendance or treatment under these rules shall be determined by the authorised medical attendance and paid by the patient.

(2) If any question arises as to whether a service is included in medical attendance or treatment, it shall be referred to the Provincial Government and the decision of the Provincial Government shall be final.

REMARKS

During the week ending the 1st February 1958, in 28 towns of Pakistan (excluding 12 towns of West Pakistan and 4 towns of East Pakistan) having a population of 30,000 and over, the number of deaths recorded was 755. The 1951 Census population of these towns was 2,661,342 and the death rate was 14.8 per thousand of population. Births in the same towns numbered 1,963, giving a birth rate of 38.3 per thousand of population.

In the above-mentioned towns, 34 deaths from small-pox and 4 deaths from cholera were recorded. The deaths from small-pox were recorded in Sirajganj 12, Dacca 8, Shikarpur 5, Chandpur and Khulna 3 each, Mymensingh, Barisal and Pabna 1 each. The deaths from cholera were recorded in Barisal 2, Khulna 1.

Plague remained absent during the week under report.
