## PRESIDENT'S SECRETARIAT

No. F. 40(4) Pres/58.—The following Warrant is published for general information:—

## Warrant of Institution of the President's Medal for Best Shot

WHEREAS under the Constitution of the Islamic Republic of Pakistan the President is empowered to award decorations;

AND WHEREAS it is fitting to institute a new medal for the best shot among the members of the Armed Forces and Civil Armed Forces of Pakistan;

Now, THEREFORE, in exercise of the powers conferred on him by the Constitution, and of all other powers enabling him in that behalf, the President is pleased to institute, create and govern the decoration designated hereinafter:—

1. **The Medal.**—The Medal shall be called the President's Medal for Best Shot.

2. **Award of medal.**—The medal shall be awarded annually to the person securing the highest aggregate score in the army championship match during the central meetings of the Pakistan Rifles Association and the name of every person to whom the medal is awarded shall be kept in a register.

3. **Description.**—The medal shall be round in shape, of silver, and shall bear on the obverse crossed rifles surrounded by wheat-ear wreath supporting crescent and star in vertical position, i.e., with horns upwards.

In the lower section of the crossing of the rifles, in a concave shape, shall be a scroll inscribed "A. R. A.". On the top of the medal shall be inscribed the words "President's Medal" in semi-circle; on the bottom shall be inscribed the words "For Best Shot", also in semi-circle. On the reverse shall be inscribed a crescent and star surrounded on both sides with a wreath with the word "Pakistan" written below in Arabic script.

4. **Order of wear.**—The medal shall be worn on the left breast suspended by a ribbon of scarlet plain silk, one and a quarter inches wide, with four narrow stripes in Pakistan Green of equal width, two at each end one eighth inch apart. It shall be worn immediately after the Republic Commemoration Medal but before all foreign decorations and medals.

5. **Cancellation and restoration.**—The President may cancel and annul the award of the medal to any person, and thereupon the name of such persons shall be erased from the register. But it shall be competent for the President to restore any medal which may have been so forfeited. The notice of cancellation or restoration in every case shall be published in the Service Order concerned.

make the following amendment in the Pakistan Post Office Rules, 1955, namely :—

In Part VIII of the aforesaid Rules, for cross-heading V and rule 202 the following shall be substituted :—

" V.—RE-DELIVERY TO SENDER OR DELIVERY TO ANOTHER ADDRESSEE AT THE REQUEST OF THE SENDER OR POSTAL ARTICLES IN COURSE OF TRANSMISSION BY POST.

202. Postal articles, whilst in the course of transmission by post, may be recalled by the sender or delivered to another addressee at the request of the sender, without reference to or the consent of the first addressee, subject to the following conditions, namely :—

(a) No such postal article as aforesaid shall be re-delivered to the sender or delivered to another addressee at the request of the sender except under the orders of—

- (i) the First Class Postmaster or the Superintendent of Post Offices, within whose jurisdiction the article is posted ; or
- (ii) the Head of a Postal Circle ; or
- (iii) the Director-General.

(b) An application for the re-delivery or delivery to another addressee of a postal article shall be made in writing to any of the authorities aforesaid, either direct or through any officer in charge of a post office.

(c) An application shall be received only from the sender of the postal article, or from some person authorised in this behalf by the sender in writing.

(d) A fee of one rupee shall be paid in respect of each postal article for which an application is made under (b) above and the fee shall in no case be refundable :

Provided that no fee shall be charged in the case of official articles.

(e) Upon receiving such application and the fee as aforesaid, the officer in charge of the post office shall, unless he is a First Class Postmaster, send the same to the First Class Postmaster or the Superintendent of Post Offices to whom he is subordinate, and shall in the meanwhile detain the postal article, in case it is in his custody, or, where he is a First Class Postmaster, proceed to act under (g) below.

(f) If the postal article is not in the custody of the said officer, he shall require the officer in charge of the post office of address in the case of an inland postal article, or of the post office of exchange in the case of a foreign postal article, to abstain from delivering it to the addressee or from sending it to its address, and to detain the article in his custody, and such requisition may be sent by air or telegraph, at the expense of the applicant.

(g) When the application reaches an authority named in (a) above, that authority may, upon being satisfied that the applicant is the sender, order the re-delivery to the sender or delivery to another addressee of the postal article.

(h) In the case of foreign postal articles which have already left the country, the post office of exchange concerned shall arrange to have the form FMS 19(a) filled in by the sender and to transmit the same to the office of destination and the form FMS 19(a) may be forwarded by air, or the request contained therein transmitted to the office of destination by telegraph, on payment of the necessary charges by the sender.

Except as otherwise provided by or under the Cantonments Act, 1924, or by any other law in force, or as hereunder, no copy of, or extract from any register, book, accounts, records or documents belonging to or in the possession of the Cantonment Board, shall be given nor shall inspection of any such register, book, accounts, record or document be granted to any person without the previous sanction in writing of the Executive Officer.

2. Except as aforesaid, every person wishing to inspect such record or document or to obtain any copy thereof or extract therefrom shall apply in writing, to the Executive Officer, on the form prescribed in the attached schedule and obtainable on payment of annas two from the Board's office. Permission to inspect such record or document and grant of copies thereof or extract therefrom may be refused without assigning any reason.

3. No permission shall be given for the inspection of any correspondence between the Board and the Central or Provincial Government or any Officer of the said Government, or of any other document, the inspection of which is, in the opinion of the President or the Executive Officer, detrimental to the interests of the Board or of the Government or to which the party applying is not entitled to, nor shall copies of extracts from any such correspondence or documents be supplied.

4. No copy shall be granted of a record, map or plan which has been printed or lithographed and published under the authority of the Government and is for sale to the general public.

5. No extract from a document shall be given which when read apart from the whole is capable of misrepresenting the purport, sense or any final order passed by the Board or any Officer.

6. The following fees shall be charged in advance:—

- (i) For inspection of any document or record other than Minute Book or Assessment List—One rupee per hour or part thereof. For certified true copy of one entry from the Assessment List—One rupee per entry.
- (ii) For search of an Index file register for the purpose of finding or tracing any document—One rupee for each year's Index File register which has to be searched.
- (iii) (a) For copying or making extracts from any other document or office record—One rupee per hundred words or part thereof.  
(b) If the original is in the tabular form, double the rate charged for (a).
- (iv) For a certified copy of a map or plan or any immovable property bearing a separate survey number—Such fee not exceeding fifteen rupees and not less than two rupees as the Executive Officer determine.
- (v) For supplying a certified copy of birth or death entry—Rupee One.
- (vi) For the supply of an extract from a Property or Building Register of sites and transfers—Two rupees and eight annas.
- (vii) For the supply of a duplicate copy of a licence—Eight annas.

(viii) For attesting a copy of document—Eight annas.

(ix) For the supply of any other document not covered by the above—One rupee per page or part, of a page of the register, as the case may be.

Provided that the District Soldier's Board shall not be charged fees for obtaining extracts from Cantonment Births and Deaths Registers maintained by the Cantonment Board, when such extracts are required for official purposes.

7. When an application is made for urgent copies, these, if supplied within three days from the date of receipt of the application, shall be charged for at double the rate prescribed under bye-law 6 and if supplied within six hours or earlier from the time of the application, at triple the rate prescribed in bye-law 6.

7. The fees prescribed in bye-law 6 shall be credited into the Cantonment Fund, but Executive Officer may make to the official or officials preparing copies a reward of an amount not exceeding one half of the total proceeds.

**No. 473|58.**—The following Bye-laws for regulating the erection, re-erection or alteration of the buildings in the Fort Sandeman Cantonment, framed by the Cantonment Board, Fort Sandeman, in exercise of the powers conferred by section 186 of the Cantonments Acts, 1924 (II of 1924) are published for general information, the same having been previously published, approved and confirmed by the Central Government as required by Section 284(I) of the said Act, namely:—

1. (i) Every person intending to erect, re-erect or make additions or alterations to a building shall give notice in writing to the Executive Officer under

section 179 of the Cantonments Act, 1924, in form 'A' appended to these bye-laws and shall at the same time submit in triplicate except as provided in bye-law 8 (one copy being on ferro cloth or linen and the other two copies in blue print) duly signed by himself or by his agent, the following plans:—

- (a) a site plan of the land on which it is intended to erect or re-erect the building,
- (b) a plan showing elevations and cross sections of the building which is proposed to erect, re-erect together with a plan of the existing building(s), if any, showing platforms, balconies and other projections existing thereon, and
- (c) the specifications in duplicate detailed in form 'B' appended to these bye-laws.

(ii) All new works shall be indicated on the site and building plans by a distinct colour and key to the colours used shall be given thereon:—

Proposed work .. Red  
Existing work .. Black.  
Demolition .. Yellow.

2. (i) All plans submitted for sanction under these bye-laws must be signed by a qualified architect, except (in case of one storied buildings costing less than Rs. 1,000).

(ii) In this bye-law "a qualified Architect" means:—

- (a) a Bachelor of Civil Engineering of any British or Pakistani University, or
- (b) a member of the Institution of Civil Engineers, or
- (c) a member of the Royal Institute of British Architects, or
- (d) a fellow of the Royal Institute of British Architects, or
- (e) a person accepted as such by the Municipal Committee|Fort Sandeman Cantonment Board under their rules for the time being in force.

3. The site plan shall be drawn to a scale of not less than 100 feet to an inch. The scale used shall be marked on the plan which shall clearly show:—

- (a) the direction of the north point,
- (b) the boundaries of the site on which it is proposed to erect or alter the building(s),
- (c) the position of all adjacent streets, vacant lands and drains,
- (d) the names, if any, and width of all streets on which the site abuts, together with the numbers, if any, of adjoining houses or premises,
- (e) the line of frontage of adjoining buildings,
- (f) the alignment of drains showing the manner in which the roof and house drainage and surface drainage will be disposed of, and
- (g) a sketch of the buildings and premises showing all electric wiring and poles and water pipes within twenty feet of the boundaries of the site.

4. The building plan shall be drawn to a scale of not less than 20 feet to an inch. It shall include a ground plan and sectional elevation and shall show, *uter alia*, the following:—

- (a) The external dimensions of the main building.
- (b) The ground floor, the first floor, the second floor and the roof.

(c) The thickness and composition of all beams, rafters and all other supports.

(d) The position and dimensions of all projections beyond the main walls of the building.

(e) The position of all proposed and existing drains, urinals, privies, fireplaces, kitchens, gutters and downspouts.

(f) The dimensions of all rooms and position of doors, windows and ventilators in each room of every story.

(g) The materials to be used in the foundations, walls, floors and roofs.

(h) The purpose for which it is intended to use the building.

(i) The level and width of the foundations and the level of the ground floor with reference to the level of the centre of the street on which the front of the proposed building is to abut.

(j) The plan to be submitted shall also show the details and calculations of load for the foundations, plinth wall up to the roof and parapet of the upper storey, together with the size of R. C. C. and size and number of iron bars to be used in pillars, beams and slabs, etc.

5. No part of any building shall project beyond the general alignment fixed for the street.

6. Every person who erects or re-erects a building the whole or any part of which is intended or used for human habitation shall if so required, construct one or more privies in connection with or as part of such building.

7. No latrines or refuse water pits shall be constructed within 10 feet of a Kitchen nor shall any latrine be permitted if the total area of the site is less than 200 sq. feet.

8. No loft constructed in a house shall be used for human habitation unless it complies with the minimum height prescribed in these bye-laws.

9. Every room in a building intended to be used for human habitation shall be provided with:—

- (a) No room to have floor area less than 100 sq. feet.
- (b) At least one door, one window and one ventilator.
- (c) Height of rooms to be eight feet at eaves in case of pent roofs and ten feet in case of flat roofs.

10. The height of the proposed building shall not be less than:—

(a) In the case of flat roof:—

- (i) 12 feet from the ground floor,
- (ii) subsequent storey 10 feet.

(b) In case of a pent roof 13 feet from the ground line to the eaves.

11. No house steps shall be constructed so as to project on to a street or beyond a public drain running in front or at the back of the buildings.

12. All doors, windows and ventilators provided for rooms in the proposed building shall not be less than the following minimum sizes:—

(i) Door 3'X6'.

(ii) Windows 2'X3'.

(iii) Ventilators 1'X1'.

13. Sun shades over doors, windows and ventilators on the ground floor of a building projecting over a street shall not be allowed.

14. In no case shall the height of a building be more than one and a half the width of the street on which it is to abut:

15. No latrine shall be allowed to open on any public street or lane unless screened by a 5 feet high purdah wall.

16. No room intended as a godown for the storage of food grains in excess of fifty maunds shall be constructed unless the floor and walls up to a height of two feet are made of stone, concrete or other impervious material and are also ratproof.

17. House drains through which waste or sullage water is intended to pass, shall be constructed of masonry or other impervious material and shall be connected to the nearest public drain wherever such drain exists within 50 feet of the proposed building. In the absence of such a public drain the house drain shall be discharged into a soakage or cess pit, which shall be constructed and maintained by the owner of the building.

18. Every building of more than one story shall have a width of stairs of not less than three feet to ensure safety in case of fire and no such stairs shall be constructed of inflammable materials.

19. Gates, doors, windows or shelters on the ground floor of the building abutting on a street shall be made to open outwards on the said street.

20. The plinth of all buildings shall be at least one foot above the level of the ground and every wall of such building shall have a damp proof course of not less than one inch in thickness above the plinth level, which shall consist of cement concrete or plaster.

21. Where the plans are unintelligible, ambiguous or are in contravention of these bye-laws, the Executive Officer may return such plans to the applicant giving his reasons in writing and until a rectified plan is submitted the applicant shall be deemed to have given no notice under section 179 of the Cantonments Act, 1924.

NOTE.—The forms 'A' and 'B' prescribed in these bye-laws shall be obtained from the office of the Cantonment Board on payment of such price as may be fixed by the Board from time to time.

AGRICULTURAL DEVELOPMENT FINANCE CORPORATION  
NOTIFICATION

No. 20(2)II.—In exercise of the powers conferred by Section 43 of the Agricultural Development Finance Corporation Act, 1952 (XVII of 1952), the Board of Directors of the Agricultural Development Finance Corporation, with the previous sanction of the Central Government, hereby make the following amendments to the Agricultural Development Finance Corporation's Employees Provident Fund Regulations, 1953, namely—

(1) Delete "12" before the proviso to Clause 11 and insert "12" before the Clause reading "The Fund's moneys will be invested in Approved Securities".

(2) Regulation 15 may be substituted by the Regulations No. 15 and 15A as shown below :—

"15. Advances from the Fund :

(1) A temporary advance may be granted to a subscriber from the amount standing to his credit in the Fund at the discretion of the Administrators, subject to the following conditions :—

(a) The subscriber shall satisfy the Administrator of the necessity for the advance ;

The grant of advance shall be regulated by the principles embodied in Appendix A.

(b) The Administrators shall record in writing their reasons for granting the advance.

(c) The advance shall not, save in exceptional cases, for reasons to be recorded in writing by the Administrators, exceed three months' emoluments and shall, in no case, exceed the amount of subscription and interest thereon standing to the credit of the subscriber in the Fund at the time when the advance is granted.

(d) The advance shall not, except for special reasons to be recorded in writing by the Administrators, be granted until at least 12 months after the final repayment of all previous advances together with interest thereon.

(2) (a) The advance shall be recovered from the subscriber in such number of equal monthly instalments as the Administrators may direct, but such number shall not be less than twelve unless the subscriber so elects, or in any case more than twentyfour. A subscriber may at

his option, make repayment in a smaller number of instalments than that prescribed. Each instalment shall be a number of whole rupees, the amount of the advance being raised or reduced, if necessary, to admit of the fixation of such instalments.

- (b) Recovery shall be made from the monthly emoluments and shall commence on the first occasion after the advance is made on which the subscriber draws emoluments, other than leave salary or subsistence grant, for a full month. Recovery shall not be made, except with the subscriber's consent, while he is on leave or in receipt of subsistence grant, and may be postponed by the Administrators during the recovery of an advance of pay granted to the subscriber.
- (c) If more than one advance has been made to a subscriber, each advance shall be treated separately for the purpose of recovery.
- (3) (a) After the principal of advance has been fully repaid, interest shall be paid thereon at the rate of one fifth per cent. of the principal for each month or broken portion of a month during the period between the drawal and complete repayment of the principal:

Provided that subscribers whose deposits in the Fund carry no interest shall not be required to pay into the Fund any additional instalments on account of interest on advances granted to them from the Fund.

- (b) Interest shall ordinarily be recovered in one instalment in the month after complete repayment of the principal; but if the period of repayment exceeds twenty months, interest may if the subscriber so desires, be recovered in two equal monthly instalments. The method of recovery shall be that provided in sub-clause (2) (b). Interest shall be rounded to the nearest rupee.
- (4) If an advance has been granted to a subscriber and drawn by him and the advance is subsequently disallowed before repayment is completed, the whole or balance of the amount withdrawn, shall, with interest at the rate provided in Regulation 13, forthwith be repaid by the subscriber to the Fund or in default be ordered by the Administrators to be recovered by deduction from the emoluments of the subscriber by instalments or otherwise. Provided that subscribers whose deposits in the Fund carry no interest shall not be required to pay any interest.
- (5) Recoveries made under this Regulation shall be credited, as they are made, to the account of the subscriber in the Fund. NOTWITHSTANDING ANYTHING contained in these Regulations, the Administrators shall have the discretion on a unanimous vote to relax on grounds of real hardship the provisions of the above regulation by taking into account the total amount standing at the credit of the

employee inclusive of the employee's own subscription and the contribution of the Corporation when sanctioning the advance in the case of those who have rendered service in the Corporation for a period of over five years.

#### 15-A. Payments towards Insurance Policies :

A subscriber shall be permitted to borrow from the Fund sums to meet payments towards a Policy or insurance on the life of the subscriber effected under a scheme of insurance approved by the Corporation, which may be withheld from subscriptions to the Fund or withdrawn from the amount subscribed thereto by the subscribers (including interest thereon). Any sum so withheld from a subscription shall be deemed to be part of the subscription for the purpose of calculating the Corporation's contribution under Regulation 11.

The Insurance policies in question shall be assigned to the Corporation.

*Note* :—Advances under Regulations 15 and 15A may be sanctioned by the Managing Director to the subscribers in urgent and deserving cases subject to subsequent formal approval of the Executive Committee acting as Administrators.

#### APPENDIX A

The following are deemed to be good and sufficient reasons for the grant of advances, provided the Administrators are satisfied that the applicant's pecuniary circumstances justify an advance and that the amount advanced will be expended on the object for which it is given :—

- (a) to pay expenses incurred in connection with the prolonged illness of a subscriber or any person actually dependent on him;
- (b) to pay for the overseas passage for reasons of health or education of a subscriber or any person actually dependent on him;
- (c) to pay obligatory expenses on a scale appropriate to the subscriber's status in connection with marriages, funerals or ceremonies, which by his religion, it is incumbent on him to perform.

The Administrators should reject an application for an advance to repay a debt incurred on account of illness or any other recognised purpose, made unreasonably long after the event to which it relates.

Advances are not rigidly confined to the objects mentioned in clauses (a) to (c) above, but may be sanctioned only for reasons no less cogent. An advance may not be granted for the purchase of a house or land, or for the erection of, or repairs to, a building, or to meet the expenses of law suits, or to repay ordinary debts, or to furnish security deposits, or to purchase motor cars or other means of conveyance.

#### REMARKS

During the week ending the 29th March 1958, in 25 towns of Pakistan (excluding 4 towns of West Pakistan, a 15 towns of East Pakistan and the Karachi Federal Area) having a population of 30,000 and over the number of deaths recorded was 543. The 1951 census population of these towns was 25,74,785 and the death rate was 11.0 per thousand of population. Births in the same towns numbered 1,923, giving a birth rate of 38.8 per thousand of the population.

In the above-mentioned towns 9 deaths from small-pox were recorded in West Pakistan. The deaths from small-pox were recorded in Shikarpur 6, Sukkur, Nawabshah and Mirpurkhas 1 each.

Cholera and Plague remained absent during the week under report.
