No. PLI. 24-10|58.—The President is pleased to direct that the following further amendments shall

with immediate effect be made in the Post Office Insurance Fund Rules (hereinafter referred to as "the said rules"), namely:—

(1) For Rule 16 of the said Rules, the following shall be substituted, namely:—

"16. When a person wishes to insure his life under these Rules, or to purchase an endowment assurance policy, he will be required to answer in his own handwriting, if possible, the questions in the prescribed form of proposal, which can be obtained at the nearest post office (head or sub.), and to sign the form, or affix his left thumb impression thereon, if he is illiterate or is unable to sign his name, in the presence of the officer to whom the proposer is immediately subordinate or an officer of the Post Office not below the rank of postal clerk who knows the proposer or any other responsible Government officer who knows the proposer. The immediate superior or other officer in whose presence the proposer signs the proposal form or affixes his left thumb impression thereto will, in turn, sign in the space provided in the proposal form a certificate to the effect that he knows the proposer and that the proposer has signed the proposal or affixed his left thumb impression in his presence. The proposer will attach to the proposal form an attested copy of a document proving his age, e.g., baptismal certificate, extract from a birth register maintained by a local body, matriculation or School Leaving Certificate or history of services, service book or graduation list. The attestation should be by the immediate superior of the proposer or by a gazetted officer. When the proposer is illiterate or is unable to sign his name the officer whose presence the proposer's left thumb impression is affixed on the proposal form should attach to the proposal a memorandum authenticated by his signature and designation giving a personal description of the proposer so as to enable the medical officer to identify him."

2. Note 2 below Rule 16 shall be omitted and the existing Note 3 shall be re-numbered as Note 2.

tile Commissioner hereby direct that no person shall transport any imported cloth or indigenous mill-made cloth of more than 40s average count from any place in East Pakistan to any place outside that province except under a general or special permission issued by me or an officer authorised by me in this behalf, provided that:—

(i) Persons travelling by rail, sea or Air may carry with them, as their personal luggage, the aforesaid types of cloth not exceeding 5 lbs. in weight.

(ii) the aforesaid types of cloth may be transmitted by post parcels not exceeding 5 lbs. in weight, provided the cloth is meant for personal use of the consignee.

2. The above restrictions shall not apply either to handloom cloth, or indigenous mill-made cloth of an average count not exceeding 40s.

No. 42(6)54-B.—The following Recruitment Rules for the post of Director of News, Central News Organisation, Radio Pakistan are published for general information:—

PART I.—METHOD OF RECRUITMENT

1. These Rules may be called Recruitment Rules for the Class I post of Director of News, Central News Organisation, Radio Pakistan.

2. For the purposes of these Rules:—

- (a) 'Government' means the President.
- (b) 'Commission' means the Federal Public Service Commission.
- (c) 'Department' means Radio Pakistan.
- (d) 'Post' means the post of Director of News, Central News Organisation, Radio Pakistan, Karachi.
- (e) 'Direct appointment' means appointment made otherwise than by promotion.

3. Recruitment to the post shall be made by selection by one of the following methods:—

- (i) by promotion in accordance with Part II of these Rules; or
- (ii) if no suitable officer is available for promotion, by direct appointment in accordance with Part III of these Rules.

4. Vacancies in the post which are filled otherwise than by promotion shall be distributed between the Provinces of Pakistan in accordance with the Establishment Division Office Memorandum No. 25/10/50-SEI, dated the 6th October 1950 and Office Memorandum No. 25/68/50-SEI, dated the 22nd January 1952, and the supplementary instructions issued from time to time.

PART II.—RECRUITMENT BY PROMOTION

5. Recruitment by promotion shall be made from among the officers holding posts in the cadre of News Editors in the Department after consultation with the Commission, and the officer selected will be appointed by Government. No officer shall have any claim to such appointment as of right.

6. Persons recruited under this part of rules will be placed on probation in accordance with rule 13.

PART III.—RECRUITMENT BY DIRECT APPOINTMENT

7. Recruitment by direct appointment shall be made on the recommendations of the Commission.

8. A candidate for direct appointment to the post must:—

- (a) be a citizen of Pakistan: Provided that the President may authorise the temporary employment of a person who is not a citizen of Pakistan;
- (b) be not less than 35 years of age and not more than 45 years of age at the time of submission of his/her application, relaxable in suitable cases and in the case of permanent Government servants and those who have been in continuous temporary service for at least 5 years in the Central News Organisation of Radio Pakistan;
- (c) possess good educational qualifications with ability to write English and Urdu/Bengali well, and journalistic experience in a news agency, newspaper or experience of public relations work for 10 years, with intimate knowledge of current affairs;
- (d) satisfy the Commission that his/her character and antecedents are such as to make him/her suitable for appointment to the post. Candidates will have no right of appointment unless Government are satisfied, after such enquiry as may be necessary, that the candidate is suitable in all respects for appointment to the Public Service;
- (e) have such other special qualifications as Government may, in consultation with the Commission, prescribe for the post.

9. The Government may, in consultation with the Commission, modify or waive any or all of the requirements of sub-rules 8(b), (c) and (e) when it is not practicable to obtain a suitable candidate who fulfils all the requirements of these sub-rules.

10. (a) Applications for direct appointment shall be submitted to the Commission on such form, on such date and in such manner as the Commission may prescribe. Candidates who join Government service

After submitting their applications should also submit the Departmental permission to the Commission immediately thereafter.

(b) Persons already in service shall, in the matter of applications, be governed by the provisions of the Government Servants' Application for Posts (Central Services) Rules, 1953.

(c) The decision of the Commission as to the eligibility or otherwise of a candidate shall be final.

11. The maximum age limit will be relaxed as follows:—

(a) by three years in the case of Scheduled Castes and candidates belonging to the Tribal Areas of the former North-West Frontier Province and Baluchistan, the Frontier States and Kalat Division and the excluded areas in the Dera Ghazi Khan District of West Pakistan;

(b) by two years in the case of candidates belonging to the excluded areas of East Pakistan;

(c) by three years in the case of the candidates who are permanent residents of Azad Kashmir Territory, the Gilgit Agency or Baltistan or candidates living in these areas or in any other part of Pakistan who belong to the State of Jammu and Kashmir.

NOTE 1.—The term "Scheduled Caste" means a Scheduled Caste determined in accordance with the provisions of Article 204 of the late Constitution. Such candidates will be required to submit a certificate from the District Magistrate in support of their claim.

NOTE 2.—Only those candidates who are permanent residents of the areas mentioned at (a) and (b) above and whose families have been living in those areas will be eligible for the concession and in each case a certificate from the Political Agent or the Deputy Commissioner will be required to be produced. Members of Tribes belonging to the Tribal Areas who have settled in the settled districts will not be eligible for this concession.

NOTE 3.—The concession mentioned at (c) above will be admissible to candidates who produce a certificate from the Ministry of Kashmir Affairs, Government of Pakistan.

12. A candidate for appointment to the post must be in good mental and bodily health and free from any physical defect likely to interfere with the discharge of his/her duties as an officer of the service. A candidate, who after such medical examination as the Government may prescribe, is not found to satisfy these requirements, shall not be appointed.

13. (a) Appointment shall be made on probation for a period of one year.

(b) If, in the opinion of Government, the work or conduct of an officer on probation is unsatisfactory, or shows that he/she is unlikely to become efficient, Government may discharge/revert him/her, or extend his/her probation for such further period, not exceeding one year, as Government may think fit.

(c) On the conclusion of the period of probation, Government may confirm a probationer in his appointment, provided a clear vacancy exists.

(d) If no action is taken by Government under sub-rule (b) or (c) of this rule, the period after the prescribed period of probation shall be treated as temporary engagement until further orders.

No. 42(17)1954-B.—The following Recruitment Rules for the post of Assistant News Editor and posts in that cadre, viz., Chief News Listener and Assistant Director of Monitoring in Radio Pakistan are published for general information:—

PART I.—METHODS OF RECRUITMENT

1. These Rules may be called the Recruitment Rules for Class II (gazetted) post of Assistant News Editor and posts in that cadre in Radio Pakistan.

2. For the purposes of these Rules:—

- (a) "Government" means the President.
- (b) "Commission" means the Federal Public Service Commission.

(c) "Post" means the post of Assistant News Editor and posts that have been declared to be in that cadre. The present posts in that cadre are Assistant News Editor, Chief News Listener and Assistant Director of Monitoring in Radio Pakistan.

(d) "Department" means Radio Pakistan.

(e) "Direct appointment" means appointment made otherwise than by promotion or transfer from another Service/Department.

3. The post shall be treated as a "Selection appointment" and shall be filled by the following methods:—

4. Subject to the provisions of rule 3, Government shall determine the method or methods to be employed for the purposes of filling any vacancy or vacancies and the number of candidates to be recruited by such method.



"ALL PAKISTAN" FIRST ESTIMATE OF RAPE AND MUSTARD CROP FOR THE YEAR 1958-59

No. F. 1-13|58-59|AF&S.—The first estimate of the area under Rape and Mustard crop for the year 1958-59 is 1,764,000 acres as against 1,766,000 acres reported in the corresponding estimate of the previous year and shows a nominal decrease of 0.1 per cent. The revised acreage reported in the final estimate of the last year was 1,808,000 acres.

With the exception of former Punjab and East Pakistan there has been a general decrease in the acreage under this crop which is attributed partly to

unfavourable weather conditions, lack of timely rains and partly to increase in area under Wheat crop as a result of "Grow More Food Campaign" launched by the Government. The increase in area under the crop in East Pakistan and former Punjab is due to high price of Mustard oil, timely supply of seeds by Agriculture Department and propaganda of Departmental Staff to Grow More Mustard.

REMARKS

During the week ending the 20th December, 1958, in 39 towns of Pakistan (excluding 7 towns of West Pakistan and town of East Pakistan) having a population of 30,000 and over, the total number of deaths recorded was 1,315. The 1951-Census population of these towns was 4,210,908 and the death rate was 16.2 per thousand of the population. Births in the same towns numbered 3,511, giving a birth rate of 43.3 per thousand of the population.

In the above-mentioned towns of Pakistan 13 deaths from Small-pox were recorded in Sargodha 6, Multan 1, Bahawalpur 2 and in Lahore, Sialkot, Lyallpur 1 each in West Pakistan. In East Pakistan 13 deaths from Cholera were recorded in Dacca 3, Barisal 5, Khulna 2 and in Chandpur, Narayanganj, Rajshahi 1 each.

Plague remained absent during the week under report.
