(b) The licensee shall exhibit his stock book and records to any officer authorized under section 13 of the Petroleum Act, 1934, whenever such an Officer calls upon him to do so.

In East Pakistan, the area under winter and summer sesamum crop recorded a decrease and increase of 5 and 13.0 percent respectively, over the previous year's crops. The decrease in winter sesamum crop occurred due to the closure of Kaptai dam in Chittagong Hill Tracts which is the major Til Growing district of East Pakistan. The area under summer sesamum crop increased on account of favourable weather conditions. The provincial increase stood at 5 percent.

In West Pakistan there was a general increase in area under sesamum crop with the exception of D.I. Khan and Sargodha Divisions, on account of beneficial rains during the pre-sowing period and high prices of the commodity in the market in the previous season as a

result of the Government decision to order the use of at least 5 percent of sesamum oil in vegetable ghee production. The decrease in D.I. Khan and Sargodha Divisions may be attributed to failure of rains. The overall provincial increase is 37.5 percent.

Production.—The production of sesamum crop for 1961-62 is estimated at 36,715 tons as against 31,290 tons reported in the corresponding estimate of previous year and shows an increase of 17.3 percent.
