"ALL PAKISTAN" FIRST ESTIMATE OF MAIZE CROP FOR THE YEAR 1962-63, RELEASED BY THE DEPARTMENT OF MARKETING INTELLIGENCE AND AGRICULTURAL STATISTICS.

No. AE|St-E(9)R|63.—According to First Estimate, the area under Maize crop for 1962-63 is 1,140,000 acres as compared to 1,144,000 acres reported in the corresponding estimate of the preceding year and shows a small decrease of 0.4 per cent.

A nominal increase of 0.4 per cent. in area under the crop has occurred in West Pakistan notwithstanding decrease in Lahore, Sargodha, Multan and Bahawalpur Divisions. The decrease in these divisions may be attributed to diversion of area to competing cash crops. Peshawar and Rawalpindi divisions, however, have recorded an improvement in area as a result of sufficient supply of rain and canal water, though coming late in some areas.

There has been a general decline in area in East Pakistan (—38.1 per cent) owing to unfavourable weather conditions at the time of sowing and later on heavy floods also adversely affected growth of the crop.
