No. Cy. 3882/63-SB.—In pursuance of Sub-Regulations (1) and (4) of Regulation 3 and Sub-Regulation (3) of Regulation 4 of the State Bank of Pakistan (Special Instruments) Regulations 1950, it is hereby notified that in order to help the illiterate pilgrims going to Saudi Arabia the State Bank of Pakistan has arranged that in addition to the facility of travellers cheques and Bank Drafts to be issued by authorized dealers State Bank's Pilgrim Notes will also be issued this year as in the past to such Pilgrims who desire to take foreign exchange in this form. The pilgrim notes are in the denominations of Rs. 10 and Rs. 100 and have the following special features:—

2. Design.

(i) Rs. 10. The design and numbering of the Rs. 10 pilgrim note is similar to the present Rs. 10 note of the State Bank of Pakistan with the difference that the pilgrim note is printed in light green colour. The design on the front is the Shalimar Gardens

process on water marked paper, the subject of the water-mark being the star and crescent in a waxing position with one security thread. The following inscription is over-printed in black on the front.

"For Haj Pilgrim from Pakistan" at the top.

"For use in Saudi Arabia only" at the bottom.

(ii) Rs. 100. The design and numbering of the note is similar to the design of Rs. 100 note of the Government of Pakistan issued by the State Bank of Pakistan with the difference that the pilgrim note is printed in red colour and the signature of the then Finance Minister is in Urdu. The note is printed by the Intaglio process on buff paper with two security line threads running vertically down the type numbering. The following inscription is over-printed on the front.

"For pilgrim from Pakistan" at the top.

"For use in Saudi Arabia and Iraq" at the bottom. The words "and Iraq" in the inscription have been cancelled by rubber stamp.

It has been decided by the Government to permit children of all ages to accompany their parents on Haj. Separate application for a child of any age will have to be filled up. Children between the ages of 3 to 16 years will be entitled to half the quota of foreign exchange fixed for adults. Minimum exchange quota for children entitled to exchange as mentioned above would be Rs. 350 per child

5. Arrangements at Jeddah for Exchange of Pilgrim Notes.

The pilgrim notes can be exchanged for rials at the prevailing rates at the Offices/Correspondents of the Banks mentioned at para. 3 above, functioning at Jeddah.

The pilgrim notes can be repatriated through any bank from any country against payment in sterling at the State Bank's ready selling rate for sterling. The agencies in Saudi Arabia or in any other country can directly send their holdings of pilgrim notes to any Authorised Dealer in Pakistan and collect sterling at the State Bank's ready selling rate. On receipt of a mail or cable advice Authorised Dealers may sell sterling forward to their correspondents abroad at the State Bank's forward selling rate for the value of Pilgrim Notes actually purchased by them and indicated in the advice. These forward contracts should be valid for delivery up to 3 months or 26th August 1964 whichever is earlier.

6. Procedure for issue of pilgrim notes.

All banks authorised to deal in foreign exchange can accept from intending pilgrims deposits covering passage fare for the class applied for, amount required for purchase of foreign exchange quota, cost of rations if required for consumption in Saudi Arabia, pilgrim pass fees, etc. For such deposits the banks will issue three receipts in duplicate separately for each application as laid down in F. E. Circular No. 69, dated 17th December 1963. Foreign Exchange would be issued to the successful applicants at port towns only by the banks who issue the deposit receipts and banks that do not have a branch at port towns or do not establish Booths in the Haji Camps shall indicate at

the time of their issue the name of some other bank with whom arrangements are made for release of foreign exchange against their deposit receipts. While the deposits can be received by all the offices of the Authorised Dealers, foreign exchange shall be issued only by offices in Port towns of Authorised Dealers who have issued deposit receipts. The authorised Dealers would not make any change for the acceptance of deposits and their remittance to the Port Towns.

Exchange would be issued to successful Haj applicants on surrender of deposit receipts either in the manner prescribed in Chapter XVIII of the Exchange Control Manual or in the form of Haj Notes. The successful Haj applicants would be issued exchange only to the extent of the amount they deposited in advance for the issue of exchange. In other words, a person who has been successful in the ballot can not draw full quota of exchange unless he had deposited in advance funds for purchase of the full quota.

Exchange for Haj would be issued on production of :—

- (i) Valid Pilgrim passes issued for pilgrimage to Saudi Arabia.
- (ii) Deposit receipts for exchange quota issued by banks.
- (iii) Air/Steamer Ticket for destination in Saudi Arabia.
- (iv) Application in form 'H'.

"ALL PAKISTAN" SECOND ESTIMATE OF SUGARCANE CROP FOR THE YEAR 1963-64 RELEASED BY THE DEPARTMENT OF MARKETING INTELLIGENCE AND AGRICULTURAL STATISTICS.

No. MI/AS-E(3)/64.—Area.—According to the second estimate, the area under sugarcane crop for the year 1963-64 has been estimated to be 1,529,000 acres as against 1,381,000 acres and 1,630,000 acres recorded in the corresponding and final estimates of 1962-63 respectively. It has registered an increase of 10.7 per cent. over the second estimate, but represents a decrease of 6.2 per cent over the final estimate of the preceding year (1962-63).

In East Pakistan, the area has recorded a general increase throughout the Province as a result of favourable weather conditions at the time of plantation. The provincial increase stands at 8.2 per cent.

In West Pakistan too, a general increase of 11.5 per cent over the corresponding estimate has been observed. The increase is reported to have occurred primarily on account of congenial weather conditions and regular supply of canal water during sowing season. The farmers' keen interest in its cultivation due to attractive prices of Gur and Khandsari prevailing in the Market contributed towards the increase of area under the crop.

Production.—The production of sugarcane (stripped

22,897,000 tons reported in the corresponding and final estimates of the previous year. The production has shown a significant increase of 13.2 per cent when compared with the second estimate but has recorded a decrease of 5.3 per cent over the final estimate of the previous year.

In East Pakistan, an all-round increase has occurred with the exception of Khulna Division and is mainly attributed to corresponding increase in acreage. The condition of the crop was earlier reported fair, but a cyclone swept over certain parts causing a slight damage to the crop.

The production of cane registered a general increase (14.4 per cent) throughout West Pakistan over the corresponding estimate but a decrease of 10.1 per cent over the final estimate of 1962-63. The increase is due to corresponding increase in area, satisfactory weather conditions and adequate water supply during growth period notwithstanding a slight shortage of water supply reported in Lahore, Sialkot and Bahawalpur Districts. A successful control of borer attack may also be considered to have contributed towards the increased production.
