S. R. O. 365(K)|64 :

In exercise of the powers conferred by section 2 of the Agricultural Produce (Grading and Marketing) Act, 1937 (I of 1937), and in supersession of Sann Hemp Grading and Marking Rules, 1942, the Central Government is pleased to make the following rules, the same having been previously published in the *Gazette of Pakistan*, dated October 18, 1963, required by the said section, namely :—

SANN HEMP GRADING AND MARKING RULES, 1964.

1. **Short title and application.**—(1) These Rules may be called the Sann Hemp (Grading and Marking) Rules, 1964.

(2) They shall apply to Sann Hemp (*Crotalaria Juncea*) grown in Pakistan.

2. **Definition.**—In these Rules, unless the subject or context otherwise requires "Schedule" means Schedule to these Rules.

3. **Grade designations and definition of quality.**—Grade designations to indicate the characteristics of quality of Sann Hemp are set out in column 1 of Schedule I, and the definition of quality indicated by such designations is specified in columns 2 and 3 thereof.

4. **Grade designation marks.**—The grade designation marks to be applied to each bale shall consist of a label bearing a Government seal, serial number, consignment number, grade designation mark, and year of harvest, as set out in Schedule II.

5. **Method of marking.**—The mark shall only be applied to Sann Hemp in full-pressed bales. The grade designation mark label shall be securely attached to each bale in a manner approved by the Agricultural Marketing and Statistical Adviser.

6. **Method of packing.**—Sann Hemp shall be packed in bales of customary weight for 400 lbs. in an approved manner. Sann Hemp of one grade only shall be packed in one lot, each lot comprising of Sann Hemp prepared in the same manner and in similar conditions.

7. Method of grading.—(1) Classification, baling and marking of Sann Hemp shall be done according to the instructions issued from time to time by the Agricultural Marketing and Statistical Adviser.

(2) Grade designation of bales shall be done after samples of Sann Hemp have been tested by an officer authorized by the Agricultural Marketing and Statistical Adviser in this behalf.

(3) A certificate of quality in the form given in Schedule III shall then be issued by the Agricultural Marketing and Statistical Adviser or an officer authorized by him in this behalf.

8. Expenses of grading and testing.—The expenses for grading and testing of Sann Hemp shall be paid to the Central Government in such manner as the Agricultural Marketing and Statistical Adviser may direct, at the rate of Rs. 1.50 (Rupee one and fifty paise) per bale of 400 lbs.

9. Special conditions of authorization.—In addition to the conditions specified in rule 4 of the General Grading and Marking Rules, 1937, the conditions set out below shall be the conditions of every certificate to the conditions specified in rule 4 of the General Rules, namely:—

(a) The premises of the authorized dealers of

Sann Hemp and the baling presses concerned shall be clean, and shall provide adequate space and facilities for cleaning, sorting, baling, weighing, storage, official inspection and marking of Sann Hemp.

(b) The bales shall be presented for inspection and drawing of samples at the grading station or the point of export, as the case may be, in a suitably covered area. The bales spoiled by water or oil or otherwise shall not be accepted for sampling and marking.

(c) Authorized dealers shall provide the labour needed for shifting and weighing the bales and doing other work in connection with the inspection, sampling and marking of the bales at the Sann Hemp markets and at the points of export.

(d) All such instructions regarding the method of sampling, testing, marking and inspection of Sann Hemp, before and after baling, and regarding the maintenance of records thereof, as may be issued by the Agricultural Marketing and Statistical Adviser from time to time, shall be observed by all concerned.

SUBJECT :—*Establishment of Institute of Development Economics.*

Pursuant to the request by the General Body of the Institute of Development Economics, Karachi (as contained in their Resolution, dated the 16th January 1964) to establish another Institute in place of the existing one for the purposes of expending its activities and improving its organisation and administration, the President is pleased to establish a Pakistan Institute of Development Economics, here-in-after referred to as the 'Institute'.

2. Objectives.

The objectives of the Institute shall be :

- (a) to function as an agency for conducting and promoting research, surveys, seminars, conferences experiments and demonstrations in the field of development economics, demography and related social problems ;
- (b) to provide facilities for training in economics and demographic analysis and research techniques ;
- (c) to publish research papers, studies and such other works as are completed at the Institute or are prepared in collaboration with it or which are otherwise of substantial value to its work ;
- (d) to provide information, advice and consultation regarding modern research techniques and methodology in economics and related social disciplines ;
- (e) to procure requisite personnel, funds and equipment and mobilize other resources for the achievement of goals from all sources within and outside the country ;
- (f) to co-operate with governmental, non-governmental and international agencies in the field in all such activities as lead to the attainment of the objectives delineated above ; and
- (g) to undertake such other activities as may help to realize the objectives of the Institute.

3. Board of Trustees.

(a) The control and administration of the Institute shall vest in a Board of Trustees composed of the following :—

- (i) The President and two Vice-Presidents.
- (ii) The Executive Board.
- (iii) Members.

(b) *The President and Vice-Presidents.*—The President and Vice-Presidents shall be nominated by the Central Government. The President (and in his absence a Vice-President) shall convene and preside over the meetings of the Board of Trustees. The President and the Vice-Presidents of the Board of Governors of the existing Institute at the time of adoption of this constitution, shall be the first President and Vice-Presidents respectively of the Board of Trustees.

(c) *Executive Board.*—There shall be a standing Board called the Executive Board composed of the following :—

- (i) The Chairman, who shall be nominated by the Central Government. The Chairman

of the Executive Committee of the existing Institute at the time of adoption of this Constitution, shall be the first Chairman of the Executive Board.

- (ii) At least six but not more than eleven members. Two of these shall be elected from and by the Senior Fellows as here-in-after defined in clause 5. The Director of the Institute shall be an *ex officio* member of the Executive Board. Other members shall be nominated by the Central Government.

(d) *Members of the Board of Trustees.*—There shall be not more than 25 Members of the Board of Trustees to be selected by the Executive Board as representatives of supporting and co-operating institutions and organisations.

(e) The Board of Trustees shall be empowered to amend or revise this Constitution on the recommendation of the Executive Board.

(f) The Board of Trustees shall frame its own procedures for the conduct of its business.

(g) The terms of the President and the Vice-Presidents of the Board of Trustees and of the Chairman and Members of the Executive Board, shall be five years, renewable at the discretion of the appointing authority.

4. Functions of the Executive Board.

(a) The Executive Board shall

- (1) exercise executive responsibility and authority ;
- (2) approve budget estimates and sanction expenditure ;
- (3) meet, as far as possible, three times a year ;
- (4) make such by-laws as may be considered necessary for the proper administration of the Institute.
- (5) appoint
 - (i) a Director who will be a person of high professional and technical qualifications and has a recognised administrative capacity ;
 - (ii) a Joint Director of similar qualifications and experience ;
 - (iii) a Secretary who will be an experienced administrator ;
 - (iv) Professional and technical staff of the Institute ;
 - (v) Senior Fellows of the Institute who will be productive and highly qualified professional economists and social scientists ;
 - (vi) such special committee as may be required.

(6) take other steps for the proper functioning and development of the Institute within the frame-work of its objectives.

(b) The Executive Board may co-opt members to fill vacancies which may arise from time to time..

(c) The quorum of the Executive Board shall be four.

(d) In matters of urgency, the Chairman may act on behalf of the Board and get his decisions confirmed at the next meeting of the Board.

5. Senior Fellows.

(a) The Senior Fellows of the Institute shall be not more than twelve in number and shall serve for a term of three years which may be renewed. The Senior Fellows serving in that capacity for the existing Institute at the time of adoption of this Constitution shall be the first Senior Fellows of the Institute.

(b) Subsequent appointments as Senior Fellows shall be made by the nominated members of the Executive Board after taking into considerations recommendations made in this behalf by a majority of the Senior Fellows.

(c) Senior Fellows on the expiry of their term shall be eligible for re-appointment by the Executive Board.

(d) Professional qualifications and willingness to devote a substantial amount of time and effort to the affairs of the Institute shall be the sole criteria for appointment to the Senior Fellowship. Senior Fellows shall serve in their individual professional capacities and not as representatives of any Governmental or private organisation. Regular full-time employees of the Institute shall not be eligible to serve as Senior Fellows.

(e) The Senior Fellows shall assist the Institute in formulating and carrying out its research, training, publication and other professional functions and budgeting requirements for the purposes.

(f) The Director|Joint Director shall, in consultation with Senior Fellows, convene meetings of the Fellowship not less than twice a year to discuss the programme and progress of the professional activities of the Institute.

6. The Treasurer.

(a) The Executive Board shall elect a Treasurer of the Institute. The normal term of the Treasurer will be three years unless the office is vacated by resignation or otherwise. In the temporary absence of the Treasurer, the Chairman of the Executive Board may authorise a member of the Board to function as such;

(b) The Treasurer shall supervise the following :—

- (i) Formulation and presentation to the Executive Board of the annual Budget of the Institute.
- (ii) Financial administration of the Institute including maintenance of accounts and adoption of appropriate accounting and financial procedures.
- (iii) Formulation and submission to the Executive Board of annual accounts including balance-sheet and annual report on the financial affairs of the Institute.
- (iv) Arrangements for annual audit of accounts and recommendation to the Executive Board for appointment of an auditor.

7. Director and Joint Director.

(a) The Director, which term means in his absence the Joint Director, shall be the executive officer of the Institute and administer its affairs in accordance with the constituting bylaws and other rules and regulations of the Institute.

(b) The Director|Joint Director shall be appointed or removed by the Executive Board, shall be responsible to the Board and work under their guidance and direction.

(c) The Staff of the Institute shall be appointed by the Executive Board. However, the Executive Board may delegate its powers to the Director to the extent considered necessary.

(d) The Joint Director shall assist the Director and undertake such duties as may be assigned to him by the Director.

8. Secretary.

(a) The Secretary of the Institute shall assist the Director|Joint Director in the discharge of his administrative functions and shall be responsible to the Executive Board.

(b) He shall be appointed or removed by the Executive Board.

(c) He shall act as Secretary to the Executive Board.

(d) He shall be incharge of office, administration and shall operate funds, maintain accounts and have them audited on behalf of the Institute.

9. Finances.

(a) The Institute shall be financed from the following resources :—

- (i) Government grants.
- (ii) Gifts and endowments.
- (iii) Sale or royalties of publications.
- (iv) Income from other research undertaken and
- (v) Other resources.

(b) All funds of the Institute shall be deposited in an authorized bank approved by the Executive Board.

(c) The Secretary shall operate the Institute on behalf of the Executive Board and shall be the drawing and disbursing officer of the Institute.

(d) Accounts of the Institute shall be duly properly maintained by the Secretary and audited annually by authorised auditors approved by the Executive Board. The audited accounts shall be submitted to the Executive Board, for scrutiny.

(e) Certified copies of the annual audited accounts shall be submitted to the Government of Pakistan.

10. Building and Equipment.

(a) The Institute may acquire, hire, purchase or construct accommodation for housing its headquarters, offices, and branches and for other purposes connected with its activities if and when established.

(b) The Institute shall procure necessary research and other office equipment for the proper functioning of the Institute.

11. Location.

The headquarters of the Institute shall be located in Karachi. In due course, the Institute may establish branches in other stations as may be considered necessary.

12. This Constitution shall come into force with effect from the 16th January 1964.

R. O. 376(K) 64 :

In exercise of the powers conferred by clause (b) of sub-section (2) of section 23A of the Sea Customs Act, 1878 (VIII of 778), the Central Board of Revenue is pleased to authorise repayment to the extent specified in column (3) of the table below of customs-duties paid on the importation of the raw materials specified in column (1) of the said table and used in the production or manufacture of the goods specified in column (2) thereof, subject to the following conditions, namely :—

- (1) The goods have been manufactured according to the formula duly furnished to the Central Board of Revenue showing the quantity of various imported raw materials specified in column (1) of the said table used in the production or manufacture of the goods specified in column (2).
- (2) The manufacturer maintains proper record of the goods manufactured in accordance with the formula referred to in sub-paragraph (1) above and produces, on demand, such records and such other evidence as may be required by the Central Board of Revenue to establish that the imported raw materials have been used in accordance with the formula.
- (3) The manufactured goods are exported out of Pakistan and an application for repayment of duty is presented to the proper officer of Customs within sixty days of the date of such exportation.
- (4) The exporter makes a declaration on the reverse of the original shipping bill or other export documents to the effect that he would claim repayment of custom duties paid on the raw materials used in the production of the goods being exported.
