In exercise of the powers conferred by clause (e) of sub-section (2) of section 15BB of the Income-tax Act, 1922 (XI of 1922), the Central Board of Revenue is pleased to approve Messrs. Dost Mohammad Cotton Mills Limited, Karachi as an industrial undertaking in respect of their unit for the manufacture of hosiery yarn comprising 7,600 hosiery spindles at Karachi for the purpose of exemption from the tax under the said section. This exemption is on the basis of information supplied regarding use of raw materials produced in Pakistan and is subject to the conditions being fulfilled as are laid down in clause (d) of sub-section (2) of section 15BB of the Income-tax Act. The statutory period of exemption would be reduced by the period from the date of production to 30th June, 1964.

8. The maximum age limit will be relaxed as follows:—

- (a) by three years in the case of Scheduled Caste candidates and candidates belonging to Buddhist community, and the recognised tribes of the Special (Tribal) areas of West Pakistan.
- (b) by three years in respect of the candidates belonging to the Excluded Areas of East Pakistan (Chittagong Hill Tracts), the tribes residing in the district of Mymensingh and aboriginal tribes residing in the districts of Rajshahi and Dinajpur irrespective of the religion they profess.
- (c) by three years in respect of the candidates who are permanent residents of Azad Kashmir territory, the Gilgit Agency or Baltistan or candidates belonging to the State of Jammu and Kashmir living in these areas, or in any part of Pakistan.

NOTE 1.—The term Scheduled Caste means a scheduled caste determined in accordance with the provisions of article 204 of the late Constitution. Candidates claiming to belong to Scheduled Caste or to Buddhist Community will be required to submit a certificate from the District Magistrate concerned in support of their claim.

NOTE 2.—Only those candidates who are permanent residents of the areas mentioned at (a) and (b) above and whose families have been living in these areas will be eligible for the concession and in each case a certificate from the Political Agent or the Deputy Commissioner concerned will be required to be produced. Members of Tribes belonging to the Tribal Areas who have settled in the Settled Districts will not be eligible for this concession.

NOTE 3.—The concession mentioned at (c) above will be admissible to candidates who produce a certificate from the Ministry of Home and Kashmir Affairs (Kashmir Affairs Division), Government of Pakistan.

9. A candidate for appointment to the post must be in good mental and bodily health and free from any physical defect likely to interfere with the discharge of his/her duties. A candidate who after such medical examination as Government may prescribe, is found not to satisfy these requirements, shall not be appointed.

10. (a) Appointment shall be made on probation for a period of one year.

(b) If, in the opinion of the Director the work or conduct of the person on probation is unsatisfactory or shows that he/she is unlikely to become efficient, the Director may discharge/revert him/her forthwith or extend his/her probation for such further period, not exceeding one year, as he may think fit.

(c) On the conclusion of the period of probation the Director may confirm a probationer in his/her appointment provided a clear vacancy exists.

(d) If no action is taken by the Director under sub-rule (b) or (c) of this rule, the period after the prescribed period of probation shall be treated as temporary engagement until further orders.

6. Government may modify or waive all or any of the requirements of sub-rules (b) and (c) of Rule 5 when it is not practicable to obtain a suitable candidate who fulfils all the requirements of those sub-rules.

7. (a) Application for appointment to the post shall be submitted to the Director in such form and manner and before such date as the Director may prescribe.

(b) Persons already in Government service shall, in the matter of applications, be governed by the provisions of Government Servant's Application for Posts (Central Services) Rules, 1953. Candidates who join Government service after they have submitted their applications should also obtain in writing the permission of the Head of the Department concerned and forward the same to the Director immediately thereafter.

(c) The decision of the Director as to the eligibility or otherwise of a candidate shall be final.

REMARKS

1. During the week ending 1st June, 1963 in 63 towns (excluding 7 towns of East Pakistan) each having a population of 30,000 and over, the mid-year estimated population of these 63 towns for the year 1963 was 87,20,029; the number of deaths recorded were 974 and the death rate was 5.8 per 1,000 of population per annum.

2. The total number of births in these 63 towns were 3,303 which gave a birth rate of 19.7 per 1,000 of population per annum.

3. The rate of natural increase was +13.9 per 1,000 of population per annum.

4. In these 63 towns, 1, 1 and 50 deaths occurred due to small-pox in Bahawalpur Municipality, Karachi and Dacca Town respectively.
