The President is pleased to direct that the following further amendment shall be made, with immediate effect to the P.O.I.F. Rules (hereinafter) referred to as the said rules, namely:

For the existing note 6, below rule 28 of the said rules, the following shall be substituted, namely:

“NOTE 6.—Advance payment of premia for any number of months may be made in cash at a Post Office at the discretion of the insurant. If the advance payments of premia are made as a standing arrangement with the prior sanction of the Director, Postal Life Insurance, a rebate thereon will be allowed at the rates as indicated below during the currency of the standing arrangement:—

S. R. O. 343(K)/65:

In pursuance of Section 43-B of the Karachi Port Trust Act, 1886 (Ben. Act VI of 1886), it is hereby notified that the following amendments have been made

by the Karachi Port Trust Board with the sanction of the Central Government in Tables XIV and XVI of the Karachi Port Trust Scale of Rates, Dues and Charges framed by the said Board under Section 43 and 43-A of the said Act, namely :—

1. In Table XIV, Section C, of the said Karachi Port Trust Scale of Rates, Dues and Charges, for the existing sub-head under Scale B, the following shall be substituted :—

“ Hire of Hydraulic Cranes at Juna Bunder ”.

- (1) When requisitions for cranes reach the Wharfage Officer not later than 3-30 P.M. on the day previous to the night or day from which cranes are required :—

- (a) For one half of a day or night—Rs. 18.00 (per crane).

- (b) For the whole of the day or night—Rs. 27.00 (per crane).

- (2) Per hour or part of an hour—Rs. 5.00 (per crane).

NOTE.—(i) The requisitioning of cranes will be at the option of the user.

(ii) Subject to a minimum charge of Rs. 6.00 per crane by each person requisitioning their use.

- (ii) In Table XVI, Scale A, Section C, of the said Karachi Port Trust Scale of Rates, Dues and Charges, the following note shall be added after item 3 under sub-head (ii) 250-Tons Barges :—

NOTE.—“ Barges requisitioned and supplied for coastal vessels as defined under Table V will be charged Rs. 150.00 per barge on the same conditions as above ”.

RESOLUTION

SUBJECT.—*Establishment of a Museum of Science and Technology at Lahore, West Pakistan.*

S. R. O. 346(K)|65 :

In order to create a scienceconsciousness in the students and the public, Government of Pakistan has decided to establish a Museum of Science and Technology.

Aims and Objectives of the Museum :

2. (a) To create a scientifically educated citizenry in the country ;

- (b) to promote in the public mind an interest for science and technology and develop a scientific attitude in the masses ;

- (c) to arouse in the students an interest for the study of Science and Technology ;

- (d) to help people appreciate the contribution of science, technology and the work of scientists for human welfare and civilization ;

- (e) to supplement the teaching of science in schools and colleges.

Governing Body :

3. The Museum shall be an autonomous organisation under a Board of Governors to be appointed by the Government of Pakistan.

Board of Governors

4. (i) The Board of Governors shall consist of the following :—

- (1) Chairman to be nominated by the Government of Pakistan.

- (2) Members (a) A representative of the University of the Punjab Lahore.
(b) Adviser (Technical Education) and Ex-Officio Joint Secretary, Government of West Pakistan.

- (c) A representative of the Scientific and Technological Research Division.

- (d) A representative of the Ministry of Education.

- (e-g) Three persons to be nominated by the Government of Pakistan.

- (3) Member-Secy. Director of the Museum.

- (ii) The term of office of Members other than ex-officio members shall be three years.

Functions of the Board :

5. The Board shall frame general principles and policies for the direction and supervision of the affairs of the Museum. The Board may appoint such committees as it may deem necessary. It will frame its own rules of business and other rules and regulations for the proper discharge of its functions. All expenses on the meetings of the Board or the Committees appointed by it will be met from the funds of the Museum.

6. Until such time as the Board of Governors is fully constituted and holds its first meeting, the Ministry of Education may take such action as may be necessary or expedient for the early establishment of the Museum.

Executive Committee :

7. The Board of Governors will set up a small Executive Committee to run the day-to-day administration of the Museum. The Chairman of the Board will be the Chairman of the Executive Committee. There will be two other members to be appointed by the Board. The Director of the Museum shall be the *ex-officio* Member-Secretary of the Committee.

Director :

8. There shall be a Director who shall be the administrative Head and the Drawing and Disbursing Officer of the Museum. He shall be responsible for the proper maintenance and smooth functioning of the Museum. He shall be appointed by the Board of Governors on terms and conditions to be determined by the Board but his appointment shall be subject to the approval of the Government of Pakistan.

Funds :

9. The funds of the Museum shall consist of grant-in-aid from the Central Government and such other incomes as may accrue to it from other sources. The funds of the Museum shall be kept in a scheduled Bank as may be determined by the Board of Governors. The accounts of the Museum shall be audited by a registered firm of auditors. A statement of the audited accounts shall be placed before the Board of Governors and also submitted to the Government of Pakistan, Ministry of Education.

RESOLUTION

SUBJECT.—*Establishment of a Museum of Science and Technology at Dacca, East Pakistan.*

S. R. O. 347(K)65 :

In order to create a science-consciousness in the students and the public, Government of Pakistan has decided to establish a Museum of Science and Technology.

Aims and Objectives of the Museum :

2. (a) To create a scientifically educated citizenry in the country;

(b) to promote in the public mind an interest for science and technology and develop a scientific attitude in the masses;

(c) to arouse in the students an interest for the study of science and technology;

(d) to help people appreciate the contribution of science, technology and the work of scientists for human welfare and civilization;

(e) to supplement the teaching of science in schools and colleges.

Governing Body :

3. The Museum shall be an autonomous organisation under the administrative control of a Board of Governors to be appointed by the Government of Pakistan.

Board of Governors :

4. (i) The Board of Governors shall consist of the following :—

(1) Chairman.. .. to be nominated by the Government of Pakistan.

(2) Members (a) A representative of the East Pakistan University of Engineering and Technology, Dacca;

(b) Director of Technical Education, Government of East Pakistan;

(c) A representative of the Scientific and Technological Research Division;

(d) A representative of the Ministry of Education;

(e—g) Three persons to be nominated by the Government of Pakistan.

(3) Member-Secretary Director of the Museum.

(ii) The term of office of members other than *ex-officio* shall be three years.

Functions of the Board :

5. The Board shall frame general principles and policies for the direction and supervision of the affairs of the Museum. The Board may appoint such committees as it may deem necessary. It will frame its own rules of business and other rules and regulations for the proper discharge of its functions. All expenses on the meetings of the Board or the Committees appointed by it will be met from the funds of the Museum.

6. Until such time as the Board of Governors is fully constituted and holds its first meeting, the Ministry of Education may take such action as may be necessary or expedient for the early establishment of the Museum.

Executive Committee :

7. The Board of Governors will set up a small Executive Committee to run the day-to-day administration of the Museum. The Chairman of the Board will be the Chairman of the Executive Committee. There will be two other members to be appointed by the Board. The Director of the Museum shall be the *ex-officio* Member-Secretary of the Committee.

Director :

8. With the approval of the Government of Pakistan the Board of Governors shall appoint a Director for the Museum on such terms and conditions as may be determined by the Board. The Director shall be the administrative Head of the Museum. He shall be responsible for the proper maintenance and functioning of the Museum. He shall be the Drawing and Disbursing Officer of the Museum.

Funds :

9. The funds of the Museum shall consist of grants-in-aid from the Central Government and such other incomes as may accrue to it from other sources. The funds of the Museum shall be kept in a scheduled Bank as may be determined by the Board of Governors. The accounts of the Museum shall be audited by a registered firm of auditors. A statement of the audited accounts shall be placed before the Board of Governors and also submitted to the Government of Pakistan, Ministry of Education.

CENTRAL BOARD OF REVENUE

Customs

Islamabad, the 29th April 1965

S. R. O. 352(K)/65 :

In exercise of the powers conferred by clause (b) of sub-section (2) of section 23A of the Sea Customs Act, 1878 (VIII of 1878), and in supersession of the notifications listed in Table II and in partial supersession of the notifications listed in Table III, the Central Board of Revenue is pleased to authorize repayment to the extent specified in column 3 of the table below of customs-duties paid on the importation of the raw materials specified in column 1 of the said table and used in the production or manufacture of the goods specified in column 2 thereof, subject to the following conditions, namely :—

- (1) The goods have been manufactured according to the formula duly furnished to the Central Board of Revenue showing the quantity of various imported raw materials specified in column 1 of the said table used in the production or manufacture of the goods specified in column 2.
- (2) The manufacturer maintains proper records

of the goods manufactured in accordance with the formula referred to in sub-paragraph (1) above and produces on demand such records and other evidence as may be required by the Central Board of Revenue to satisfy itself that the imported raw materials have been used in accordance with the formula.

- (3) The manufactured goods are exported out of Pakistan and an application for repayment of duty is presented to the proper officer of Customs within sixty days of the date of such exportation.
- (4) The exporter makes a declaration on the reverse of the original shipping bill or other export document to the effect that he would claim repayment of the customs-duties paid on the raw materials used in the production of the goods being exported.

This notification shall be deemed to have taken effect on the 1st October 1964.

REMARKS

1. During the week ending 29th June, 1963 in 59 towns (excluding 3 and 8 towns of West and East Pakistan) each having a population of 30,000 and over, the mid-year estimated population of these 59 towns for the year 1963 was 85,64,122 ; the number of death recorded were 927 and the death rate was 5.6 per 1,000 of population per annum.

2. The total number of births in these 59 towns were 3,504 which gave a birth rate of 21.3 per 1,000 of population per annum.

3. The rate of natural increase was +15.7 per 1,000 of population per annum.

4. In these 59 towns, 1 and 2 deaths occurred due to Cholera in Dacca and Narayanganj Towns respectively whereas 1 and 13 deaths occurred due to Small-pox in Barisal, and Dacca town respectively.
