The following amendments are made in the Recruitment Rules for Class I & Class II Services in the Survey of Pakistan published under Gazette Notification No. F. 12-110/52-FS, dated the 13th May 1953 :—

I. In Rule 2 clause (a) after deleting the word "Governor General" the word "President" may be substituted and in Clause (c) for the word "Pakistan" the word "Central" may be substituted.

II. The existing Rule 4 may be substituted by the following :—

"4(a) A candidate for appointment must be a male and, on the date of application, must

be a citizen of Pakistan or a person deriving his nationality from the State of Jammu and Kashmir.

(b) A candidate who has married a person who is not a citizen of Pakistan shall not be eligible for appointment to the service but if any candidate marries an Indian National after obtaining the permission of Government, he will be regarded as eligible for appointment."

III. The existing clause (c) of Rule 6 may be substituted by the following :—

"One third of the vacancies in the Class II Service will be filled by promotion and the remaining 2/3rd by competitive examination."

IV. The existing Rule 9(i) may be read as 9(1) and Rule 9(ii) may be substituted by the following:—

"9(?) The maximum age limit will be relaxed as follows:—

(a) by three years in respect of candidates belonging to:

(i) the Scheduled Castes and Buddhist Community;

(ii) the recognized tribes of the special (Tribal) areas of the North West Frontier and former Baluchistan, the former Frontier and Baluch States and the former tribal areas of Dera Ghazi Khan District of West Pakistan;

(iii) the tribes in the Excluded Area of East Pakistan (Chittagong Hill Tracts);

(iv) the tribes residing in the district of Mymensingh;

(v) the aboriginal tribes residing in the districts of Rajshahi and Dinajpur irrespective of the religion they profess; and

(vi) permanent residents of Azad Kashmir Territory, the Gilgit Agency and Baltistan; or candidates of Jammu and Kashmir State who live in either of the aforesaid areas or any other part of Pakistan.

(b) By a maximum period of two years in the case of candidates who have served in the Armed Forces of Pakistan other than on regular basis and who are liable to be called for regular Military service i.e., candidates who have served in the Armed Forces of Pakistan other than on regular basis, but are liable to be called for regular military service, may deduct such service from their actual age upto a maximum of two years. This concession will, however, be admissible in each case on production of a certificate from the Ministry of Defence.

(c) By five years in the case of candidates who held permanent appointment in the Department of Survey of Pakistan or who have served it continuously for a period of not less than three years.

NOTE 1.—Candidates claiming to belong to a Scheduled Caste will be required to submit a certificate from the District Magistrate in support of their claim.

NOTE 2.—Candidates belonging to the Buddhist Community will be eligible for the concession mentioned at (a) above on production of a certificate from District Magistrate, political Agent, Deputy Commissioner or Collector as the case may be, in support of their claim.

NOTE 3.—Only those candidates who are permanent residents of the areas, mentioned at (a) above, and whose families have been living in those areas, will be eligible for the concession and, in each case, a certificate from the Political Agent or the Deputy Commissioner will be required in this behalf. Members of Tribes belonging to the Tribal Areas who are included in the Settled Districts will not be eligible for this concession.

NOTE 4.—The concession mentioned at (a) (vi) above will be admissible to candidates who produce a certificate from the Ministry of Kashmir Affairs, Government of Pakistan."

V. In Rule 24 after deleting the fullstop, the following may be added:—

"and from Technical Assistants".

VI. In Part IV, the following may be added: Rule 25 and the existing Rule 25 may be renumbered as '26':—

"Persons who fail to secure confirmation in the existing appointment, on account of unsatisfactory service record, will not be considered for promotion."

The following Recruitment Rules for the post of Secretary, Central Board of Films Censors are Published for general information:—

**PART I.—GENERAL.**

1. These Rules may be called Recruitment Rules for the Class I Posts of Secretary, Central Board of

Films Censors in the Ministry of Information and Broadcasting.

2. For the purpose of these Rules.—(a) 'Government' means the President.

(b) 'Commission' means the Central Public Service Commission.

(c) 'post' means the post of Secretary, Central Board of Films Censors, in the Ministry of Information and Broadcasting.

(d) 'Direct appointment' means appointment made otherwise than by promotion or transfer from another service|Department|post.

(e) "Words importing the masculine gender shall include females, and words in the singular shall include the plural and words in plural shall include the singular."

3. (a) Recruitment to the post shall be made by direct appointment in accordance with Part II of these rules.

(b) Vacancies in the post shall be distributed among the provinces|regions of Pakistan in accordance with the Establishment Division O.M. No. 25|10|50-SE dated 6th October 1950, and the Commission will be informed of domicile of the required candidate for appointment, as required under the Establishment Division memo. No. 1|4|64-DV, dated 30th June 1964.

**PART II.—RECRUITMENT BY DIRECT APPOINTMENT.**

4. Recruitment by direct appointment shall be made on the recommendations of the Commission.

5. A candidate for direct appointment must.—(a) be on the date of application either a citizen of Pakistan or a person deriving his nationality from the State of Jammu and Kashmir or a person whose temporary employment has been authorised by the President under Article 179(1) of the Constitution.

(b) be not less than 30 and not more than 40 years of age on the last date of receipt of application prescribed in the advertisement issued by the Commission.

(c) Possess:—

(i) University Degree.

(ii) Command on Urdu|Bengali languages for the Secretary at Lahore|Dacca respectively.

For the Secretary at Rawalpindi similar qualification in Urdu or Bengali language.

(iii) 5 years experience in an Administrative|Secretariat post in Government.

(iv) Persons having experience in Journalism|Public Relation Work|Film Industry will be preferred.

(v) Travel abroad and interests in Social and Cultural activities desirable.

6. A candidate who has married a person who is not a citizen of Pakistan shall not be eligible for appointment to the post but if a candidate marries an Indian national after obtaining the permission of Government, he will be regarded as eligible for the appointment.

7. A candidate must satisfy the Commission that his character and antecedents are such as to make him suitable for appointment to the post. The candidate will have no right unless Government are satisfied after such enquiry as may be necessary that the candidate is suitable in all respect for appointment to public service.



Part II

Requirements of Rules 5(b) and (c) will be relaxable on the recommendation of the Commission in very special cases of candidates otherwise highly qualified. Government may, in consultation with the Commission, modify or waive all or any of the said requirements when an appointment for work of a special nature is to be made and it is not practicable to obtain a suitable candidate who fulfils all the requirements of the said Rules.

(a) Application for direct appointment shall be submitted to the Commission, in such form, on such fee and in such manner and with such fee as the Commission may prescribe.

(b) Government servants who fulfil the conditions laid down in these rules are eligible for appointment permitted by the competent authority in their departments or offices and shall be subject to the provisions of the Government Servants Applications for Posts (Central Services) Rules, 1953, as amended from time to time. No Government servant shall be competent to apply for appointment even if otherwise eligible, without the permission in writing of his department/office as the case may be, and such permission must accompany the application. Candidates who join Government service after submitting their applications for recruitment to the post should also submit the Departmental permission immediately thereafter. A candidate who has left Government service, should submit with his application the original as well as a copy of his discharge/service certificate.

(c) The decision of the Commission as to the eligibility or otherwise of a candidate shall be final.

10. The maximum age limit laid down in rule 5(b) will be relaxed as follows:—

(a) by three years in respect of the candidate belonging to:—

(i) the Scheduled Caste and Buddhist Community.

(ii) the recognised tribes of the Special (Tribal) Areas of the North-West Frontier and former Baluchistan, the former Frontier and Baluch States and the former tribal areas of Dera Ghazi Khan District of West Pakistan.

(iii) the tribes in the excluded areas of East Pakistan (Chittagong Hill Tracts).

(iv) the tribes residing in the District of Mymensingh.

(v) the aboriginal tribes residing in the Districts of Rajshahi and Dinajpur irrespective of the religion they profess.

(b) By three years in the case of the candidates who are permanent residents of Azad Kashmir Territory, the Gilgit agency and Baltistan; or candidates of former Jammu and Kashmir

State who live in either of the aforesaid areas or any other part of Pakistan.

NOTE 1.—Candidates claiming to belong to a Scheduled Caste will be required to submit a certificate from the District Magistrate in support of their claim.

NOTE 2.—Candidates belonging to the Buddhist Community will be eligible for the concession mentioned at (a) above on production of a certificate from District Magistrate, Political Agent, Deputy Commissioner or Collector as the case may be, in support of their claim.

NOTE 3.—Only those candidates who are permanent residents of the areas mentioned at (a) above, and whose families have been living in those areas, will be eligible for the concession and, in each case, a certificate from the Political Agent or the Deputy Commissioner will be required in this behalf. Members of Tribes belonging to the Tribal Areas who have settled in the Settled Districts will not be eligible for this concession.

NOTE 4.—The concession mentioned at (b) above will be admissible to candidates who produce a certificate from the Ministry of Kashmir Affairs, Government of Pakistan.

11. A candidate must be in good mental and bodily health and free from any physical defect likely to interfere with the discharge of his duties as an officer. A candidate who (after such medical examination as

Government or the appointing authority, as the case may be, may prescribe) is found not to satisfy requirements, will not be appointed.

12. (a) Appointment shall be made on probation for a period of one year.

(b) If, in the opinion of Government, the work or conduct of an officer on probation is unsatisfactory, shows that he is unlikely to become efficient, Government may discharge or revert him forthwith, or extend his probation for such further period not exceeding one year as the Government may think fit.

(c) On the satisfactory conclusion of the period of probation, Government may confirm a probationary officer in his appointment provided a clear vacancy exists.

(d) If no action is taken by Government under rule (b) or (c) of this rule, the period after the prescribed period of probation shall be treated as temporary engagement until further orders.

(e) If the power to make appointments to the post is delegated by Government to any officer, that officer may exercise any of the powers of Government under this rule.
