**BOARD OF INTERMEDIATE AND SECONDARY
EDUCATION, RAJSHAHI**

Discipline and Conduct Regulations CD-68

REGULATION

1. These Regulations shall be called the Conduct and Discipline Regulations of the employees of the Board of Intermediate and Secondary education, Rajshahi and in these regulations unless there is anything repugnant in the subject or context,—

- (a) "Board" means the Board of Intermediate and Secondary Education, Rajshahi ;
- (b) "Controlling Authority" means the Controlling Authority of the Board as defined in the East Pakistan Ordinance No. XXXIII of 1961 ;
- (c) "Chairman" means the Chairman of the Board of Intermediate and Secondary Education, Rajshahi ;
- (d) "Controlling Officer" means the officer under whom the employee concerned is directly placed ;

Explanation—In case of officers of the Board the Chairman is the Controlling Officer and in case of other employees the officer in-charge of the Section concerned is the Controlling Officer ;

- (e) "Authority" means the authority competent to exercise powers under these Regulations as defined in Regulation 5(1) below ;
- (f) "Misconduct" means conduct prejudicial to good order of service discipline or conduct unbecoming of an employee of the Board and includes professional misconduct or any offence involving moral turpitude or indiscipline of any kind or insubordination or any conduct considered to be harmful or undesirable in any manner or prejudicial to the interest of the Board or the State or any other act or conduct as the Authority may decide ;
- (g) "Penalty" means any punishment which may be imposed under these regulations.

2. These regulations shall substitute the Rules and Regulations under Regulation No. CD-65, vide G. O. No. G/964/I (II)-Edn., dated the 24th September 1965 and shall apply to every employee of the Board.

3. These regulations shall take effect immediately and shall be deemed to have been in force since the inception of the Board.

4. (A) Ground for penalty—Where an employee of the Board, in the opinion of the authority,—

- (a) is inefficient, or has ceased to be efficient, whether by reason of infirmity of mind or body or otherwise, and is not likely to recover his efficiency ; or
- (b) is indifferent to his work ; or
- (c) is guilty of misconduct ; or

- (d) is corrupt or may reasonably be considered to be corrupt because he or any of the persons dependent on him, or any other person through him or on his behalf is in possession of pecuniary resources or of income (for which he cannot reasonably account) or he has assumed a style of living beyond his ostensible means; or
 - (e) is engaged or is reasonably suspected of being engaged in subversive activities detrimental to the interest of the Board or of the State or is reasonably suspected of being associated with others engaged in such activity or activities, and whose retention the service is, therefore, considered prejudicial to the interest of the Board or National security; or
 - (f) becomes a member of or is associated in any capacity with any outside organisation of any kind other than those organized by the Board, without obtaining the prior permission of the Chairman in writing; or
 - (g) is engaged directly or indirectly without the prior permission of the Board in writing in any trade, business or occupation on his own account or in the name of any other person standing as 'benamdar' for him which may, in the opinion of the authority, interfere with his normal duties; or
 - (h) absents from duty without leave or overstays beyond sanctioned leave without sufficient cause; he/she shall be liable to any one (or more than one) of the penalties described in section 4(B) below:
4. (B) Penalty—
- (i) Censuring;
 - (ii) withholding of increments or promotion (including withholding or permission to cross the efficiency bar) for a specified period;
 - (iii) recovery from pay of the whole or part of any pecuniary loss caused to the Board by negligence or otherwise,
 - (iv) reduction to a lower post or time-scale, or to a lower stage in a time-scale;
 - (v) removal from service; and
 - (vi) dismissal from service.
5. (1) The following shall be the Authority competent to impose penalty under these regulations.
- (i) The Controlling Authority in the case of the Chairman of the Board.
 - (ii) The Board in the case of all officers other than the Chairman.
 - (iii) The Chairman in the case of all other employees.
- (2) When an employee of the Board is to be proceeded against, the Authority—
- (a) may, by order in writing place the employee concerned under suspension or require the said employee to proceed on such leave as may be admissible to him; and
 - (b) shall, by order in writing inform him of the action proposed to be taken against him and the grounds of that action.
- (3) The Inquiry Committee shall be constituted as follows:
- (a) In respect of the Chairman of the Board, the Controlling Authority shall constitute an Inquiry Committee of two or three persons to be nominated by the Controlling Authority,
 - (b) In respect of the officers other than the Chairman the Board shall constitute an Inquiry Committee of two or three persons to be nominated by the Board after considering the recommendation of the Chairman,
 - (c) In respect of employees other the officers of the Board, the Chairman shall constitute the Inquiry Committee of two or three persons.
- (4) The Inquiry Committee shall enquire into the charges, and submit its findings with specific recommendations to the Authority.
6. When an employee of the Board is to be proceeded against for any or more of the offences described under Regulation 4(A), the procedure for holding an enquiry shall be as follows:
- (a) The Authority shall constitute an Inquiry Committee in the manner as laid down under Regulation 5(3).
 - (b) The Controlling Officer shall frame a formal charge-sheet containing the charge or charges against the employee concerned and shall present the charge-sheet to the Inquiry Committee whereupon the Inquiry Committee shall forward a copy of the charge-sheet to the employee concerned calling upon him to show cause why disciplinary action under Regulation 4(B) shall not be taken against him.

The employee concerned shall be required to submit a written explanation within 14 (fourteen) days from the date he receives the charge-sheet failing which it shall be presumed that he has nothing to say in his defence. If the person proceeded against is illiterate or semiliterate the charge-sheet shall be read out and explained to him by an officer of the Board (to be nominated by the Authority) who shall certify on the body of the charge-sheet that this requirement has been complied with.

(c) The explanation submitted by the employee shall be considered by the Inquiry Committee.

(d) If the employee concerned desires to be heard in person or if the Inquiry Committee considers that he should be examined in person the Inquiry Committee shall give him necessary facility for the purpose including cross-examination of witnesses by the employee concerned. But the employee concerned shall not be permitted to engage any lawyer.

(e) The findings of the Inquiry Committee with its recommendations shall be placed before the Authority who shall thereupon pass such orders as the Authority thinks fit.

(f) Notwithstanding anything contained in the foregoing clauses formal inquiry may be dispensed with, when the order of dismissal is passed on the strength of facts or conclusions arrived at by a judicial trial by a Court Martial or when the accused is absconding, or adopting means to prolong or delay the conclusion of the enquiry with a view to gain undue advantage.

Notes—(1) There is no necessity of issuing charge-sheet when an employee of the Board is to be punished as a result of his conviction by a Criminal Court for an offence involving moral turpitude.

(2) When as a result of an enquiry it is proposed to dismiss, remove from service or reduce an employee to a lower rank he should be afforded a further opportunity to show cause within a reasonable time, not exceeding one month why the proposed penalty should not be inflicted. For this purpose any representation submitted by him should be duly taken into consideration before final orders of dismissal, removal from service or reduction to a lower rank are given effect to.

7. (i) Where it is proposed to proceed against an employee of the Board on the ground of inefficiency by reason of infirmity of mind or body, the Authority may at any stage require the employee to undergo a medical examination by a Medical Officer or Medical Board, as the Authority may direct, and the medical report shall form part of the proceedings.

(ii) If the employee refuses to undergo such medical examination, it shall be presumed that there is reason to believe that the result of the examination would prove unfavourable to him.

8. In ordering the withholding of an increment, the Authority passing the order shall state the period for which it is withheld and also shall state whether this period of postponement will be counted in fixing his pay at the end of the penalty period.

9. When an employee of the Board is reduced for inefficiency or misconduct to lower post or time-scale or to a lower grade or to a lower stage in a time-scale, the Authority ordering the reduction shall state the period for which it shall be effective and also the actual pay to be fixed on the expiry of that period.

10. Every order imposing a penalty on an employee of the Board shall be communicated to him in writing under registered cover or through Peon Book.

11. (a) An employee of the Board may be placed under suspension when he is arrested or committed to prison pending trial by a Court of Law on ground of an offence involving moral turpitude or any other offence as the Authority may consider appropriate for such action.

(b) An employee of the Board whose conduct is undergoing investigation in respect of any charge, the maximum penalty for which is dismissal or removal from service, may be kept under suspension until his case is finally decided.

(c) When an employee of the Board is convicted on a criminal charge for any offence as the Authority consider sufficient for awarding any punishment the employee concerned shall, according to the merit of the case, be punished, in any manner as the Authority may decide.

12. An employee of the Board is entitled to the following payment during the period of suspension :

Subsistence allowance at the rate of one-third of his pay (if prayed for by the employee concerned).

13. The orders passed by the Authority by way of awarding punishment of on description under these regulations shall be final:

Provided that the employee so punished may only in the case of Regulations 5(1)(ii) and Regulations 5(1)(iii) submit a representation to the Authority described under Regulations 5(1)(i) and 5(1)(ii) respectively through the Authority concerned.

14. Notwithstanding anything contained in these regulations the statutory powers conferred on the Chairman of this Board shall not in any way be affected:

Provided further that the Board shall have power to amend, modify or annul any of the provisions of these regulations.



The final estimate of Rape and Mustard crops of East Pakistan for the year, 1967-68.

Character of the season—The weather condition was unfavourable at the time of sowing but subsequently it improved in the district of Bogra. In Khulna the weather was good at sowing time but later on drought prevailed there. In Noakhali and Kushtia the weather was unfavourable due to drought. Drought also prevailed in Pabna. Some damages have also been reported from Noakhali and Bogra due to drought and hail storm respectively. In other districts, the weather condition was, more or less, favourable.

Area—The total area under Rape and Mustard has been estimated at 529,965 acres in 1967-68 as against 486,680 acres of 1966-67. The increase in total area is mainly attributed to the increase in area in Dacca, Faridpur, Comilla and Dinajpur districts due to increased demand, "Grow More Food Campaign", and fair weather. In Dinajpur, the increase in area under the crop is due to utilization of some fallow land and land where Aman paddy would not be transplanted due to drought.

Yield rates—The average yield for the crops for the province stands at 6.2 maunds this year as against 5.7 maunds of last year. The increase in average yield rate is due to, more or less, favourable weather in most of the districts and better agricultural practices. The increase in yield rates has been shared by all the Divisions.

Production—The total production under the crops has been placed at 120,365 tons in 1967-68 as against 101,985 tons of 1966-67. The increase in production is due to increase in area as well as in yield rates.

District-wise acreages, yield rates and production figures are given in the appendix below.

The Final estimate of Gram crop of East Pakistan for 1967-68.

Character of the Season—Drought prevailed in the districts of Kishoreganj, Faridpur, Noakhali, Rajshahi, Pabna, Khulna, Jessore and Kushtia and affected the crop adversely. Damage due to drought has been reported from Faridpur, Noakhali, Khulna and Kushtia districts. In other districts, the weather condition was, more or less, favourable.

Area—The total area under Gram crop has been estimated at 1,52,330 acres in 1967-68 as against 146,450 acres of 1966-67. The increase in area is due to increased demand, departmental propaganda for grow more food, and favourable weather in several districts.

Yield rate—The average yield for the crop for the province stands at 8.32 mds. this year as against 9.01 mds. of the last year. The decrease in average yield rate is due mainly to decrease in yield rates in Faridpur, Rajshahi, Khulna, Jessore and Kushtia where drought affected the growth of the crop adversely.

Production—The total production under the crop has been placed at 46,555 tons this year as against 48,460 tons of the previous year. The decrease in average yield rate is responsible for decrease in production.

District-wise area, yield and production figures are given in the appendix below.
