RECRUITMENT RULES OF CLASS I AND CLASS II POSTS IN THE DEPARTMENT OF TOURISM

R.O. 759(K)/70:

The following rules for recruitment to the Class I and Class II posts in the Department of Tourism, Ministry of Defence are published for general information.

PART I.—GENERAL

1. These rules shall be called the Department of Tourism (Class I and Class II Posts) Recruitment Rules.

2. In these Rules, unless the context otherwise requires,—

(a) 'Government' means the President of Pakistan or a person authorised by the President to make appointments to the posts.

(b) 'Department' means the Department of Tourism and all its offices within the country and abroad.

(c) 'Posts' means the posts shown in the schedules I, II and III to these rules.

(d) 'Direct Appointment' means appointment made otherwise than by promotion or transfer from other posts in the Department.

(e) 'Departmental Promotion Committee' means the Committee constituted in the Ministry of Defence in the Department in accordance with the instructions contained in the Establishment Division O.M. No. FF. 33/1/47-Ests. (SE) II, dated the 29th January 1948 and the supplementary instructions issued from time to time.

(f) 'Selection Board' means a Board constituted in accordance with the Establishment Division O.M. No. 33/1/47-Ests. (SE) I, dated 29th January 1948 and the supplementary instructions issued from time to time.

3. Recruitment to the posts shall be made as follows:—

(a) The posts of Director General and Director shall be filled by promotion in accordance with Part II of these Rules.

If none is found suitable for promotion, the posts shall be filled by transfer in accordance with Part IV of these Rules.

(b) 40% of the posts of Deputy Director and Assistant Director shall be filled by promotion in accordance with Part II of these Rules and 40% by direct appointment in accordance with Part III of these Rules and the remaining 20% shall be filled by transfer in accordance with Part IV of these Rules.

(c) The post of Assistant Director (Administration) shall be filled by promotion in accordance with Part II of these Rules and if none is found suitable for appointment by promotion, then by transfer in accordance with Part IV of these Rules.

(d) 50% of the posts of Tourist Officer shall be filled by promotion in accordance with Part II of these Rules and the remaining 50% shall be filled by direct appointment in accordance with Part III of these Rules.

(e) The post of Statistical Officer shall be filled by promotion in accordance with Part II of these Rules.

(f) The posts of Script Writer, Statistician, Librarian, Public Relations Officer and Tourist Information Assistant shall be filled by direct appointment in accordance with Part III of these Rules.

(g) The post of Audit and Accounts Officer shall be filled by transfer in accordance with Part IV of these Rules provided that:—

(i) if no suitable person is available for appointment by promotion or transfer, the vacancy or vacancies shall be filled by direct appointment in accordance with Part III of these Rules.

(ii) short term vacancies reserved for direct appointment may, in consultation with the Commission, be filled by any other method of recruitment prescribed in these Rules.

4. Promotion against departmental quota will be made first and vacancies meant for transfer or direct appointment will be filled later.

5. The persons appointed will be liable to serve anywhere in and outside Pakistan.

6. (a) Appointment shall be made on probation for a period of one year, but the Government shall have the discretion of extending the period of probation or terminating it before one year for good and sufficient reasons to be recorded.

(b) If, in the opinion of Government, the work or conduct of an officer on probation is unsatisfactory or shows that he is unlikely to become efficient, Government may revert, discharge him forthwith, or extend his period of probation for such further period not exceeding six months as the Government may think fit.

(c) On the satisfactory conclusion of his period of probation, Government may confirm the officer in his appointment provided a clear permanent vacancy exists.

(d) If no action is taken by Government under sub-rule (b) or (c) of this rule, the period after the prescribed period of probation shall be treated as temporary engagement until further orders.

PART II.—RECRUITMENT BY PROMOTION

7. Recruitment by promotion shall be made in the following manner:—

(i) The posts of Director General and Director shall be filled by promotion from amongst the Director(s) and Deputy Director(s) respectively, with not less than three years service in the respective grades on the recommendations of the Central Selection Board.

(ii) Promotion to the posts of Deputy Director shall be made from amongst the Assistant Directors (with not less than 5 years' service as such) on the recommendations of the Departmental Promotion Committee.

(iii) (a) Promotion to posts of Assistant Director shall be made on the recommendation of Departmental Promotion Committee and in consultation with the Commission from amongst the Script Writers and Tourist Officers (with not less than 5 years' service as such).

(b) The post of Assistant Director (Administration) shall be filled by promotion on the recommendation of Departmental Promotion Committee and in consultation with the Commission from amongst the Superintendents having not less than 5 years' experience as such. The incumbent of this post will not be interchangeable with incumbents of other posts of Assistant Director in the Department.

(iv) Promotion to the post of Statistical Officer shall be made from amongst the Statisticians (with not less than 5 years' service as such) on the recom-

recommendations of the Departmental Promotion Committee.

(v) Promotion to the posts of Tourist Officer shall be made on the recommendation of the Departmental Promotion Committee from amongst the Public Relations Officers/Tourist Information Assistants (with not less than 3 years' service as such) in the Department.

8. No person shall have any claim to such promotion as a matter of right.

9. Persons who fail to secure confirmation in their existing appointment on account of unsatisfactory service record will not be considered for promotion.

PART III.—RECRUITMENT BY DIRECT APPOINTMENT

10. Recruitment by direct appointment shall be made on the recommendation of the Commission.

11. (i) Vacancies in the posts which are filled by direct appointment shall be distributed as follows:—

Merit	20%
East Pakistan	40%
Areas comprising Former Punjab and Bahawalpur State	23%
Areas comprising former Sind, Khairpur, N.W.F.P., and Frontier States and Tribal Areas, Baluchistan and Baluchistan States and Tribal Areas, Gilgit and Baltistan, Azad Kashmir and Refugees from Kashmir	15%
Karachi	2%

(ii) If any vacancy cannot be filled on account of non-availability of a suitable candidate of the Province/Region for which the vacancy is reserved, it should be carried over to the share of the Province/region concerned and filled from the Province/region in the next recruitment except where it is certified by the Ministry of Defence that the post is of a highly technical nature and is to be filled in immediately and it is certified by the Commission that there is no possibility of getting any candidate from the Province/region for which the vacancy is meant. In such a case the vacancy may be filled on merit basis.

(iii) 6% of the provincial quota vacancies shall be reserved for Scheduled Castes and they will be counted against the quota of the province/region in which the candidate concerned is domiciled provided that if any such vacancy cannot be filled on account of non-availability of a suitably qualified Scheduled Caste candidate, it shall be filled on the basis of merit from among the candidates belonging to the province/region concerned.

(iv) Recruitment policy as mentioned in sub-rule (i) above, will be equally applicable to isolated posts also and the Commission will be informed of domicile of the required candidate for appointment at the time of sending the requisition for recruitment as required under the Establishment Division O. M. No. 1/4/64-DV, dated the 30th June 1964.

12. A candidate for appointment must:—

(a) be either a citizen of Pakistan or a person deriving his nationality from the State of Jammu and Kashmir or a person whose temporary employment has been authorised by the President.

(b) Possess the educational qualifications prescribed for the post concerned in the Schedule I attached to these Rules.

13. Requirements of rules 12 (b) and 15 will be relaxable on the recommendations of the Commission:—

(a) In very special cases of candidates otherwise highly qualified.

(b) In cases it is not possible or practicable to obtain a candidate who possesses all the qualifications prescribed in the said rules and the Government certifies that it is inescapable to make the appointment.

14. (a) A candidate who has married a person who is not a citizen of Pakistan shall not be eligible for appointment to the post but if any candidate marries an Indian National after obtaining the permission of Government, he will be regarded as eligible for appointment.

(b) Selection for appointment confers no right to appointment unless Government are satisfied, after such enquiry as may be necessary, that the candidate is suitable in all respects for public service.

(c) A candidate must be in good mental and bodily health and free from any physical defect likely to interfere with the discharge of his duties. A candidate who, after such medical examination as the Government may prescribe, is found not to satisfy these requirements, will not be appointed.

(d) Application shall be submitted to the Commission in such form, on such date and in such manner and with such fee as the Commission may prescribe.

(e) All Government servants who fulfil the conditions laid down in these rules shall be eligible for appointment if permitted to apply by the competent authority in their Department/Office. Candidates who join Government service after sending their applications shall also obtain the permission of the Head of the Department concerned and send it to the Commission immediately thereafter. A candidate who has ceased to be in Government service shall submit with his application the original as well as a copy of his discharge/service certificate.

15. A candidate for appointment in respect of all the posts must not be more than 35 years of age on the last date of receipt of application mentioned in the advertisement for the post issued by the Commission. The age limit will be relaxable in case of Government servants who have put in five years service.

16. (1) The maximum age limit may be relaxed by three years in the case of candidates belonging to:—

- Scheduled Castes;
- Buddhist Community;
- the recognised tribes who are permanent residents in the areas mentioned below and whose families have been living in those areas.

West Pakistan:

- Quetta Division.
- Kalat Division.
- Las Bela District of Karachi Division.
- Tribal areas of D. I. Khan & Peshawar Divisions (including Frontier States of Dir, Swat, Chitral and Amb).
- Former Excluded (Baluch) area forming part of the Dera Ghazi Khan district.
- Former tribal areas of Mardan & Hazara Districts.
- Nasirabad Sub Division of Khairpur Division.
- Upper Tribal area of Hazara District.

Pakistan :

1. Tribes in the Chittagong Hill Tracts.
2. Tribes residing in the district of Mymensingh.
3. The aboriginal tribes residing in the districts of Rajshahi and Dinajpur irrespective of the religion they profess.
4. The tribal people, viz. Garo, Hajong, Khasi, Tipra, Kuki and Munipuri residing in the District of Sylhet.
- (d) the State of Jammu and Kashmir who live either in Pakistan or in the Azad Kashmir Territory, the Gilgit Agency or Baltistan, and the Permanent residents of the Azad Kashmir Territory, the Gilgit Agency and Baltistan.

NOTE I.—A candidate who claims to belong to a Scheduled Caste or the Buddhist Community will be eligible for the relaxation of age limit on production of certificate in support of his claim from the District Magistrate or Political Agent or a Deputy Commissioner as the case may be.

NOTE 2.—Tribal candidates will be eligible for the concession mentioned at (c) above on production of a certificate from the Deputy Commissioner or the Political Agent concerned.

NOTE 3.—The relaxation of age limit for a person belonging to an area mentioned at (d) above will be admissible to a candidate who produces a certificate from the Ministry of Kashmir Affairs, Government of Pakistan.

(22) The maximum age limit may also be relaxed as follows :—

In the case of released/retired officers/personnel of the Armed Forces of Pakistan, by a maximum period of ten years or by the number of years an officer/a person has actually served the Armed Forces, whichever is less. The released/retired officers/personnel of the Armed Forces will be preferred to candidates from the open market provided they possess the requisite educational and other qualifications and are otherwise suitable.

NOTE.—The relaxation in age limits prescribed in this rule shall be permitted up to the maximum period of an individual concession and not by the total period of the concessions taken together if admissible in any case.

PART IV.—RECRUITMENT BY TRANSFER

117. Recruitment by transfer to :—

(a) The posts of Director General and Director shall be made on the recommendations of the Central Selection Board from amongst Officers possessing the educational qualification and experience mentioned against the post concerned in schedule II to these rules.

(b) The posts of Deputy Director and Assistant Director except the post of Assistant Director (Administration) shall be made from amongst Officers already holding Class I post and possessing qualifications/experience mentioned against the post concerned in schedule II to these rules in consultation with the Commission or other competent authority in accordance with the relevant Rules.

(c) Recruitment by transfer to post of Assistant Director (Admn.) shall be made from amongst suitable Class I Officers working in the Central Government and possessing the qualification and experience prescribed in Schedule II. The appointment from Class II Officers will however be made to the post of Assistant Director (Admn.) if no suitable person from Class I Officers is made available.

NOTE I.—Full particulars of the post shall be circulated to the Ministries/Departments of the Central and Provincial Governments and they will be asked to recommend suitable officers for appointment.

NOTE II.—Cases involving transfer from Class II to Class I posts shall be referred to the Commission as required under the rules.

(d) The post of Audit and Accounts Officer shall be made on the recommendation of Departmental Promotion Committee from amongst persons possessing the qualifications and experience as shown in Schedule II to these rules and nominated by the Auditor General, Pakistan.

18. Appointment shall be made on tenure basis for a period of 3 years which may be extended by a further period of 3 years if the Government may think fit, but the extendable period shall not exceed beyond 3 years.

19. In exceptional cases Government may after consultation with the Central/Provincial Government revert an officer to his parent Department or to the service to which he belongs before the expiry of the period of tenure.

SCHEDULE I

QUALIFICATIONS AND EXPERIENCE REQUIRED FOR DIRECT APPOINTMENT AGAINST CLASS I AND II POSTS.

DEPUTY DIRECTOR (CLASS I) :

1. Essential :

(i) Degree from a recognised University.

(ii) Five years experience in a responsible position in a Government/Semi-Government Publicity Organization, a First Class English Newspaper/Magazine or Commercial Public Relations/Publicity concern.

OR

Five years administrative experience in a responsible position under the Government or in a Semi-Government Agency or in a reputable Commercial concern.

2. Desirable :

(i) Adequate working knowledge of the process of printing and production.

(ii) First hand knowledge of matters concerning travel trade and tourist promotional activities.

(iii) Knowledge of a foreign language other than English.

(iv) Acquaintance with Socio-Economic problems of the country including knowledge of social, historical cultural and archaeological background of Pakistan.

(v) Travel abroad.

(vi) Training in Public Relations, Journalism, Research of Tourism.

ASSISTANT DIRECTOR (CLASS I):**1. Essential:**

(i) Degree from a recognised University.

(ii) Four years experience of Journalism and Publicity preferably in Tourism.

OR

Four years experience of administrative duties in a responsible position under the Government or in a Semi-Government Agency or in a reputable Commercial concern.

2. Desirable:

(i) Adequate working knowledge of the process of printing and production.

(ii) First-hand knowledge of problems of Travel Trade.

(iii) Knowledge of a foreign language other than English.

(iv) Travel abroad.

(v) Training in Public Relations, Journalism, Research in Tourism.

STATISTICAL OFFICER (CLASS I):**1. Essential:**

(i) 2nd Class Master's Degree in Statistics or Mathematics (with Statistics as a subject in Degree Course).

(ii) Five years experience relating to Statistics in a responsible position.

OR

(i) 1st Class Master's Degree in Statistics or Mathematics (with Statistics as a subject in a Degree Course).

(ii) Three years experience relating to Statistics.

2. Desirable:

Training in operation of modern mechanical devices for tabulation of Statistical data.

SCRIPT WRITER (CLASS I):**1. Essential:**

(i) Degree from a recognised University.

(ii) Three years experience as a feature writer editorial associate or reporter in first class English Newspaper/Magazine, (Relaxable in case of authors of books/brochures/pamphlets on subject of touristic or sociological interest).

2. Desirable:

(i) Degree/Diploma in Journalism.

(ii) Travel abroad.

(iii) Proficiency in foreign language other than English.

(iv) Proficiency in Urdu/Bengali.

TOURIST OFFICER (CLASS II GAZETTED):**1. Essential:**

(i) Graduate from a recognised University.

(ii) Three years experience of Journalism and Publicity, Preferably in Tourism.

OR

Three years experience in Travel Trade.

OR

Three years administrative experience in a responsible position.

2. Desirable:

(i) Knowledge of problems of Travel Trade.

(ii) Ability to produce text for Tourist Literature.

(iii) Knowledge of foreign languages other than English.

STATISTICIAN (CLASS II GAZETTED):**1. Essential:**

(i) 2nd Class Master's Degree in Statistics or Mathematics (with Statistics as a subject in Degree Course).

(ii) Two years experience relating to Statistics.

OR

1st Class Master's Degree in Statistics or Mathematics (with Statistics as a subject in Degree Course).

2. Desirable:

Training in operation of modern mechanical devices for tabulation of Statistical data.

PUBLIC RELATIONS OFFICER (CLASS II NON-GAZETTED):**1. Essential:**

(i) Degree from a recognised University.

(ii) Good command over English language.

2. Desirable:

(i) Experience of travel service.

(ii) Knowledge of foreign languages.

TOURIST INFORMATION ASSISTANT (CLASS II NON-GAZETTED):**1. Essential:**

(i) Degree from a recognised University.
