

- (4) Boropata (*Macaranga denticulata*)

- (6) Bolapata (*Grewia species*) except in the Sundarbans area.

The tenders are to be addressed by name to the undersigned to reach his office, during office hours on or before 21st November, 1970 up to 10 a.m. The tenders will be opened at 10-30 a.m. on the same day. Intending tenderers may remain present at the time of opening tenders.

The conditions of the re-sale are as follows:

1. Intending tenderers are requested to inspect the leaves in the forest area of the mohal before they submit tenders. Any plea of non-availability of leaves after acceptance of the tender will not be entertained.



The Second estimate of Gram Crop of East Pakistan for 1969-70.

Character of the season—The condition of weather for the cultivation and growth of the crop was more or less favourable almost all over the province.

Area—According to the second estimate, the area under Gram crop of East Pakistan for 1969-70 has been estimated at 1,76,485 acres as against 1,69,500 acres and 1,68,750 acres of the corresponding and final estimates respectively of the preceding year. This shows an increase of 4.12 per cent. over the corresponding estimate of the previous year. The increase in area, shared by most of the districts, is attributed to attractive market price and favourable weather condition at sowing time.

Yield—The average yield per acre of the crop for the province stands at 9.00 mds. in 1969-70 as against 8.79 mds. and 8.75 mds. of the corresponding and final estimates respectively of 1968-69. The increase in the average yield rate of this year, observed in many of the districts, is due to favourable weather conditions.

Production—The total production of the crop in East Pakistan for 1969-70 has been placed at 58,349 tons as against 54,725 tons and 54,280 tons of the corresponding and final estimates respectively of the previous year. The increase in the total production is the result of increase in area as well as average yield rate.

District-wise acreages, yield rates and production data are given in the appendix attached herewith.

The estimates of Arhar, Musur and Motor pulses of East Paistan for 1969-70.

Weather condition—The weather was unfavourable in the districts of Faridpur, Rajshahi, Jessore and Kushtia and affected the crops adversely. In all other districts, the condition of weather for the cultivation and growth of the crops was more or less favourable.

Area—The total areas under the crops have been estimated as below:

The area under Arhar in the Province has decreased by 11 per cent. in comparison with the previous year's. The decrease in area is ascribed to increased cultivation of "Other Rabi crops" and adverse weather in some of the districts. The area of Musur and Motor have increased by 4 per cent. and 3 per cent. respectively over the previous year's. The increase in area under Musur and Motor is attributed to increased demand and favourable weather in many of the districts. The increase in area has been shared by many of the districts.

Yield rate—The average yields per acre of the crops stand as:

The average yield rates of Arhar and Motor have shown some decrease over the last year's. Unfavourable weather at growth and harvest period in some of the districts is responsible for the decrease in the average yield rates. The slight increase in the average yield rate of Musur is attributed to weather which was favourable to it in many of the districts.

Production—The total production of the crops have been placed as under:

The total production of Musur in the Province has increased this year. Increase in the total area as well as average yield rate has resulted in the increase in the total production. The total production of Arhar and Motor have decreased this year in comparison to last year's. Decrease in area as well as average yield rate has caused the decrease in the total production of Arhar and decrease in the average yield rate is responsible for the fall in the total production of Motor.

Districtwise acreages, yield rates and productions of Arhar, Musur and Motor are given in Appendix A, B, and C respectively.

The final estimate of Groundnut crops of East Pakistan for the year 1969-70.

Weather condition—The condition of weather for the cultivation and growth of Kharif Groundnut was more or less favourable in the Province except in the districts of Faridpur, Chittagong, Chittagong Hill Tracts, Rajshahi, Khulna, Jessor and Kushtia where mainly heavy rainfall affected the crop adversely.

The condition of weather for the cultivation and growth of Rabi Groundnut was also more or less favourable in the Province except in Dinajpur and some places of Sylhet district.

Area—The total areas under the crops have been estimated as below:

The total areas of Kharif and Rabi Groundnut have decreased this year in comparison with the previous years. The decrease in the total area under Kharif Groundnut, observed in all the divisions except Dacca division, is ascribed to unfavourable weather at sowing time and increased cultivation of other more paying crops. Unfavourable weather at sowing period in Sylhet district scarcity of seed and increased cultivation of other more profitable crops were mainly responsible for the fall in the total area of Rabi Groundnut. The area has decreased in all the divisions except Khulna division where its cultivation is the best.

Yield rate—The average yields per acre of the crops for the Province stand as:

The rise in the average yield rate of Kharif Groundnut, observed in Dacca and Rajshahi divisions, is attributed to favourable weather in many of the districts and better agricultural practices. The increase in the average yield rate of Rabi Groundnut, shared by all the divisions except Khulna division, is also attributed to favourable weather during the growth and harvest period in many of the districts and better agricultural practices.

Production—The total production of Groundnut has been estimated as follows:
